INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of the
NEI General Contracting, Inc. 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of NEI General Contracting, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the NEI General Contracting, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note E to the financial statements, is complete and accurate.

Opinion

NOTE A – DESCRIPTION OF THE PLAN

The following description of the NEI General Contracting, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all full time non-union employees of NEI General Contracting, Inc. (the "Company") who are age eighteen or older and have been employed for 30 days. An employee who has satisfied the eligibility requirements may enter the Plan on the first day of the month coinciding with or following the date the eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

The Plan provides for employee pre-tax contributions, Roth contributions, and discretionary employer contributions. Each year participants may contribute up to 90% of their eligible compensation, as defined by the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. Effective January 1, 2023 the Plan has enacted an automatic enrollment provision whereby all employees who become eligible to participate will be automatically enrolled in the Plan unless they affirmatively elect not to participate. Automatically enrolled participants have their deferral rate set at 4 percent of eligible compensation and their contributions invested in a designated target date fund until changed by the participant. Contributions are subject to certain IRS limitations.

The Plan allows the Company to make discretionary matching contributions. In 2024 and 2023, the Company matched 25% of the first 8% of compensation deferred by each participant. In addition, the Plan allows for a discretionary profit sharing contribution. All participants are eligible to receive the matching contribution. To be eligible to receive the profit sharing contribution, a participant is required to be employed by the Company on the last day of the plan year and must have worked a minimum of 1,000 hours during the plan year. During the years ended December 31, 2024 and 2023, the Company made matching contributions to the Plan in the amount of approximately \$490,000 and \$401,000, respectively. No additional profit sharing contribution was made during 2024 or 2023.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit sharing contribution, plan earnings or losses, and administrative expenses, if any. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined by the Plan administrator. All loans outstanding as of December 31, 2024 and 2023 had an interest rate of 4.25% - 9.50%. Principal and interest is paid ratably through payroll deductions.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company’s contribution portion of their accounts, plus actual earnings thereon, is based on the following vesting schedule:

<u>Years of Service</u>	<u>Vested Percentage</u>
Less than 2 years of service	0%
After 2 years of service	20%
After 3 years of service	40%
After 4 years of service	60%
After 5 years of service	80%
After 6 years of service	100%

Any participant who attains normal retirement age, terminates employment due to disability, or dies, becomes fully vested regardless of length of service.

Payment of Benefits

On termination of service, a participant shall be entitled to receive a distribution in an amount equal to the value of his or her vested account.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$10,602 and \$45, respectively. These accounts will be used to reduce future expenses and Plan Sponsor contributions. Also, during the years ended December 31, 2024 and 2023 the Plan Sponsor used approximately \$20,000 and \$26,000, respectively, of forfeitures to reduce employer contributions.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, including the collective trusts, which hold indirect investments in fully benefit responsive investment contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan’s Investment Committee determines the Plan’s valuation policies utilizing information provided by the investment advisers and custodians. See Note C for discussion of fair value measurements.

Investment Valuation and Income Recognition (continued)

The Plan's shares of mutual funds are valued at quoted market prices which represent the net asset value ("NAV") of shares held by the Plan at each year end. The investment in the collective trust is valued at NAV per unit, as determined by the trustee at year end. The NAV is used as the practical expedient to estimate fair value of the collective trust.

The Plan invests in investments in a group annuity contract through a stable value fund which is valued as reported daily by the fund's trustee based on a formula as determined in the guaranteed investment account contract. The fund principal and interest is backed by the entire general account asset class of Empower Annuity Insurance Company of America.

The Plan invests in variable annuities through the PGIM High Yield Bond Fund. The prices per unit for the variable annuity options are calculated daily by the annuity provider according to the methods described in the annuity contract. The initial pricing input is the quoted price obtained for the underlying mutual fund which is then adjusted to apply the expense factor disclosed in the annuity contract. The accounting unit value is determined in a manner similar to a mutual fund NAV calculation dividing the net assets by the number of outstanding units.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The preceding methods described may produce a fair value calculation that is not indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/(depreciation) of fair value of investments.

Date of Management Review

The Plan has evaluated subsequent events through the date of this report, the date the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosure in these financial statements.

NOTE C – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

- *Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. (Level 1)
- *Stable Value Fund/Fixed Account:* Valued as reported daily by the fund's trustee. It is determined in accordance with a formula contained in the guaranteed investment account contract and designed to reflect the value of the assets in the general investments account. The majority of the assets in the general investments account are fixed income, treasuries, public bonds, private placements, bank loans, commercial mortgage loans, mortgage backed securities and other types of debt. (Level 2)

- *Variable Annuity Contracts:* Valued based on the market value of the underlying investments as determined by an independent professional’s opinion and independent pricing sources (Level 2).
- *Common Collective Trusts:* Consists of pools of investments used by institutional investors to obtain exposure to equity and fixed income markets. Common collective trusts held by the Plan invest in target date funds. Shares held in common collective trusts are reported at the net unit value of units held at year end. The unit value is determined by the total value of fund assets divided by the total number of units of the fund owned.

NOTE D – STABLE VALUE AND ANNUITY CONTRACTS

The Plan has a group annuity contract with Empower Annuity Insurance Company of America. The group annuity contract, the Empower Investments Fixed Account – Series Class II, is a fixed account that is part of the general account of Empower Annuity Insurance Company of America. The fund seeks to achieve consistent returns to support a competitive credited rate. Bonds invested in the general account segment have an average maturity between three and seven years; are investment-grade quality, and are diversified across a range of fixed income asset classes such as asset-backed securities, mortgage-backed securities, commercial mortgage-backed securities, commercial mortgages and private equities. The account credits interest daily to the group contract holder on a portfolio basis. The credited interest rate may change or stay the same each quarter.

NOTE D – STABLE VALUE AND ANNUITY CONTRACTS (continued)

The Plan also has a group annuity contract with investments in the PGIM High Yield Bond Fund. The Fund's investment objective is to provide a high level of current income. The Fund invests in a diversified portfolio of high yield income instruments that are rated below investment grade with varying maturities and other investments with similar economic characteristics.

Certain events limit the ability of the Plan to transact at fair value with the issuer. Such events include premature termination of the contracts by the Plan, discontinuation of operations, layoffs, Plan termination, bankruptcy, mergers and early retirement incentives. The Plan does not believe that any events which would limit the Plan's ability to transact at fair value with participants are probable to occur.

NOTE E – CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified by Empower Trust Company, LLC (the trustee of the Plan).

NOTE F – PARTY IN INTEREST TRANSACTIONS

Section 3(14) of ERISA defines a party in interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan, or an employer whose employees are covered by the Plan. The Plan invests in shares of investments managed by Empower Trust Company, LLC ("Empower"). A portion of the income or loss of the Plan is derived from these investments. Investment advisory services are provided by UBS Financials Services, Inc. ("UBS"). Fees paid by the Plan to Empower and UBS for certain investment management fees were deducted from the net asset values of the funds held by the Plan.

Certain employees and officers of the Company, who are also participants in the Plan, perform administrative services to the Plan at no cost to the Plan. These transactions are exempt from the prohibited transaction rules.

NOTE G – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE H – TAX STATUS

The Plan has adopted a volume submitter profit-sharing plan with Great West Trust Company (now known as Empower Trust Company, LLC). That Plan obtained its latest opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the Plan and the related trust, as then designed, are in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe the Plan is qualified, and the related trust is tax exempt.

NOTE I – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE J – PROHIBITED TRANSACTION

As required by ERISA Section 2510.3-102, the Plan Sponsor is required to segregate employee contributions from its general assets and remit them to the Plan as soon as they can be reasonably segregated. Due to an administrative error, participant contributions totaling \$50,420 in 2024 were not remitted to the Plan in a manner that would meet the DOL's requirement for timely remittance. The Plan Sponsor has made a corrective contribution to the Plan in 2024 for the late deposit. An additional contribution to the affected participants' account has also been made to compensate the participants for lost earnings due to the delay in remitting the funds.
