Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of Jewish Adoption and Foster Care Options 403(b) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (2024 Financial Statements).

Responsibilities of Management for the 2024 Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Their report dated September 23, 2024 indicated that (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedule, other than the information in the 2023 supplemental schedule that agreed to or is derived from the certified investment information, were presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2023 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determines meets the requirements of ERISA Section 103(a)(3)(C).

Note 1. Plan Description

General

The following description of Jewish Adoption and Foster Care Options 403(b) Retirement Plan (the “Plan”), as amended, provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

The Plan, which was established on January 1, 2003, is classified as a defined-contribution plan, and covers eligible employees of Jewish Adoption and Foster Care Options (the “Plan Sponsor” or “Company”) upon hiring. The primary purpose of the Plan is to provide retirement savings benefits to employees of the Company based on the respective eligibility requirements, applicable wages and contributions, and vesting schedules. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Each year, participants may contribute on a pre-tax basis up to 100% of eligible compensation, as stated in the Plan and subject to Internal Revenue Service (“IRS”) limitations. Participants’ deductions are made through a salary reduction agreement. The Plan Sponsor may elect to make a discretionary matching contribution in an amount annually determined by the Plan Sponsor. Additional discretionary non-elective contributions may be funded at the option of the Company’s Board of Directors. The Plan Sponsor made a \$52,240 discretionary matching contribution for the year ended December 31, 2024. The discretionary matching contribution was equal to 25% of the participant’s contributions up to 6% of the participant’s compensation for the year ended December 31, 2024. Contributions are subject to certain limitations.

Participant Investment Account Options

Participants direct the investment of their accounts into various investment options offered by the Plan. Investment account options available include money market funds and mutual funds.

Participant Accounts

Under the Plan, a separate account is maintained for each participant. Each participant’s account is credited with the participant’s contribution, employer contributions, the allocation of forfeitures of terminated participants, and allocations of Plan earnings. Participant contributions and employer discretionary contributions are allocated, at the participant’s election, to investment funds held at Nationwide Financial Services, Inc. (the “Plan Custodian”). Plan earnings are allocated based on the actual earnings of the respective participant’s investments. Participants may change their investment options at any time with certain exceptions.

Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 up to a maximum of the lesser of 50% of their respective vested balances or \$50,000 by executing a note in accordance with the Plan’s provisions. Participants may only have one loan outstanding at any point in time and the loan must be repaid within five years unless the loan proceeds are used in the purchase of the participant’s primary residence. The notes are collateralized by the balance in the participant’s account and bear interest at rates ranging from 4.25% - 10.50%. Principal and interest are paid ratably through payroll deductions.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Employer discretionary matching and non-elective contributions plus actual earnings become fully vested after three years of service with no partial vesting prior to three years of service.

Payment of Benefits

Upon the death, permanent disability, or retirement of participants, their entire account balances become fully vested. Benefit payments are to be made in annuity payments, installment payments, or a lump-sum payment equal to the value of the account. Participants who terminate for reasons other than death, disability, or retirement are entitled only to their vested balances.

Note 2. Summary of Significant Accounting Policies

The following is a summary of significant accounting policies followed in the preparation of these financial statements, which have been prepared in accordance with accounting principles generally accepted in the United States of America.

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

Forfeitures

Forfeitures of terminated participants are used to reduce employer contributions or pay Plan administrative expenses. There were no significant forfeitures used during the year ended December 31, 2024. There was an approximately \$3,400 and \$3,800 forfeiture balance as of December 31, 2024 and 2023, respectively.

Investment Valuation and Income Recognition

Investments in mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. Money market funds and mutual funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of marketable securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date and interest income is recorded as earned on the accrual basis.

In accordance with the Plan's policy of stating marketable securities at fair value, the change in fair value for the year is reflected in the statement of changes in net assets available for benefits as net appreciation in fair value of investments.

Notes Receivable from Participants

Notes receivable from participants are recorded at their unpaid principal balance, plus accrued but unpaid interest.

Contributions

Contributions to the Plan are recorded in the period in which they become obligations of the Plan Sponsor.

Payment of Benefits

Participant benefits are recorded when paid. As of December 31, 2024 and 2023, there were no amounts allocated to accounts of participants who elected to withdraw from the Plan but had not yet been paid.

Administrative Expenses

The Plan's administrative expenses are shared by the Plan and the Company, as provided by the Plan document. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles and with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results may differ from those estimates.

Subsequent Events

The Plan Sponsor has evaluated subsequent events for recognition and disclosure through October 1, 2025, which is the date the financial statements were available to be issued.

Note 3. Certification of Plan Custodian

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Plan Custodian, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedules are complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedules.

Note 4. Fair Value Measurements

The fair value of financial instruments is presented based upon a hierarchy of levels that prioritize the inputs of valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

- Level 1** Unadjusted quoted prices in active markets for identical assets or liabilities the Plan has the ability to access at the measurement date.
- Level 2** Inputs to the valuation methodology that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3** Significant, unobservable inputs used for valuing the asset or liability in which little or no market data exists.

A financial instrument's level, within the fair value hierarchy, is based on the lowest level of input that is significant to the fair value measurement in its entirety.

Note 5. Exempt Party-in-Interest Transactions

Certain plan investments are funds managed by the Plan Custodian as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. Fees paid to the Plan Custodian were \$26,284 for the year ended December 31, 2024. The Company also absorbs significant costs related to various administrative and investment advisory services on behalf of the Plan.

Note 6. Risks and Uncertainties

The Plan's investments are not insured and are subject to credit and market risks. Financial information relating to those investments is included in these financial statements based on information provided by the Plan Custodian.

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 7. Income Tax Status

The original plan is a prototype plan prepared and maintained by a third party. The prototype plan obtained its latest determination letter on March 31, 2017, in which the IRS stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and tax-exempt.

Note 8. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the Plan assets shall be distributed in proportion to participants' respective account balances as of the date of termination.

Note 9. Prohibited Transactions

Certain contributions were not transmitted to the Plan in a timely manner during the Plan year ended December 31, 2024. The Employer remitted \$129,266 of the delinquent contributions during the 2024 Plan year. The Employer remitted the related lost earnings during the 2025 Plan year.
