Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Harte Hanks, Inc. Pension Plan I, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits in liquidation as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits in liquidation for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Harte Hanks, Inc. Pension Plan I's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. As further discussed in Note 1a of the financial statements, Harte Hanks, Inc. (the Plan Sponsor) approved a plan to terminate the Plan effective January 12, 2023, and changed its basis of accounting from the ongoing basis of accounting to the liquidation basis of accounting used in presenting the financial statements. All of the Plan's assets have been distributed as of December 31, 2024. Our opinion is not modified in respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

1. DESCRIPTION OF PLAN

The following description of Harte Hanks, Inc. Pension Plan I (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

a. General

The Plan was a noncontributory defined benefit pension plan, which provided retirement benefits for eligible employees of Harte Hanks, Inc. and certain affiliates (the Company) (the Plan Sponsor). The Plan was subject to the provisions of the Employment Retirement Income Security Act of 1974 (ERISA). The Plan Sponsor acts as Plan Administrator for the Plan.

Effective December 31, 1998, the Plan was modified (frozen) to (a) restrict future participation to only those employees of the Plan Sponsor who were participants in the Plan as of December 31, 1998, (b) provide for 100% vesting in frozen accrued benefits of such participants and (c) provide for cessation of benefit accruals of such participants as of December 31, 1998.

On January 12, 2023, the Board of Directors approved a plan to terminate the Plan. The Internal Revenue Service (IRS) provided the Plan with a favorable determination letter approving the liquidation and termination of the Plan, dated May 3, 2024. The Plan Sponsor instructed the third-party administrator to amend the Plan to provide for such termination and be liquidated in accordance with the terms and conditions of the Plan, including any rules or regulations promulgated by the Pension Benefit Guaranty Corporation (PBGC) and the IRS. The Plan subsequently purchased annuity contracts from Nationwide Life Insurance Company amounting to \$71,849,425 to provide benefits to current retirees of the Plan, which is included in benefits paid to participants and annuity purchases in the accompanying statement of changes in net assets available for benefits in liquidation. The remaining plan participants received a lump sum payment from the Plan. All Plan assets have been distributed as of December 31, 2024.

b. Contributions

The Plan's funding policy was for the Company to contribute to the Plan amounts to meet or exceed the annual ERISA minimum funding requirements as determined by the Plan's independent actuary. The minimum funding requirements were met for the years ended December 31, 2024 and 2023. No voluntary participant contributions are permitted.

c. Retirement Benefits

The Plan provided for normal retirement benefits to be paid to participants on the first day of the first month following the attainment of the age of 65. The Plan provided for an early retirement benefit to be paid once participants had attained the age of 55. The monthly pension benefit payable to participants was based on years of credited service and average monthly compensation, as contained in the plan document.

The normal forms of benefit payments were a life annuity or, if married, a joint and 50% survivor annuity. However, a participant had the option of electing actuarially equivalent benefits paid under annuity payments. The options available, subject to certain limitations, included single-life annuity and joint annuitant options.

d. Death and Disability Benefits

Upon the death of a vested participant who was married, the surviving spouse was eligible to receive a death benefit in the form of a survivor annuity.

A participant who retired because of disability was entitled to a disability benefit commencing on their normal retirement date or earlier, if elected. The benefit was determined as if the participant had been employed through the normal retirement age and using the participant's eligible compensation as of the date of termination of service occurs.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

The Plan prepares its financial statements in accordance with generally accepted accounting principles (U.S. GAAP) established by the Financial Accounting Standards Board (FASB). References to U.S. GAAP in these notes are to the FASB Accounting Standards Codification (ASC).

The financial statements are presented on the liquidation basis of accounting, due to the Plan Sponsor voting to terminate the Plan, management determining liquidation was imminent, and the Plan's assets being fully distributed at December 31, 2024 (see Note 1a.).

Under the liquidation basis of accounting, assets are measured to reflect the estimated amount of cash expected to be collected in settling or disposing of the assets during the liquidation process and liabilities are measured using the accrual basis of accounting and would include any expected costs of the disposal of assets and other costs expected to be incurred during the liquidation process. The difference between assets measured under the liquidation basis of accounting and fair value is immaterial to the financial statements, references to fair value are synonymous to liquidation basis.

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities and the actuary present value of accumulated plan benefits at the date of the financial statements and changes therein. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transactions between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the qualified institution. See Note 5 for discussion of fair value measurements.

Purchases and sales of investments were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments being sold, as well as held during the year.

Contributions

The Company's policy was to make contributions to the Plan each year at least equal to the minimum funding requirements of ERISA, if any.

Benefit Payments

Benefits were recorded when paid.

Administrative Expenses

Certain administrative expenses of maintaining the Plan were paid directly by the Plan Sponsor and are excluded from these financial statements. All expenses associated with the investment advisory, actuarial, PBGC, and benefit payment processing of the Plan were paid by the Plan and included in administrative expenses in the accompanying statements of changes in net assets available for benefits in liquidation. During 2024, the Plan did not pay any PBGC premiums. During 2023, the Plan paid PBGC premiums of \$647,604.

Subsequent Events

Subsequent events have been evaluated through September 30, 2025, which is the date the financial statements were available to be issued. There were no events that met the criteria for recognition or disclosure in the financial statements.

3. INFORMATION PREPARED AND CERTIFIED BY THE PLAN'S QUALIFIED INSTITUTION

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Bank of America, N.A., a qualified institution, has certified to the completeness and accuracy of all investments reported in the accompanying statements of net assets available for benefits in liquidation as of December 31, 2024 and 2023, and the supplemental schedule, Form 5500, Schedule H, Part IV, Line 4j - Schedule of Reportable Transactions in Liquidation for the year ended December 31, 2024, and the related investment transactions and investment income (loss) in the accompanying statements of changes in net assets available for benefits in liquidation for the years ended December 31, 2024 and 2023.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to certified investment information, except for comparing such certified investment information included in the accompanying financial statements and supplemental schedule.

4. ACTUARIAL PRESENT VALUE OF ACCUMULATED BENEFITS

Accumulated benefits are those future periodic payments under the Plan's provisions, including lump-sum distributions, which are attributable to the service the participants have rendered. Accumulated benefits include benefits expected to be paid to (a) retired or terminated employees or their beneficiaries, (b) beneficiaries of participants who have died, and (c) present participants or their beneficiaries. Benefits under the Plan are based on the employee's highest monthly average produced of five consecutive calendar years' compensation out of the last ten calendar years at the earlier of termination or Benefit Accrual Preservation Date (the valuation date). Benefits payable under all circumstances - retirement, death, disability, and termination of employment - are included, to the extent they are deemed attributable to employee service rendered to the valuation date.

Upon terminating the Plan, different actuarial assumptions and other factors were applicable in determining the actuarial present value of accumulated Plan benefits. As a result, since the Board of Directors voted to terminate the Plan, the final plan contribution was calculated. Accordingly, an actuarial valuation was not completed for the period ended December 31, 2024, as all Plan assets were distributed as prescribed by ERISA and its related regulations.

5. FAIR VALUE MEASUREMENT

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. *Fair Value Measurement* establishes a hierarchy of the valuation techniques based upon whether the inputs to those valuation techniques reflect assumptions other market participants would use based upon market data obtained from independent sources (also referred to as observable inputs). The fair value hierarchy is as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Governmental and corporate bonds: Valued based on pricing models, quoted prices of securities with similar characteristics or discounted cash flows.

Money market funds: Valued at the daily closing price as reported by the fund. Money market funds held by the Plan are open-ended funds that are registered with the SEC. These funds are required to publish their daily net asset value and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Treasury notes: Valued based on quoted prices in active markets as received by the qualified institution. The funds held by the Plan are deemed to be actively traded.

There were no changes in the valuation methodologies used during December 31, 2023.

The preceding methods used to determine fair value may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. While the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

All plan assets have been distributed as of December 31, 2024.

6. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Bank of America, N.A., provides custodial, investment advisory and trustee services to the Plan. Aon provides actuarial services to the Plan. These transactions qualify as parties-in-interest and are reported as administrative expenses in the accompanying statements of changes in net assets available for benefits in liquidation. During the years ended December 31, 2024 and 2023, the Plan paid the parties-in-interest administrative expenses in the amount of \$754,762 and \$1,130,287, respectively.

7. TAX STATUS

The Plan Sponsor has obtained its latest determination letter dated May 20, 2015, in which the IRS stated that the restated plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believed that the Plan was designed and being operated in accordance with the applicable requirements of the IRC up to the determination to liquidate the Plan. Additionally, the IRS has provided the Plan with a favorable determination letter approving the liquidation and termination of the Plan (see Note 1a).

7. TAX STATUS (Continued)

U.S. GAAP requires the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan Sponsor has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. PLAN TERMINATION

On January 12, 2023, the Plan Sponsor's Board of Directors approved a plan to terminate the Plan. The complete liquidation of plan assets occurred on December 31, 2024 (see Note 1a). As such, the net assets of the Plan were distributed, as prescribed by ERISA and its regulations, generally to provide the following benefits in the order indicated:

1. Benefits attributable to employee contributions, taking into account those paid out before termination.
2. Annuity benefits that former employees or their beneficiaries have been receiving for at least three years or that employees eligible to retire for that three-year period would have been receiving if they had retired with benefits in the normal form of annuity under the Plan. The priority amount is limited to the lowest benefit that was payable (or would have been payable) during those three years. The amount is further limited to the lowest benefit that would be payable under plan provisions in effect at any time during the five years preceding plan termination.
3. Other vested benefits insured by the PBGC, a U.S. government agency, up to the applicable limitations.
4. All other vested benefits (that is, vested benefits not insured by PBGC).
5. All non-vested benefits.

Certain benefits under the Plan were insured by the PBGC. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivor's pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan were guaranteed at the level in effect on the date of the Plan's termination.

Whether all participants receive their benefits as the Plan terminates depended on the sufficiency of the Plan's net assets available to provide for accumulated benefit obligations and on the financial condition of the Plan Sponsor and the level of benefits guaranteed by the PBGC. The Plan Sponsor made contributions to the Plan, based on actuarial calculations, sufficient to fully fund and distribute participants' accrued benefits in order to terminate the Plan.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant balances and the amounts reported in the accompanying statements of net assets available for benefits in liquidation.
