To the Administrative Committee of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Americare Systems, Inc. Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Americare Systems, Inc. Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution and a regulated insurance company as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution and a regulated insurance company agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Americare Systems, Inc. Retirement Savings Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTE A | DESCRIPTION OF PLAN

The following description of the Americare Systems, Inc. (the “Company”) Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

1. General

The Americare Systems, Inc. Retirement Savings Plan is a defined contribution plan which became effective on January 1, 1992, and most recently amended effective January 1, 2024 to add Roth elective deferrals. The Plan covers all employees of the Company who have one year of service and are age twenty-one or older. A year of service means the twelve-consecutive-month period during which an employee completes 1,000 or more hours of service. Employees enter the Plan the first of the month on or after meeting the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

2. Contributions and Investment Options

For each plan year, the Company will contribute to the Plan the individual’s elective deferral, which is a portion of their compensation which is directed by the participant to be contributed. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Company will deposit quarterly a matching contribution equal to a discretionary percentage (as determined by the Company) of the elective deferral. To receive a matching contribution participants must be active in the quarter. In 2024 and 2023, the Company matched 50% of each participant’s salary deferrals that did not exceed 3% of compensation. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of all contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Code limitations.

3. Participant Accounts and Allocations

Each participant’s account is credited with the participant’s contribution and allocations of the Company’s contribution and Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

NOTE A | DESCRIPTION OF PLAN

4. *Vesting*

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

5. *Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loan is limited to five years unless it is for the purchase of a principal residence. The loans are secured by the balance in the participant's account and bear interest at prevailing rates. Principal and interest is paid ratably through payroll deductions, but not less frequently than quarterly.

6. *Payment of Benefits*

When a participant reaches the normal retirement age of sixty-five, their account will be payable to them beginning on the date of retirement or on a later date that they elect. The plan also allows for early retirement at age 55 with 6 years of vesting service. At retirement date, the participant will have the option to choose from various annuities or a lump sum payment. The Plan also allows for hardship and in-service distributions at age 59 ½ from certain accounts.

If the participant terminates employment other than normal retirement, the participants account will be treated as follows:

(A) If the amount is not greater than \$5,000, the amount will be distributed in a single lump sum payment.

(B) If the amount is greater than \$5,000, the amount will be distributed in a single lump sum payment, provided an election to waive a qualified joint and survivor annuity has been made.

7. *Forfeited Accounts*

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$429 and \$5,435, respectively. These accounts may be used to reduce future employer contributions and plan expenses. Employer contributions and expenses were reduced by \$54,454 in 2024 and \$35,123 in 2023 from forfeited nonvested accounts.

NOTE B | SUMMARY OF ACCOUNTING POLICIES

A summary of the significant accounting policies applied in the preparation of these financial statements follows.

1. *Basis of Accounting*

The accompanying financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

2. *Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

3. *Investment Valuation and Income Recognition*

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date and in the principal and most advantageous market for the asset or liability. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

4. *Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. The Plan deems all participant notes receivable to be fully collectable; therefore, no allowance for uncollectable accounts is required. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

5. *Payments of Benefits*

Benefit payments to participants are recorded upon distribution.

6. *Administrative Expenses*

Expenses of maintaining the Plan are paid by the Plan and the participants.

7. *Subsequent Events*

The Plan has evaluated subsequent events through September 29, 2025, the date the financial statements were available to be issued.

NOTE C | SUMMARY FINANCIAL INFORMATION CERTIFIED BY THE REGULATED INSURANCE COMPANY AND CUSTODIANS

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, permitted under such election, the Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Principal Life Insurance Company (regulated insurance company), Principal Life Insurance Company on behalf of Principal Global Investors Trust Company and Principal Trust Company (custodians) except for comparing such information certified by the regulated insurance company and custodians to information included in the Plan's financial statements and supplemental schedules.

The following is a summary of the unaudited information regarding the Plan at December 31, 2024 and 2023, and for the years then ended, included in the Plan's financial statements and supplemental schedules that was obtained from data that has been prepared and certified to as complete and accurate by the regulated insurance company and custodians.

NOTE D | FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used to measure investments at fair value at December 31, 2024 and 2023.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds

Mutual funds classified in Level 1 are valued at net asset value (NAV) of shares held by the Plan at year end. NAV represents the sum of the underlying investments and represent the price at which the funds are traded on active markets.

NOTE D | FAIR VALUE MEASUREMENTS

Pooled Separate Accounts

Pooled separate accounts classified in Level 1 consist mainly of level 1 or 2 pricing inputs, including quoted prices for similar assets in active or non-active markets. The NAV of a separate account is not publicly quoted but is available to current investors via the Employer website or when plan participants access their account values. The NAV is the basis for current transactions and the pooled separate accounts can be redeemed at NAV as of the measurement date. Therefore, the pooled separate accounts are considered to have a “readily determinable fair value.” There are no conditions, limits or restrictions on redemption transactions and amounts can be redeemed on a daily basis. The pooled separate accounts invest in various mutual funds, fixed securities, short term securities, asset backed securities, mortgage backed securities, real estate and domestic stocks each with their own investment strategies.

Common Collective Trust Funds

Common collective trust funds (CCTF) are classified in Level 1 and consist of a variety of underlying investments that do not have publicly quoted pricing inputs. The fair value of the underlying investments are used in determining the NAV of the CCTFs, which is not publicly quoted but is available to current investors via the Employer website or when plan participants access their account values. The NAV is the basis for current transactions and the CCTFs can be redeemed at NAV as of the measurement date. Therefore, the CCTFs are considered to have a “readily determinable value.”

Guaranteed Interest Account

The fair value of the guaranteed interest account is the amount plan participants would receive currently if they were to withdraw or transfer funds within the Plan prior to their maturity for an event other than death, disability, termination or retirement.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE D | FAIR VALUE MEASUREMENTS

The fair value of the guaranteed interest account is discontinuance value which is the amount the plan participant will receive if they transfer or surrender their funds out of the guaranteed interest account. That can be in the form of account value less either a market value adjustment which moves with market interest rates or a flat discontinuance charge depending on the product type. The discontinuance value is described in the group annuity contract.

NOTE E | PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE F | PLAN TAX STATUS

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the U.S. Department of Labor or Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. Penalties and interest assessed by taxing authorities are included in the provision for income taxes, if applicable. There were no penalties and interest for 2024 and 2023. The Plan is subject to routine audits by the taxing jurisdictions. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE G | RELATED PARTY TRANSACTIONS

Personnel and facilities of the Company have been used to perform administrative functions for the Plan at no charge to the Plan. Certain Plan investments are shares of pooled separate accounts and collective investment trust funds managed by Principal Life Insurance Company and mutual funds managed by Principal Global Investors Trust Company. Principal Life Insurance Company is a regulated insurance company and Principal Global Investors Trust Company is the custodian as defined by the Plan and, therefore, these transactions qualify as exempt party in interest transactions.

NOTE H | RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

NOTE I | PROHIBITED OR NON-EXEMPT TRANSACTIONS

The Plan Sponsor failed to remit participant contributions on a timely basis in the amount of \$14,787 and \$13,777 for 2024 and 2023, respectively. As of December 31, 2024, the Plan Sponsor was in the process of self-correcting late remittances for 2024 by remitting lost earnings into the Plan in 2025. The Plan Sponsor is also working to correct certain employer contributions to participants for excess matching contributions for 2024 by moving any excess matching contribution to the forfeiture account.
