## INDEPENDENT AUDITOR'S REPORT

**To the Sponsor of the  
East Bay SPCA 401(k) Profit Sharing Plan and Trust  
Oakland, California**

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of the East Bay SPCA 401(k) Profit Sharing Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 of the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. ### 1. DESCRIPTION OF THE PLAN

The following description of the East Bay SPCA 401(k) Profit Sharing Plan and Trust (the Plan), provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

**General** – The Plan is a defined contribution plan covering the employees of East Bay Society of the Prevention of Cruelty to Animals (the Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Administration** – The Sponsor is the administrator of the Plan and, as such, carries out the duties imposed under ERISA. The Sponsor has delegated certain responsibilities for the operation and administration of the Plan. American United Life Insurance Company (the Trustee) was the appointed custodian of the Plan's assets. Administrative and recordkeeping services are provided by OneAmerica for American United Life Insurance Company.

**Eligibility** – An employee who is at least eighteen years old becomes eligible to participate in the Plan and receive the 3% safe harbor contribution after completing two consecutive months of service with the Sponsor. To be eligible to receive the full discretionary profit sharing contributions, a participant must also be an employee of the Sponsor on the last day of the plan year.

**Contributions** – Participants may contribute a percentage of their salary (1% to 92%), subject to IRS limitations, through salary deferrals. Participants may also contribute amounts representing distributions from other qualified retirement plans. The Sponsor provides a safe harbor non-elective contribution equal to 3% of the participant's compensation for the plan year. Additional non-elective discretionary contributions to eligible participants are allowed under the Plan. For the 2024 plan year, the Sponsor made no additional discretionary contributions.

**Participant accounts** – Each participant's account is credited with the participant's contributions, rollovers, employer contributions, and the participant's share of plan earnings or losses and expenses. Participant accounts are invested based solely on participant elections.

**Notes receivable from participants** – The Plan provides a provision that allows participants to borrow up to one-half of their vested interest in the Plan. Loans may not exceed \$50,000. The loans are secured by the participants' vested account balances. The interest rate is determined by the Sponsor based on a reasonable rate of interest as compared to interest rates charged for similar types of loans by other lenders. The principal balance plus interest is repaid through employee payroll deductions over a maximum of 5 years, except in the case of a loan made for the purpose of acquiring their primary residence, in which case the loan repayment term may be extended.

**Vesting and forfeitures** – Participants are immediately vested in their contributions, rollover contributions, safe harbor contributions and earnings thereon. Vesting in the discretionary profit sharing contributions plus actual earnings thereon is based on years of continuous service (in which participant has a minimum of 1,000 hours of service in that year) according to the following schedule:

Forfeitures of terminated participants' non-vested accounts will be used pay allowable administrative expenses and reduce Sponsor contributions. Forfeitures totaled \$9,642 and \$12,654 in 2024 and 2023, respectively, and these forfeitures were applied to allowable administrative expenses and to reduce funding of the Sponsor contributions for the Plan years then ended.

**Payment of benefits** – Distributions from the Plan are available to participants or their beneficiaries upon the participant attaining age 59 ½, at retirement, or upon termination of employment. In the case of financial hardship, participants may withdraw their own elective deferrals subject to the requirements of the Plan.

**Costs of administration** – Fees and expenses incurred for services and goods provided to the Plan are the liability of the Plan. The Sponsor is jointly liable to third parties for payment of such fees and costs. The Sponsor may voluntarily reimburse the Plan for any of the fees and costs. Any reimbursement by the Sponsor to the Plan is not considered an employer contribution.

**Termination of the Plan** – Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA.

## 2. SIGNIFICANT ACCOUNTING POLICIES

**Basis of accounting** – The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Investment valuation and income recognition** – The Plan's investments are stated at fair value based on public prices traded in the active market. Purchases and sales of securities are recorded on a trade-date basis. Interest income and gains (losses) are recorded on the accrual basis. Dividends and capital gain distributions are recorded on ex-dividend dates. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

The Plan has a fully benefit-responsive investment contract which is reported at contract value. Contract value is the relevant measure for the portion of net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan. See Note 4 for discussion of the investment contract.

**Notes receivable from participants** – Participant loans are valued at their unpaid principal balance plus accrued interest. Interest income is recorded on an accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Contributions** – Employee contributions are recorded in the period payroll deductions are made. Contributions from the Sponsor are recorded in the period to which the contributions relate.

**Payment of benefits** – Benefits are recorded when paid.

**Tax status** – The Plan obtained its latest determination letter on April 10, 2014, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the plan administrator and the Plan’s tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, and, therefore, believe the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administration believes the Plan is no longer subject to income tax examinations for the years prior to 2019.

**Estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Parties-in-interest** are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. OneAmerica for American United Life Insurance Company is the Plan recordkeeper and American United Life Insurance Company is the Plan’s Trustee, therefore, the Plan’s payment of fees to OneAmerica for American United Life Insurance Company American United Life Insurance Company qualify as party-in-interest transactions.

The Plan investments include a benefit-responsive contract held by the Trustee. Consequently, these transactions are qualified as party-in-interest transactions (see supplemental schedule). Any purchases and sales of the investments are performed on the open market at fair value. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan, and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

Notes receivable from participants also reflect party-in-interest transactions. Certain administrative functions are performed by officers or employees of the Sponsor. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Sponsor.

**Risks and uncertainties** – The Plan invests in various investment securities. Investments, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits and benefit obligations.

**Subsequent events** have been evaluated through June 11, 2025, the date the financial statements were available to be issued. Management concluded that no material subsequent events have occurred since December 31, 2024, that require recognition or disclosure in the financial statements.

### 3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observed for substantially the full term of the asset or liability.

Level 3 Unobservable inputs for the asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

All of the Plan's investments invested in mutual funds are classified within Level 1 of the fair value hierarchy because they are measured by pricing on publicly traded markets with reasonable levels of price transparency.

### 4. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan's investments in the AUL Stable Value Fund are offered through a group annuity contract. The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The following represents the Plan's investment in fully benefit-responsive investment contracts at December 31:

The AUL Stable Value Account (SVA) is an interest-earning investment option, backed by AUL's general account assets. Interest is credited to all SVA monies at the current rate declared by AUL. New contributions and transfers to the SVA earn the interest rate in effect at the time of the contribution or transfer. AUL may declare a new interest rate for the SVA that becomes effective on

January 1 of each calendar year; however, any increase in the interest rate will never be greater than 1.00% above the previously declared rate. The minimum interest rate guarantee is 0%. For those group variable annuity contracts subject to SEC registration, AUL maintains a Guaranteed SVA Account Value equal to the greater of the participant's or the contract holder's SVA Account Value or an amount equal to the total of all contributions, transfers, and reallocations to the SVA for the participant or the contract holder that have not been withdrawn previously, at a rate of interest guaranteed in the group variable annuity contract. These guarantees are based on the continued claims-paying ability of AUL. The crediting rate is reviewed on an annual basis for resetting. The interest rate was 2% and 1.25% as of December 31, 2024 and 2023, respectively.

### 5. CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by American United Life Insurance Company (the trustee of the Plan).
