## Independent Auditors' Report

### The Board of Trustees of Brooklyn Prospect Charter School Retirement Plan

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of the Brooklyn Prospect Charter School Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institutions).

Management has obtained certifications from the qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### ***Opinion***

### 1. Description of Plan

The following description of the Brooklyn Prospect Charter School Retirement Plan (the "Plan") is provided for general information only. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### ***General***

The Plan is a defined contribution plan covering substantially all employees of Brooklyn Prospect Charter School (the "School" or "Employer"). There are no minimum age or service requirements for employees to participate in the Plan. Nonresident aliens and temporary or seasonal employees who work less than 1,000 hours per year are not eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### ***Contributions***

Each year, participants may contribute up to 80% of their eligible compensation on a pre-tax or after-tax (Roth) basis, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. There is an annual dollar limit as to the amount that can be deducted from compensation that is determined by the Internal Revenue Code ("IRC"). Participants may also rollover or transfer amounts representing distributions from other qualified plans.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically invested in a designated fund until changed by the participant. Unless a participant elects otherwise, the Plan provides for automatic enrollment at a contribution rate of 2% of a participant's eligible compensation and there is no escalation provision.

The Plan provides for an Employer matching contribution to the Plan. The employer matching contribution is equal to 100% of a participant's elective deferrals up to 4% of their eligible compensation. The Employer may also contribute a discretionary non-elective contribution to the Plan which would be allocated as a uniform percentage of participant compensation. For the 2024 plan year, no non-elective contributions were made to the Plan.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of (a) Employer contributions and (b) Plan earnings (losses) thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All investments of the Plan are participant directed.

### 1. Description of Plan (*continued*)

#### ***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum amount of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their account balance. Principal and interest is repaid through payroll deductions. The term of the loans is limited to five years unless it is used for the purchase of a participant's principal residence, which is limited to a period consistent with commercial home loan practices. A participant may have no more than one outstanding loan from the Plan at any time. Upon termination of service, the principal balance and accrued interest shall be immediately due and payable.

#### ***Payment of Benefits***

Benefits are paid upon retirement, age 59 ½, death, or other termination of employment. Upon termination of service, a participant's balance will be paid in a lump-sum amount equal to the participant's account balance, installment payments over a specified period of time, or periodic installments payments of a specified dollar amount. Benefits can also be distributed in the event of a participant's immediate and heavy financial need. Such distributions, which are considered withdrawals, are subject to restrictions as to use of the proceeds. Upon termination if a participant's vested account is \$5,000 or less, the participant will receive the value of his or her account in a single lump-sum distribution.

#### ***Vesting***

Participants are immediately vested in their elective deferral contributions, plus actual earnings thereon. For the Employer matching and non-elective contributions and earnings thereon, participants are vested at the rate of 50% per year after the second year of service with full vesting occurring after the third year of service. A participant will become 100% vested if the participant incurs a severance of employment due to death or disability.

#### ***Forfeitures***

If a participant terminates employment and is less than 100% vested, they forfeit the non-vested portion of their account balance. Forfeitures are retained in the Plan and may be used to either reduce future Employer matching contributions or Plan expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$59,324 and \$2,684. During 2024, \$103,939 were used to reduce Employer contributions and \$300 were used to reduce Plan expenses.

### ***Plan Expense Account***

The Plan and Empower entered into a revenue sharing arrangement whereby annual basis points of .25% will be deducted from Plan assets (prorated monthly) for payment of expenses related to the Plan's registered investment advisor. The Plan Expense Account is a nonparticipant directed account within the Plan and is used to record-keep the deductions from Plan assets as outlined in the agreement. The Plan Expense Account balance was \$0 at December 31, 2024 and 2023. During 2024, Plan expenses were reduced by \$34,376 from the Plan Expense Account.

## 2. Summary of Significant Accounting Policies

### ***Basis of Accounting and Use of Estimates***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. At December 31, 2024 and 2023, all of the Plan's investments, that were valued at fair value, were valued using level 1 inputs.

### ***Investment Valuation and Income Recognition***

All of the Plan's investments are stated at fair value except for the group annuity contract, which is stated at contract value. Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. These funds are deemed to be actively traded. The group annuity contract is valued at contract value, which represents contributions plus credited interest less participant withdrawals and fees.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

#### ***Payments of Benefits***

Distributions are recorded when paid.

#### ***Expenses***

Certain expenses of the Plan are paid by the School and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in value of investments.

#### ***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is September 25, 2025.

### 3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Life & Annuity Insurance Company of New York and Empower Trust Company, LLC, qualified institutions.

### 4. Group Annuity Contract

The Key Guaranteed Portfolio Fund (the "Fund") is a fully benefit-responsive general account product of Empower Annuity Insurance Company of America ("EAICA"). Because the Fund is a general account product offered through the group annuity contract, principal and interest for participant-initiated benefit payments are fully guaranteed by the entire general account assets of EAICA.

### 4. Group Annuity Contract (*continued*)

The Fund credits interest daily and the crediting interest rate may change or stay the same each quarter. The quarterly crediting rate applies to all money deposited regardless of when it was deposited.

A participant may transfer their account balance in the Fund to any other investment option offered under the Plan at any time, with no restrictions or penalties because the Fund is designed to be a Plan's only capital preservation option.

Upon termination of the group annuity contract, the plan sponsor may choose the following options associated with the Fund depending on the provisions in the applicable Fund rider which are: (1) receive the payout of the Fund in a lump sum with a market value adjustment; (2) receive the payout of the Fund in a lump sum at book value (EAICA may defer payment to a date no longer than 12 months in the future); or (3) mutually agree in writing to any other payout option allowable under applicable law.

The credit risk of the issuer, EAICA, was evaluated by nationally recognized statistical rating agencies as follows: A.M. Best Company, Inc. (A+), Moody's Investors Service (Aa3), Standard and Poor's Ratings Services (AA), and Fitch Ratings (AA-). These ratings were as of December 31, 2024.

### 5. Plan Termination

Although it has not expressed any intent to do so, the School has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

### 6. Tax Status

The Internal Revenue Service ("IRS") issued an opinion letter to the prototype plan document preparer dated November 14, 2022, which states that the form of the prototype plan qualifies under the applicable provisions of the IRC. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

### 7. Party-in-Interest Transactions

The group annuity contract is issued by Empower Life & Annuity Insurance Company of New York, a trustee of the Plan. Therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

### 7. Party-in-Interest Transactions *(continued)*

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

### 8. Prohibited Transaction

During the 2023 plan year, the Employer failed to remit to the Plan certain participants' contributions and loan repayments amounting to \$308,974 within the period prescribed by the Department of Labor regulations. Delays in remitting the contributions to the Plan were due to administrative oversight. The Employer is in the process of making the necessary corrections to satisfy both the Department of Labor and IRS guidance.

### 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect, the value of the Plan's net assets available for benefits. The effects of economic and market conditions subsequent to December 31, 2024 are not reflected in these financial statements and future effects on the Plan's net assets available for benefits cannot be predicted.
