Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Gryphon Investors 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Notes to Financial Statements

Note 1. Description of the Plan

The following description of the Gryphon Investors 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General and eligibility: The Plan is a defined contribution retirement plan established January 1, 2006, for the benefit of all employees of Gryphon Advisors, LLC (the Company or Plan Sponsor), who have attained the age of 21 years, except for employees who are nonresident aliens or employees solely compensated under a collective bargaining agreement. The Plan is subject to the provisions of the Employment Retirement Income Security Act of 1974 (ERISA). Participants are eligible for participation immediately upon employment commencement date or if later, upon satisfaction of eligibility conditions. Charles Schwab Trust Bank (Charles Schwab or the Trustee) is the Plan trustee and custodian. Milliman, Inc. (Milliman) provides administrative and record-keeping services to the Plan.

Contributions: Each year, participants may contribute up to 100% of pretax or after-tax annual compensation, subject to maximum limits defined by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contributions plans (rollovers).

Employer matching contributions are based on the safe harbor matching contribution formula and the Company matches all contributions at the rate of 100% of the first 3% of an active participant's compensation contributed to the Plan and at 50% of the next 2% of the active participant's compensation contributed to the Plan. For the year ended December 31, 2024, the Company made matching contributions to the Plan totaling \$1,415,353. The Company may also contribute discretionary contributions annually, subject to certain statutory limits, which the Company determines at its discretion. No discretionary contributions were made to the Plan for the year ended December 31, 2024.

Participant accounts: Each participant's account is credited with the participant's contributions and allocations of: (a) Plan's earnings or losses on investments, and (b) administrative expenses. Allocations are based on a participant's earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of contributions into various investment options offered by the Plan.

Notes receivable from participants: Participants may borrow from their accounts a minimum of \$1,000, up to maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are secured by the balance in the participant's account and bear interest at the rate of prime plus 1%. Principal and interest are repaid ratably through payroll deductions within five years, or up to 15 years if used to acquire a principal residence of the participant. In the event the scheduled repayment remains unpaid as of the last business day of the calendar quarter following the calendar quarter in which a loan is initially considered past due, the loan is considered to be in default and considered a deemed distribution.

Vesting: Participants are 100% vested immediately in their contributions plus actual earnings thereon and the Company's safe harbor matching contributions. Employer discretionary contributions vest 25% annually for each year of credited service, which is defined as 1,000 hours, and are fully vested after four years.

Note 1. Description of the Plan (Continued)

Payment of benefits: Upon termination of service due to death, disability, retirement or termination of employment, a participant or beneficiary, as applicable, shall receive a lump-sum distribution in an amount equal to the value of the participant's interest in his or her account. If a participant's vested account balance is equal to or less than \$1,000, and no election is made, the vested account balance will be distributed directly to the participant. The Plan also allows in-service withdrawals and hardship withdrawals under certain circumstances.

Forfeited accounts: The Plan provides for forfeitures of terminating participants' nonvested accounts to pay for administrative expenses or reduce future employer contributions under the Plan's provisions. As of December 31, 2024 and 2023, and during the year ended December 31, 2024, there were no forfeitures.

Revenue sharing account: Fees received from the Plan investments in the form of 12b-1 fees, sub-transfer agency fees and administrative servicing fees, are paid into a revenue sharing account within the Plan. Contractual fees for recordkeeping services and for other allowable plan administrative expenses are generally paid from this account. For the year ended December 31, 2024, revenue sharing income received totaled \$17,980 and expenses paid totaled \$17,980. The balance of revenue sharing funds at December 31, 2024 and 2023, was \$38 respectively. Revenue-sharing net activity is reflected in net appreciation in fair value of investments.

Note 2. Summary of Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting under accounting principles generally accepted in the United States of America (U.S. GAAP).

Contributions: Contributions from the Plan participants are recorded in the year in which participant contributions are withheld from amounts paid. As of December 31, 2024 and 2023, there were no participant contributions receivable. Safe harbor matching contributions are recorded in the year that the contributions are withheld from amounts paid and remitted on a quarterly basis. As of December 31, 2024 and 2023, there were \$82,859 and \$98,231 of employer contributions receivable, respectively. Discretionary contributions, if any, or recognized upon the authorization of the Company. All participant and employer contributions are participant-directed.

Use of estimates: The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities, at the date of the financial statements, and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by Charles Schwab. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Note 2. Summary of Accounting Policies (Continued)

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. As of December 31, 2024, the rates of interest on outstanding loans range from 4.25% to 9.50% with various maturities through September 2029.

Benefits: Benefits are recorded when paid.

Administrative expenses: The Plan incurs record-keeping and administrative expenses. Specific participant transaction expenses are deducted from participant accounts directly. Plan expenses that cannot be directly charged to a specific participant transaction may be paid, in whole or in part, from revenue-sharing payments that the Plan receives from certain participant funds or paid by the Company. Investment-related expenses are included in net appreciation in fair value of investments.

Subsequent events: The Plan has evaluated subsequent events through September 8, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified and Provided by Charles Schwab

The following is a summary of the plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab, a qualified institution:

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under Accounting Standards Codification 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

Registered investment companies (mutual funds): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded (Level 1).

Money market fund: Valued at the daily closing price as reported by the fund. Money market funds hold primarily cash and these funds are required to publish their NAV and to transact at that price. The money market fund held by the Plan is deemed to be actively traded (Level 1).

Note 5. Related-Party and Party-In-Interest Transactions

Charles Schwab is the Trustee and custodian and Milliman is the third-party record-keeper, as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Charles Schwab and Milliman for custodian and record-keeping services totaled approximately \$17,600 and \$5,800, respectively, for the year ended December 31, 2024.

Certain administrative functions are performed by employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan. Administrative expenses for participants are paid directly by the Plan Sponsor.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in any portion of their accounts not already 100% vested.

Note 7. Tax Status

The Plan has adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since adopting the preapproved plan document; however, The Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
