## **Independent Auditor's Report**

To the Plan Administrator, Participants, and Beneficiaries of G.L. Homes of Florida Corporation 401(k) Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of G.L. Homes of Florida Corporation 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of G.L. ### 1. Description of Plan

The following description of the G.L. Homes of Florida Corporation 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan established January 1, 1992, as restated July 1, 2022. The Plan covers all employees of G.L. Homes of Florida Corporation; GL Financial Services, LLC; Grey Management, LLC; G.L. Commercial Management, LLC; and Nova Title Company (collectively, the Company) under the provisions of Section 401(a) of the Internal Revenue Code (IRC) who have completed three months of service and are age 20.5 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The 401(k) Plan Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and is responsible for oversight of the Plan.

#### Contributions

Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined in the Plan document, up to the maximum limits prescribed by the Internal Revenue Code (IRC). Participants' contributions were limited to an annual maximum of \$23,000 and \$22,500 for the Plan years ended December 31, 2024 and 2023, respectively. Participants over the age of 50 are allowed to contribute an additional \$7,500 for the Plan years ended December 31, 2024 and 2023. The Company may make discretionary matching contributions in amounts to be determined by the Company. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

Participants are eligible for Company discretionary matching contributions once they have completed one year of service defined as a year in which an employee accrues 1,000 or more hours of service. The Plan requires a participant to be employed as of year-end to be eligible to receive discretionary matching contributions unless the participant terminated due to retirement, disability, or death. For the years ended December 31, 2024 and 2023, the Company matched 25% of the participants' pre-tax contributions up to 6% of base compensation, as defined in the Plan. Participants direct the investment of participant and employer contributions.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation. The Plan does not have an escalation feature.

Effective January 1, 2025, automatically enrolled participants will have their deferral rate increase by 1% each January 1st until their deferral rate reaches 10%.

#### Participant accounts

Each participant's account is credited with the participant's contributions and an allocation of the (a) the Company's discretionary contributions and (b) the Plan's earnings and appreciation/depreciation in the value of investments, and may be reduced by allocations of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### 1. Description of Plan (continued)

#### Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the employer discretionary matching contribution portion of their accounts, plus actual earnings thereon is based on years of continuous service. A participant is 25 percent vested after two years of credited service and continues to vest in increments of 25 percent until 100 percent vested after five years of credited service. A year of vesting service is defined as a year in which an employee accrues 1,000 or more hours of service.

#### Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at 2 percent above the prime rate, as defined. Terms range from one to five years or greater for the purchase of a primary residence. Interest rates on outstanding loan balances at December 31, 2024 and 2023 range between 3.25% and 10.50%. Principal and interest are paid ratably through bi-weekly payroll deductions. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document

#### Payment of benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or installment payments as provided in the Plan document. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. If a terminated participant's vested balance is less than or equal to \$7,000, the amount may be automatically distributed in the form of cash or as a direct rollover, as elected by the Participant, but if the Participant fails to make an election, as an automatic rollover for amounts greater than \$1,000 and a cash payment for amounts \$1,000 or less. In addition, the Plan allows for hardship distributions if certain criteria are met.

#### Forfeited accounts

Forfeitures of non-vested accounts are used during the year to pay administrative expenses and reduce employer contributions. During the years ended December 31, 2024 and 2023, forfeitures of \$28,635 and \$38,833, respectively, were used to reduce employer contributions. During the years ended December 31, 2024 and 2023, no forfeitures were used to pay Plan expenses. Forfeited nonvested accounts available at December 31, 2024 and 2023 were \$19,431 and \$24,446, respectively.

### **2. Summary of Accounting Policies**

#### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Plan expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

#### **Subsequent events**

Subsequent events were evaluated through September 30, 2025, the date the financial statements were available to be issued.

### 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Investments measured at net asset value:* Consisting of common-collective trusts, valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. There were no unfunded commitments or redemption restrictions at December 31, 2024 and 2023, and there is no notification period for a Plan level redemption of the collective trusts.

### **5. Related-Party and Party In Interest Transactions**

Certain Plan investments are managed by the Trustee, and therefore, these transactions qualify as party in interest transactions and are included in net appreciation in fair value of investments on the statements of changes in net assets available for benefits. As service providers to the Plan, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to these service providers were \$50,259 and \$50,056 for the years ended December 31, 2024 and 2023, respectively.

Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

### **6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

### **7. Tax Status**

The Plan adopted pre-approved plan offered by Schwab Retirement Plan Services. On September 21, 2020, the IRS stated in an opinion letter that the pre-approved plan and related trust adopted by the Plan, as then designed, was in compliance with applicable requirements of the IRC and, therefore, the related trust is exempt from taxation. The Plan has been amended since receiving the letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

### **8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments at December 31, 2024 may not necessarily be indicative of amounts that could be realized in a current market exchange.
