### Report on the Audit of the Financial Statements

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the accompanying financial statements of Haverford College Retirement Healthcare Savings Program (formerly Emeriti Retiree Health Plan for Corporation of Haverford College), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Haverford College Retirement Healthcare Savings Program's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). We are required to be independent of Haverford College Retirement Healthcare Savings Program and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

**NOTE 1 DESCRIPTION OF PLAN**

The following description of the Haverford College Retirement Healthcare Savings Program (the Plan) (formerly Emeriti Retiree Health Plan for Corporation of Haverford College) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan, which was established July 1, 2005, is a defined contribution health and welfare plan covering substantially all employees of Haverford College (the College) who are not seasonal employees or employees scheduled to work less than 910 hours (1,000 hours effective July 1, 2024) per year. Plan assets are held in a voluntary employees' beneficiary association (VEBA) trust. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Effective July 1, 2024 the Plan name was changed from Emeriti Retiree Health Plan for Corporation of Haverford College to Haverford College Retirement Healthcare Savings Program.

CBiz Benefits and Insurance Services, Inc. performed recordkeeping and claims management services for the Plan through March 31, 2024. Effective April 1, 2024 OneBridge Benefits, Inc. assumed recordkeeping and claims management of the Plan.

**Eligibility**

Employees are eligible to participate in after-tax salary reduction arrangement in the Plan after attaining age 21. Employees are eligible to participate in College contributions after attaining age 40. Fixed-Term Employees have a one year waiting period before eligibility. Entry into the Plan is the month in which eligibility requirements are met.

**Contributions**

Eligible employees and retirees may voluntarily contribute a portion of their after-tax compensation, as defined by the Plan. The College begins making employer contributions to the Plan on behalf of each eligible employee as soon as administratively possible after the employee attains age 40. The College's contribution is based on an annual flat dollar amount for each eligible participant, adjusted annually as determined at the discretion of Plan management. The College will cease making employer contributions to a participant's account as of the date when the College has made contributions for 25 years, the employee ceases to be employed by the College, or if the participant dies. The approved annual employer contribution for the year ended December 31, 2024 was \$1,000.

**Benefit Payments**

A participant who is employed by the College meets the requirements for eligibility under the Plan upon attaining age 60, having performed at least seven years of continuous service, or age 65, having performed at least five years of continuous service.

**Benefit Payments (Continued)**

Upon meeting the requirements for retirement eligibility under the Plan, participants are reimbursed for allowable medical expenses for themselves, spouses, domestic partners, and those individuals designated as dependents. The Plan also provides eligible participants with the option to enroll in medical and dental insurance coverage through Aetna Life Insurance Company.

In addition, participants who cease employment with the College are eligible for reimbursement benefits from their vested account balance.

**Insured Benefits**

The Plan provides for fully insured medical, dental, and prescription drug benefits. The College purchases annual insurance contracts for these insured benefits. Premiums for all insured benefits are paid from the participant's account balance or retiree contributions.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, the College's contributions, allocations of Plan earnings or losses, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. Income is allocated daily based on the shares in the participant's vested account. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

**Vesting and Forfeitures**

Participants are immediately vested in their employee contributions plus actual earnings thereon. A participant who has met the requirements for retirement eligibility, or has completed at least seven years of continuous service, will not forfeit his or her accumulated employer account balance upon termination of employment. If a participant ceases to be employed by the College and has not met the eligibility requirements for vesting of employer contributions, those contributions are forfeited to the Plan. Forfeitures of employer contributions are used to reduce future College contributions or effective July 1, 2024, can also be used to pay Plan expenses as well. Any residual balance remaining in the employee after-tax contribution account upon the participant's death and the death of any related dependents will be forfeited to the Plan. Forfeited employee contributions are allocated among participants with a positive balance in their employee contribution account.

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$27,258 and \$17,781, respectively. There were \$29,133 of forfeitures used to offset College contributions for the year ended December 31, 2024.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, benefit obligations and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Administrative Expenses**

The College pays certain administrative expenses incurred in connection with the operation of the Plan. The administrative expenses on the statement of changes in net assets available for benefits primarily represent fees deducted from participants' accounts for recordkeeping, consulting, and custodial services.

**Payment of Benefits**

Reimbursements for qualified medical expenses are recorded when paid. Premiums paid by the Plan are recorded as premium payments in the accompanying statement of changes in net assets available for benefits and benefit obligations.

**Benefit Obligations**

Health costs incurred by certain participants and their beneficiaries are covered by group insurance contracts maintained by the Plan. It is the present intention of the Plan Sponsor to continue obtaining fully insured insurance coverage for such costs. There were no premiums payable as of December 31, 2024 and 2023.

**Subsequent Events**

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through September 10, 2025, the date the financial statements were available to be issued.

**NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION**

TIAA Trust, N.A. the qualified institution of the Plan as of December 31, 2023 and for the period January 1, 2023 through December 16, 2024 and Alta Trust, the qualified institution of the Plan as of December 31, 2024 and for the period December 17, 2024 through December 31, 2024, have supplied the Plan administrator with certifications as to the completeness and accuracy of all investment information reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4 FAIR VALUE OF INVESTMENTS**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

**NOTE 4 FAIR VALUE OF INVESTMENTS (CONTINUED)**

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

*Money Market Fund:* Valued at the net asset value (NAV) of shares held by the Plan at year-end based on a quoted price in an active market.

*Registered Investment Companies:* Valued at the NAV of shares held by the Plan at year-end as quoted in active markets. In an effort to reduce market timing and excessive trading, shareholders will be locked out of a fund for 90 days if a purchase, sale, and repurchase with that fund is made within a 60-day period.

**NOTE 5 RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 6 PLAN TERMINATION**

Although it has not expressed any intent to do so, the College has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE 7 PLAN TAX STATUS**

The VEBA trust funding certain benefits of the Plan received an exemption letter from the Internal Revenue Service (IRS) dated October 11, 2006, stating that the trust is tax-exempt under the provisions of Section 501(c)9 of the Internal Revenue Code (IRC). However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. No federal or state income taxes have been recorded in 2024 for unrelated business taxable income.

In addition, the Plan and trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 PARTY-IN-INTEREST TRANSACTIONS**

The Plan investments are managed by Alta Trust and TIAA, TIAA Trust, N.A., the qualified institutions as defined by the Plan, and therefore, the investment transactions qualify as party-in-interest transactions. Fees incurred by the Plan for recordkeeping, consulting, and custodial services during the year ended December 31, 2024 also qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
