## **NOTE 1 - DESCRIPTION OF PLAN**

The following description of the LPHC, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions. The Plan is sponsored by Lodestone Pacific Holding Company, Inc. (the Company).

### **General Description**

The Plan is a defined contribution plan covering substantially all employees of Lodestone Pacific, Inc., Bettendorf Enterprises, Inc., Eureka Ready Mix, Inc., and Customer Truck Service, who have one year of service and are age eighteen or older. An employee who becomes eligible under the Plan begins participation effective the first day of the first or seventh month following completion of eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Company's Board of Directors is responsible for overseeing the Plan. The Board appoints the trustee of the Plan who is responsible for its investment policy. The assets of the Plan are administered by the Company under the direction of the trustee.

### **Contributions**

Participants may make traditional 401(k) or Roth 401(k) contributions to the Plan up to the annual maximum amount determined by the Internal Revenue Service, including catch-up contributions by participants who have attained age 50 before the end of the Plan year. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Company may make discretionary profit sharing contributions to the Plan, up to the legal maximum, allocated pro-rata based upon annual compensation of all eligible participants. During the year ended December 31, 2024, the Company did not make a profit sharing contribution to the Plan. The Company also makes matching contributions to the Plan of fifty percent of the first one thousand dollars contributed by each participant. Total employer matching contributions for the year ended December 31, 2024 were \$47,364.

Participant deferral and company matching contributions to the Plan are specifically directed by the participants into various investment options offered by the Plan.

### **Participant Accounts**

Each participant's account is credited with the participant's contribution, the Company matching contribution, and allocations of (a) the Company's profit sharing contribution, (b) Plan earnings, and (c) forfeitures of terminated participants' nonvested accounts, other than those used for Plan expenses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are immediately vested in their voluntary contributions and the Company matching contribution plus actual earnings thereon. Vesting in the Company profit sharing contribution plus earnings thereon is based on years of service based on the following vesting schedule:

A year of service, for purposes of vesting, is a twelve consecutive month computation period during which an employee works 1,000 or more hours.

**Payment of Benefits**

Upon retirement, termination of employment, death or disability, the value of a participant's vested benefits may be paid in a single lump-sum distribution. The Plan also allows in-service distributions and hardship distributions under certain conditions and within limitations specified by the Plan. The Plan has a \$5,000 threshold for vested account balances for terminated employees. If the vested portion of a participant account is below \$5,000 at the time the participant is terminated, the vested balance will be distributed in a lump sum as soon as administratively feasible after termination. In the absence of a distribution request, the Plan will establish an individual retirement account (IRA) in another bank, outside of the Plan, and roll the vested balance of the account to the IRA if the amount exceeds \$1,000. If the vested balance is \$1,000 or less, a lump sum cash distribution will be made.

**Forfeited Accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$-0- and \$-0-, respectively. Forfeitures may be allocated to participants as additional non-elective contributions or used to pay expenses of the Plan.

**Retirement**

Normal retirement under the Plan is 60 years of age.

**NOTE 2 - SUMMARY OF ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting with the exception of benefits, which are recorded when paid.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are carried at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustee determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. Investment fees are netted against the appreciation or depreciation in the fair value of investments of the funds and are not separately stated. See Note 4 for discussion of fair value measurements.

## **NOTE 2 - SUMMARY OF ACCOUNTING POLICIES (continued)**

### **Investment Valuation and Income Recognition (continued)**

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Expenses**

All expenses incurred in administering the Plan may be paid out of the trust fund or paid by the Company. The Company absorbs significant costs of the Plan. Such expenses include any expenses incident to the functioning of the administrator including, but not limited to, fees for accountants, counsel and other specialists and other costs of the Plan. Investment related expenses are included in net appreciation of fair value of investments.

## **NOTE 3 - INFORMATION CERTIFIED BY THE TRUSTEE**

The Plan Administrator has elected the method of compliance permitted by 29 CFR Section 2520.103-8 of the Department of Labor Rules and Regulations and disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by the trustee, John Hancock Life Insurance Company, and was not subjected to any auditing procedures performed:

- All investments shown in the accompanying statements of net assets available for benefits.
- Net investment income from the investments, as shown in the accompanying statement of changes in net assets available for benefits, including net realized and unrealized appreciation (depreciation) in the fair value of assets.

## **NOTE 4 - FAIR VALUE MEASUREMENTS**

FASB Accounting Standards Codification 820, Fair Value Measurement ("ASC 820"), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets and liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:  
Quoted prices for similar assets or liabilities in active markets;  
Quoted prices for identical or similar assets or liabilities in inactive markets;  
Inputs other than quoted prices that are observable for the asset or liability;  
Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**NOTE 4 - FAIR VALUE MEASUREMENTS (continued)**

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value:

John Hancock relies on a third-party trading operations manager, RPS Trading Operations (RPS), to calculate the daily unit values of each sub-account using net asset value (NAV). Each sub-account invests in shares of an Exchange Traded Fund (ETF), which have different classes of units, depending on the Cost of Class of Funds selected.

Fund information is received electronically by RPS daily from the market and uploaded to a unit valuation system that ensures information on all funds has been received, the valuation date is accurate and that all income distribution factors have been updated before final daily calculation. If there are discrepancies between the net asset value and the market change, the unit valuation system will display a warning message and RPS will investigate the discrepancies and take action as required.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5 - RELATED-PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS**

The Plan invests in pooled separate accounts managed by John Hancock Life Insurance Company, the trustee, as defined by the Plan and, therefore, transactions with John Hancock Life Insurance Company qualify as party in interest transactions. Morgan Stanley provides investment advisory services to the Plan and, therefore, transactions with Morgan Stanley qualify as party in interest transactions. Peery & Associates, Inc. is the third-party administrator of the Plan and, therefore, transactions with Peery & Associates, Inc. qualify as party in interest transactions. Platform CPA's LLP performs the annual Plan audit and, therefore, transactions with Platform CPA's LLP qualify as party-in-interest transactions.

**NOTE 5 - RELATED-PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS  
(continued)**

Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. Plan administration and investment advisory services are included in administrative expenses. As described in Note 2, expenses incurred in administering the Plan are paid out of the trust fund or paid by the Company.

**NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

**NOTE 7 - TAX STATUS**

The Company adopted a Prototype Non-standardized Profit Sharing Plan with a Cash or Deferred Arrangement (CODA), which received a favorable opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). While the prototype plan has been amended since receiving the letter, the plan administrator believes the Plan has been operated in accordance with the applicable provisions of the IRC. The Plan is qualified under Section 401(a) of the IRC and is exempt from federal income tax under provisions of Section 501(a) of the IRC, and from applicable state tax, as state law conforms to the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service.

The Plan is subject to routine audits by taxing jurisdictions. In general, the Plan's returns are subject to examination by federal tax authorities for a period of three years beginning with the later of the due date of the return or the date they are filed. There are currently no examinations in progress.

**NOTE 8 - RISKS AND UNCERTAINTIES**

Each investment fund is diversified through a portfolio containing a wide variety of investments that fit the particular investment strategy and targeted composition. Further diversification is available to participants through participation in more than one fund. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Credit risk is considered to be minimal. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

**NOTE 9 - SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through October 2, 2025, which is the date the financial statements were available to be issued.
