### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### Notes to Financial Statements

#### 1. Description of Plan:

The following description of the Virginia Physicians, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering all eligible employees of Virginia Physicians, Inc. (the "Company"), except for any collectively bargained (union) employees. Employees became eligible to participate in the plan after completing one year of service with at least 1,000 hours of service. Effective March 15, 2017, employees become eligible to participate in the plan after completing 90 days of service. Employees become eligible to receive matching non-elective safe harbor and profit sharing contributions on the first day of the month coinciding with or next following the date the employee completes one year of service with at least 1,000 hours of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Contributions:** The Plan provides for participant contributions of pre-tax and Roth contributions of annual compensation, as defined in the Plan. Participants may contribute up to 100% of pretax annual compensation. Participants may also contribute amounts representing distributions from other qualified plan and certain individual retirement accounts. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Plan includes an automatic increase of deferral rate of 1 percent per year until 10 percent until changed by the participant.

Annually, the Company makes a Safe Harbor Non-Elective contribution to the plan in the amount of 3% of the participants' covered compensation for the plan year. The Company may make a discretionary profit sharing contribution not to exceed 2% of a participant's covered compensation for the plan year and may also make a discretionary supplemental profit sharing contribution. There was a 2% percent profit sharing contribution to the Plan for 2024 and 2023.

**Participant Accounts:** Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) Plan earnings or losses, and charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investment Options:** Participants may direct Empower Annuity Insurance Company of America, as to the investment of their account balances in accordance with guidelines established by the Plan. Participants may change their investment elections at any time. Investments which are invested in one of the trustee's investment options are described herein as "Participant-Directed." Investments which are invested outside of the trustee's investment options are described as "Self-Directed."

### Notes to Financial Statements, Continued

#### 1. Description of Plan, Continued:

**Vesting:** Participants are immediately vested in their contributions and Safe Harbor Non-Elective contributions from the Company, plus actual earnings thereon. Vesting in the Company's discretionary matching and profit sharing contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. Participants are fully vested in Company contributions after attaining six years of credited service.

**Notes Receivable from Participants:** Participants may borrow from their Plan accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms cannot exceed five years, unless the proceeds are used to acquire a principal residence. The loans are secured by the vested balance in the participant's account and bear interest at rates commensurate with the bank prime rate plus 1% as determined by the U.S. Federal Reserve on the last business day of a calendar quarter. Principal and interest are paid ratably through payroll deductions. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Only one outstanding loan is allowed per participant at any one time. Management has evaluated notes receivable from participants for collectability and has determined that no allowance is considered necessary.

**Plan Administration:** Overall responsibility for administering the Plan rests with the Company. Participant accounts are administered by Empower which serves as third party administrator to the Plan. Empower Bank & Trust, FSB ("Trustee") serves as the trustee. The self-directed funds are the responsibility of the Plan administrator.

**Payment of Benefits:** On termination of service due to death or retirement, the participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, periodic installments over a term not to exceed the life expectancy of the participant or the joint life and last survivor expectancy of the participant and his spouse, or a single life annuity. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

**Forfeitures:** Forfeited balances of terminated participants' non-vested accounts are applied to pay administrative expenses or to reduce future Company contributions. Forfeited balances available at December 31, 2024 and 2023 were \$214,845 and \$186,129, respectively. No forfeitures were applied to reduce Company contributions during 2024 and 2023.

#### 2. Summary of Significant Accounting Policies:

**Basis of Accounting:** The financial statements of the Plan are prepared on the accrual basis of accounting.

#### 2. Summary of Significant Accounting Policies, Continued:

**Guaranteed Investment Contract:** Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the term of the Plan.

**Investment Valuation and Income Recognition:** The Plan's investments are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits:** Benefits are recorded when paid.

**Use of Estimates:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

**Subsequent Events:** Management has evaluated subsequent events through October 3, 2025, the date the financial statements were available to be issued, and has determined there are no subsequent events to be reported in the accompanying financial statements.

#### 3. Fair Value Measurements:

The Financial Accounting Standards Board (“FASB”) has issued guidance for measurement and disclosure of fair value and established a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology are quoted prices for similar instruments in active and inactive markets; and model driven valuations with significant inputs and drivers derived from observable active markets.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement. There were no level 3 investments as of December 31, 2024 and 2023.

Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for investments carried or disclosed at fair value:

**Money market fund:** Valued at cost, which approximates fair value.

**Mutual funds, corporate stocks and ETFs:** Valued at the closing price reported on the active market on which the individual securities are traded.

**Corporate bonds:** Valued using pricing models maximizing the use of observable inputs for similar securities. This includes basing values on yields currently available on comparable securities of issuers with similar credit ratings.

**Pooled separate accounts:** Valued at the net assets value (“NAV”) of shares held by the Plan at year-end. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 4. Investment Contract with Insurance Company:

The Plan entered into a traditional benefit-responsive investment contract with Empower. As the guaranteed investment contract issuer, Empower is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The specified interest rate is based on formula established by the contract issuer but may not be less than one percent. The guaranteed investment contract does not permit Empower to terminate the agreement prior to the scheduled maturity date. The average net interest credit rating was 2.10% for 2024 and 1.93% for 2023.

In accordance of FASB guidance Accounting Standard Update (ASU) 2015-12, because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or other factors.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

#### 5. Administrative Expenses:

Although not required by the Plan, some of the costs of the Plan administration are absorbed by the Company.

#### 6. **Related-Party Transactions:**

The Plan invests in various mutual funds and a guaranteed investment contract managed by Empower. These are related-party transactions and are identified as parties-in-interest in the accompanying schedule of assets (held at end of year). The Plan paid administrative fees to Empower amounting to \$74,396 during 2024 and \$83,011 during 2023.

The self-directed funds are administered by Buehler & Berryhill who charges participants transaction fees for services provided with regards to these accounts. Fees paid by the Plan for the investment management services for the self-directed funds are included in administrative expenses. The Plan paid \$59,415 of administrative expenses to Buehler & Berryhill in 2024 and \$43,991 in 2023.

#### 7. **Plan Termination:**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

#### 8. **Tax Status:**

The Internal Revenue Service has determined and informed the prototype sponsor by a letter dated September 16, 2022 that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter; however, the plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Management has evaluated the effects of accounting guidance related to uncertain income tax positions and concluded that the Plan had no significant financial statement exposure to uncertain income tax positions at December 31, 2024 and 2023. The Plan is not currently under audit by any tax authority.

#### 9. **Risks and Uncertainties:**

The Plan provides for various investment securities. Investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the financial statements.
