INDEPENDENT AUDITOR'S REPORT

To the Participants and Beneficiaries
Intermountain Centers for Human Development 401(k) Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Intermountain Centers for Human Development 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Intermountain Centers for Human Development 401(k) Profit Sharing Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

1. Description of Plan

The following description of the Intermountain Centers for Human Development (Organization) 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a deferred arrangement covering all full-time employees of the Companies owned by the Organization who have completed at least one year of service and are at least twenty-one years of age. The Companies owned by the organization include Intermountain Centers for Human Development, Inc., Behavioral Consultation Services, Intermountain Health Center, Inc., Intermountain Academy, Intermountain Foster Care LLC, and Community Partners, Inc. All full-time employees are eligible for employer discretionary contributions once they have completed at least one year of service and are at least twenty-one years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute a percentage of pretax annual compensation as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Organization may also make a discretionary contribution on the participants' behalf. Contributions are subject to certain limitations imposed by the Internal Revenue Service (IRS).

Participant Accounts

Each participant's account is credited with an allocation of the Organization's discretionary contribution, forfeitures and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

SECURE 2.0 Act

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023, which included SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions, with varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the plan administrator will determine the optional provision to elect and amend the Plan document accordingly. Most of the significant provisions will become effective in 2024 and thereafter. Management has determined there is no material impact to the Plan's 2024 financial statements.

Vesting

Participants are immediately vested in their voluntary contributions and rollover contributions, plus actual earnings thereon. Vesting in employer discretionary contributions, for participants that were not a part of the merger with the Community Partners, Inc. 401(k) Plan, is based on years of continuous service. A participant is 100% vested in employer discretionary contributions, plus actual earnings thereon, after three years of service based on a vesting schedule of 40% after one year of service, 80% after two years of service and 100% after three years of service. Vesting for participants that were a part of the merger with the Community Partners, Inc. 401(k) Plan, is based on years of continuous service. A participant is 100% vested in employer discretionary contributions after three years of service based on a vesting schedule of 33% per year. To earn a year of service, participants must be employed for a twelve-month period, beginning on the participant's date of hire.

1. Description of Plan, Continued

Notes Receivable from Participants

Participants may borrow from their fund accounts a maximum of \$50,000 or 50% of their account balance, whichever is less. The notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined quarterly by the Plan administrator. The interest rates on notes receivable from participants range from 3.25% to 9.50%. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installments over a period of years not exceeding the participant's normal life expectancy or the normal joint life expectancy of the participant and designated beneficiary. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Forfeited Accounts

At December 31, 2024 and 2023, there was \$226,947 and \$315,428, respectively, in forfeited non-vested accounts. During the years ended December 31, 2024 and 2023, forfeitures of \$-0- and \$118,087, respectively, were reallocated to participant accounts. There were no forfeitures used to reduce employer contributions during the years ended December 31, 2024 and 2023. Forfeitures of \$78,583 and \$11,903 were used to pay administrative expenses during the years ended December 31, 2024 and 2023, respectively.

Administrative Expenses

As provided in the Plan agreement, administrative expenses may be paid either by the Plan or by the Organization. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses. For the years ended December 31, 2024 and 2023, the Plan paid contract administrator fees of \$164,625 and \$73,731, respectively. All other administrative expenses, such as professional fees, were paid by the Organization on behalf of the Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Accounting Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a discussion of fair value measurements.

Investment Valuation and Income Recognition, continued

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net change includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid. Corrective distributions are reported as a reduction of employer contributions in the statement of changes in net assets available for benefits.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

Excess Contributions Payable

Amounts payable to participants totaling \$-0- and \$20,299 as of December 31, 2024 and 2023, respectively for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to participant contributions. The Plan distributed the 2023 excess contributions to the applicable participants prior to March 15, 2024.

Deferred Contribution Revenue

Deferred contribution revenue of \$95,768 and \$-0- as of December 31, 2024 and 2023, respectively, represents employee deferrals and employer contributions deposited on December 31, 2024 for a January 3, 2025 pay date. The contribution revenue will be recognized during the plan year ended December 31, 2025.

3. Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

4. Income Tax Status

The IRS has determined and informed plan management, by a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions. However, there are currently no audits in progress for any tax periods.

5. Fair Value Measurements

The Financial Accounting Standards Board has established a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: valued at the net asset value of shares held by the Plan.

Common/collective Trusts: Valued at the net asset value based on the market value of its underlying investments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values.

Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

During the years ended December 31, 2024 and 2023, the Organization inadvertently failed to deposit \$278,301 and \$561,816, respectively, of participant contributions within the required timeframe as stated by the Department of Labor (DOL). The amount of \$2,501 was corrected subsequent to December 31, 2024, and the amounts of \$275,800 and \$561,816 was corrected during the year ended December 31, 2024. The DOL considers late deposits to be nonexempt prohibited transactions. Management of the Organization believes that all required steps have been taken to correct this issue with the DOL and the Plan participants.
