**NOTE 1 – DESCRIPTION OF THE PLAN**

The following description of the Inland Counties Legal Services, Inc. Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Inland Counties Legal Services, Inc. (the Company) who have two months of service and are age 18 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees oversees governance of the Plan. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Trustees.

Contributions

Each year, participants may contribute a percentage of their compensation, not to exceed the maximum allowed by law. Participants may make pre-tax contributions and/or Roth contributions to the Plan and participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans as rollover contributions.

The Company makes matching contributions on behalf of each participant at one hundred percent of participant contributions, limited to one percent of a participant's compensation for the first year of service. After the first year of service the one percent limitation on compensation escalates to a maximum of five percent of compensation at ten years. The Company, at its discretion, may also make profit sharing contributions on behalf of participants.

Participant Accounts

An account is maintained for each participant. The participant's account is credited with the participant's contribution, matching contributions and allocations of (a) the profit sharing contribution, if any, and (b) Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at 3.25 to 8.50 percent. Principal and interest is paid ratably through semi-monthly payroll deductions.

Investments

Participants direct the investments of their contributions and the Company's contributions into various investment options offered by the Plan. The investments available included various mutual funds and a stable value investment (Standard Stable Asset Fund) managed by The Standard Insurance Company (Standard).

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. After one year of service, a participant becomes 20 percent vested. Each service year thereafter will increase the participant's vesting by 20 percent, with 100 percent vesting after five years. Furthermore, a participant who attains normal retirement age of 65 or who retires because of disability shall be 100 percent vested in employer contributions.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum payment equal to the value of the participant's vested interest in his or her account, a specified dollar amount each year, or a partial payout as determined by the participant. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. In service distributions may be made at the request of a participant upon reaching the age of 59½. Hardship distributions are available under the Plan pursuant to IRC requirements.

Forfeited Accounts

Forfeited balances of terminated participant's nonvested accounts are used to reduce employer's contributions or pay plan expenses. At December 31, 2024 and 2023, the forfeited nonvested balance totaled \$2,478 and \$5,400, respectively. In 2024, expenses paid with forfeitures were \$9,547.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and disclosures made in the accompanying notes to the financial statements. While management believes these estimates are adequate, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan. See Note 3 for discussion of fair value measurements.

Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the gains and losses on investments bought and sold as well as held during the year.

Management fees charged to the Plan for investments in registered investment companies (mutual funds) are based on assets invested and are deducted on a daily basis. Management fees are reflected as a reduction of investment return for such investments.

The Standard Stable Asset Fund, provided by Standard, is a fully benefit responsive investment contract that is measured at contract value. Contract value is the amount participants can expect to receive when transacting with the investment and it differs from fair value. The Stable Asset Fund provides participants with liquidity at contract value for daily transactions including transfers between funds. Liquidation of the entire contract may cause a one-time adjustment to the aggregate contract value, resulting in a redemption that is different from the contract value. Daily liquidity is available for participant contributions and withdrawals at contract value regardless of market conditions. These transactions are valued at the fund's NAV, which is established through an amount equal to the total of all contributions made, less withdrawals and administrative expenses, plus interest credited. Participant balances are redeemable daily. Certain events may limit the ability of the plan to transact at contract value. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules.

Upon occurrence of any of these events, a market value adjustment or other withdrawal restrictions may apply. The plan sponsor may choose to pay the market value adjustment directly, if applicable, so that participants' contract values are not affected. Standard may terminate the contract with 30 days advance written notice to the contract owner for reasonable cause.

The Plan Sponsor was not aware of any events that would limit the Plan's ability to transact at contract value as of December 31, 2024, and through the date of issuance.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. As of December 31, 2024, and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Expenses incurred for administering the Plan, if not paid by the Company, are paid by the Plan. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included in net appreciation (depreciation) of fair value of investments.

**NOTE 3 – FAIR VALUE MEASUREMENTS**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented and there were no changes in the methods used to measure fair value at December 31, 2024 and 2023.

Level 1 Fair Value Measurements

The fair value of Registered investment companies (mutual funds) is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded. The fair values of common stocks are based on the closing price on the active market where the individual securities are traded. The Plan has no other assets that are required to be presented in the fair value hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 4 – INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN**

The Plan Administrator has elected the method of compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, the custodian of the Plan, has certified the completeness and accuracy of:

- Investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net appreciation in fair value of investments, and interest income on stable asset fund reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024;
- Investments reflected on the supplemental schedule of assets (Held at End of Year) as of December 31, 2024.

**NOTE 5 – PARTY IN INTEREST TRANSACTIONS**

The Standard Stable Asset Fund held by the Plan, is managed by Standard, the Plan recordkeeper, and therefore, transactions with this entity qualify as exempt party-in-interest transactions.

**NOTE 6 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

**NOTE 7 – TAX STATUS**

The Internal Revenue Service (IRS) has determined and informed the Standard Retirement Services, Inc., who designed plan document utilized by the Plan, by a letter dated June 30, 2020, that the Plan is acceptable for use by employers under the relevant provisions of the Internal Revenue Code (IRC). The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified.

Accounting principles generally accepted in the United States of America require the Plan Administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**NOTE 8 – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
