Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule, Schedule H, Line 4i - Schedule of Assets Held at End of Year, as of and for the year ended December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Years ended December 31, 2024 and 2023

1. Description of Plan

The following description of the Arbitration Forums, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established January 1, 1978 and restated March 1, 2022 as a defined contribution plan available to employees of Arbitration Forums, Inc. (the Company). The Plan is intended to satisfy all the requirements for a qualified retirement plan under the provisions of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company serves as the Plan's sponsor and administrator. The Plan's directed trustee is Fidelity Management Trust Company (Fidelity) and the Plan's recordkeeper is Fidelity Investments. The Company's Board of Directors is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Board of Directors.

Eligibility

The Plan covers all employees of the Company who are at least 18 years of age. Employees may become a participant upon the first day of employment or reaching 18 years of age.

Contributions

Contributions from plan participants and contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation. Each year, participants may contribute a percentage of pretax and post-tax annual compensation, as defined in the Plan, limited by the provisions of the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make "catch up" contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. Employees will be automatically enrolled in the Plan within 30 days after their date of hire (or reaching 18 years of age) with an initial pre-tax deferral of 6%.

The Company contributes a Safe Harbor matching contribution amount equal to the sum of 100% of the amount of the participant's elective deferrals that do not exceed 3% of the participant's compensation, plus 50% of the amount of the participant's elective deferrals that exceed 3% of the participant's compensation, but do not exceed 6% of the participant's compensation. Safe harbor matching contributions in the amount of \$999,320 were made for the year ended December 31, 2024.

1. Description of Plan (continued)

Contributions (continued)

The Company may also make discretionary nonelective and discretionary matching contributions. Only those employees hired between March 1, 2009 and June 30, 2021 and still employed at the end of the year are eligible for discretionary nonelective contributions. Discretionary nonelective contributions in the amount of \$1,203,841 were made for the year ended December 31, 2024. The 2024 discretionary nonelective contribution was allocated to participants at a rate of 10% of the participant's eligible compensation for the year. No discretionary matching contributions have been made for the year ended December 31, 2024. The Company's contribution is invested directly into the investment options selected by the participant. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

At the end of each Plan year, the Company also implements an employer true-up match contribution. This employer true-up match contribution is included in the employer contributions receivable on the statements of net assets available for benefits as of December 31, 2024 and 2023, and in employer contributions on the statement of changes in net assets available for benefits for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contributions, and Plan earnings.

Participant accounts are charged with administrative expenses based on a participant's use of a Plan feature, a participant's receipt of a distribution or loan, and if a participant has terminated employment but their investments remain in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and Safe Harbor matching contributions, plus actual earnings thereon. Vesting in the Company's discretionary contributions and earnings thereon is based on years of continuous service. Discretionary matching contributions have a three year cliff vesting schedule. Discretionary nonelective contributions have a five year graded vesting schedule.

1. Description of Plan (continued)

Payment of Benefits

On termination of service due to retirement, death, disability, or termination of employment, a participant with a vested balance greater than \$7,000 may elect to receive the vested interest in his or her account in a lump-sum payment, installment payments, or have assets rolled to another retirement plan. A single lump-sum cash distribution will be made to terminated participants whose vested balance is less than \$1,000 and alternate instruction is not provided by the participant within a reasonable period of time. If the amount of the participant's vested balance is more than \$1,000 but less than \$7,000, the participant's account balance will be distributed to a qualified individual retirement account in the participant's name.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of a participant's vested account balance attributable to participant deferrals and rollover contributions. One outstanding loan is allowed at a time. The loans are secured by the balance in the participant's account and bear interest at rates between 4.25% and 9.50%. Loan terms may not exceed five years unless the loan is for the purchase of a primary residence. Principal and interest is paid ratably through bi-weekly payroll deductions.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$35,110 and \$30, respectively. These accounts will be used to reduce discretionary employer contributions or pay qualified plan expenses. Forfeitures used to pay qualified plan expenses totaled \$11,594 during the year ended December 31, 2024.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

2. Summary of Significant Accounting Policies (continued)

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies utilizing information provided by investment advisors and the Trustee. See Note 3 for additional discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded when received. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Revenue-Sharing Income

Amounts received through a revenue-sharing agreement between the Plan and Fidelity Investments are recorded as revenue-sharing income in the accompanying statement of changes in net assets available for benefits. Amounts received as revenue-sharing income are first allocated to eligible participants in accordance with the agreement and any remaining amount following this allocation is allocated to the forfeiture account and used to offset expenses of the Plan.

Operating Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of distributions, self-directed brokerage accounts, and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through September 25, 2025, the date the financial statements were available to be issued. During the period from December 31, 2024 to September 25, 2025, the Plan did not have any material recognizable subsequent events.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common collective trusts: Valued at NAV of shares held by the Plan at year end. The NAV is used as the practical expedient to estimate fair value. NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Cash and cash equivalents: Valued at the closing account balance held by the Plan at year end.

Common stocks: Valued at the closing price reported on the active market on which the individual securities are traded.

4. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contribution at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their entire account.

5. Tax Status

The Plan has adopted a non-standardized pre-approved profit sharing plan sponsored by Fidelity Management and Research Company. The pre-approved profit sharing plan provider has received an opinion letter from the Internal Revenue Service as to the pre-approved profit sharing plan's qualified status. The pre-approved profit sharing plan opinion letter has been relied upon by this Plan. The plan administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

6. Accounting for Uncertainty in Income

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2020.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Information Certified by Fidelity Management Trust Company

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the Trustee of the Plan), a qualified institution.

9. Related Party Transactions and Party In Interest Transactions

Certain Plan investments are managed by Fidelity. Fidelity is the Trustee and Recordkeeper of the Plan and, therefore, transactions involving these investments are considered party in interest transactions. Total fees paid by the Plan for administrative costs amounted to \$16,388 for the year ended December 31, 2024.

The Plan's service agreement with Fidelity Investments, the Recordkeeper, includes a revenue-sharing arrangement. Therefore, these transactions are considered to be party in interest transactions. The amount received by the Plan under the revenue-sharing agreement was \$66,239 during the year ended December 31, 2024, and is included in revenue-sharing income in the statement of changes in net assets available for benefits.

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Arbitration Forums, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 8 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule, Schedule H, Line 4i - Schedule of Assets Held at End of Year, as of and for the year ended December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Years ended December 31, 2024 and 2023

1. Description of Plan

The following description of the Arbitration Forums, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established January 1, 1978 and restated March 1, 2022 as a defined contribution plan available to employees of Arbitration Forums, Inc. (the Company). The Plan is intended to satisfy all the requirements for a qualified retirement plan under the provisions of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company serves as the Plan's sponsor and administrator. The Plan's directed trustee is Fidelity Management Trust Company (Fidelity) and the Plan's recordkeeper is Fidelity Investments. The Company's Board of Directors is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Board of Directors.

Eligibility

The Plan covers all employees of the Company who are at least 18 years of age. Employees may become a participant upon the first day of employment or reaching 18 years of age.

Contributions

Contributions from plan participants and contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation. Each year, participants may contribute a percentage of pretax and post-tax annual compensation, as defined in the Plan, limited by the provisions of the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make "catch up" contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. Employees will be automatically enrolled in the Plan within 30 days after their date of hire (or reaching 18 years of age) with an initial pre-tax deferral of 6%.

The Company contributes a Safe Harbor matching contribution amount equal to the sum of 100% of the amount of the participant's elective deferrals that do not exceed 3% of the participant's compensation, plus 50% of the amount of the participant's elective deferrals that exceed 3% of the participant's compensation, but do not exceed 6% of the participant's compensation. Safe harbor matching contributions in the amount of \$999,320 were made for the year ended December 31, 2024.

1. Description of Plan (continued)

Contributions (continued)

The Company may also make discretionary nonelective and discretionary matching contributions. Only those employees hired between March 1, 2009 and June 30, 2021 and still employed at the end of the year are eligible for discretionary nonelective contributions. Discretionary nonelective contributions in the amount of \$1,203,841 were made for the year ended December 31, 2024. The 2024 discretionary nonelective contribution was allocated to participants at a rate of 10% of the participant's eligible compensation for the year. No discretionary matching contributions have been made for the year ended December 31, 2024. The Company's contribution is invested directly into the investment options selected by the participant. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

At the end of each Plan year, the Company also implements an employer true-up match contribution. This employer true-up match contribution is included in the employer contributions receivable on the statements of net assets available for benefits as of December 31, 2024 and 2023, and in employer contributions on the statement of changes in net assets available for benefits for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contributions, and Plan earnings.

Participant accounts are charged with administrative expenses based on a participant's use of a Plan feature, a participant's receipt of a distribution or loan, and if a participant has terminated employment but their investments remain in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and Safe Harbor matching contributions, plus actual earnings thereon. Vesting in the Company's discretionary contributions and earnings thereon is based on years of continuous service. Discretionary matching contributions have a three year cliff vesting schedule. Discretionary nonelective contributions have a five year graded vesting schedule.

1. Description of Plan (continued)

Payment of Benefits

On termination of service due to retirement, death, disability, or termination of employment, a participant with a vested balance greater than \$7,000 may elect to receive the vested interest in his or her account in a lump-sum payment, installment payments, or have assets rolled to another retirement plan. A single lump-sum cash distribution will be made to terminated participants whose vested balance is less than \$1,000 and alternate instruction is not provided by the participant within a reasonable period of time. If the amount of the participant's vested balance is more than \$1,000 but less than \$7,000, the participant's account balance will be distributed to a qualified individual retirement account in the participant's name.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of a participant's vested account balance attributable to participant deferrals and rollover contributions. One outstanding loan is allowed at a time. The loans are secured by the balance in the participant's account and bear interest at rates between 4.25% and 9.50%. Loan terms may not exceed five years unless the loan is for the purchase of a primary residence. Principal and interest is paid ratably through bi-weekly payroll deductions.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$35,110 and \$30, respectively. These accounts will be used to reduce discretionary employer contributions or pay qualified plan expenses. Forfeitures used to pay qualified plan expenses totaled \$11,594 during the year ended December 31, 2024.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

2. Summary of Significant Accounting Policies (continued)

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies utilizing information provided by investment advisors and the Trustee. See Note 3 for additional discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded when received. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Revenue-Sharing Income

Amounts received through a revenue-sharing agreement between the Plan and Fidelity Investments are recorded as revenue-sharing income in the accompanying statement of changes in net assets available for benefits. Amounts received as revenue-sharing income are first allocated to eligible participants in accordance with the agreement and any remaining amount following this allocation is allocated to the forfeiture account and used to offset expenses of the Plan.

Operating Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of distributions, self-directed brokerage accounts, and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through September 25, 2025, the date the financial statements were available to be issued. During the period from December 31, 2024 to September 25, 2025, the Plan did not have any material recognizable subsequent events.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Common collective trusts: Valued at NAV of shares held by the Plan at year end. The NAV is used as the practical expedient to estimate fair value. NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Cash and cash equivalents: Valued at the closing account balance held by the Plan at year end.

Common stocks: Valued at the closing price reported on the active market on which the individual securities are traded.

4. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contribution at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their entire account.

5. Tax Status

The Plan has adopted a non-standardized pre-approved profit sharing plan sponsored by Fidelity Management and Research Company. The pre-approved profit sharing plan provider has received an opinion letter from the Internal Revenue Service as to the pre-approved profit sharing plan's qualified status. The pre-approved profit sharing plan opinion letter has been relied upon by this Plan. The plan administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

6. Accounting for Uncertainty in Income

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2020.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Information Certified by Fidelity Management Trust Company

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the Trustee of the Plan), a qualified institution.

9. Related Party Transactions and Party In Interest Transactions

Certain Plan investments are managed by Fidelity. Fidelity is the Trustee and Recordkeeper of the Plan and, therefore, transactions involving these investments are considered party in interest transactions. Total fees paid by the Plan for administrative costs amounted to \$16,388 for the year ended December 31, 2024.

The Plan's service agreement with Fidelity Investments, the Recordkeeper, includes a revenue-sharing arrangement. Therefore, these transactions are considered to be party in interest transactions. The amount received by the Plan under the revenue-sharing agreement was \$66,239 during the year ended December 31, 2024, and is included in revenue-sharing income in the statement of changes in net assets available for benefits.
