As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Their report dated January 16, 2025 indicated that in their opinion (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Their report also indicated that the form and content of the 2023 supplemental schedule, other than the information in the 2023 supplemental schedule that agrees to or is derived from the certified investment information, were presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, and the information in the 2023 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **1. Description of Plan**

The following description of the First Bank Upper Michigan Deferred Compensation and Profit Sharing Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

### **General**

The Plan is a defined contribution plan covering all eligible employees of First Bank Upper Michigan (the Employer or Plan Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

### **Eligibility**

There are no minimum age or minimum service requirements in order for participants to make salary deferrals and to receive employer matching contributions. There is a one year of service requirement, employed on the last day of the year, and worked 1,000 hours, for participants to be eligible to receive the discretionary employer profit sharing contribution. Exceptions to these conditions include a participant's death during the year, terminated employment as a result of a disability, or terminated employment after attaining normal retirement age of 65.

The Plan includes an eligible automatic contribution arrangement whereby all eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, to contribute 3% of eligible compensation during the first year, increasing by 1% annually up to the maximum automatic rate of 10%.

### **Contributions**

Each year, participants may elect to contribute up to 100% of their compensation, not to exceed the maximum contribution allowable by the Internal Revenue Code (IRC) adjusted annually for the cost-of-living changes. There is no minimum elective deferral limit for the Plan. Rollover contributions are allowed by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan also allows Roth deferrals.

Participants direct the investment of their contributions into various investment options offered by the Plan, in accordance with the Plan's investment policy. Participants may change their investment options and transfer between funds as desired. The Employer makes matching contributions for eligible participants. The matching contributions are equal to 50% of the first 6% of eligible compensation that a participant contributes to the Plan. The Employer may also make discretionary profit sharing contributions to the Plan. For both 2024 and 2023, the Employer elected to make profit sharing contributions to the Plan equal to 3% of eligible compensation.

**1. Description of Plan (continued)**

**Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Employer's contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant account balances, the number of participants in the Plan, or participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately 100% vested in their deferral contributions plus actual earnings thereon. Vesting in Employer matching and discretionary profit sharing contributions plus actual earnings thereon is based on a 6-year graded vesting schedule where a participant works at least 1,000 hours each year. Participants also become 100% vested upon death or disability.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. Loan terms may be up to five years, or for up to fifteen years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and shall be charged an annual prevailing rate of interest plus 1% to be fixed by the Employer at the time the loan is written. Principal and interest will be repaid at the same intervals as the participant's regular payroll by means of a payroll deduction. A participant may have a maximum of two loans outstanding at any time.

**Payment of Benefits**

A participant may take a distribution of their entire vested account balance in a single lump sum, installment distributions, or a partial lump sum upon termination of employment, subject to specific Plan provisions. Participants are allowed in-service distributions prior to termination of their employment under certain conditions specified in the Plan, such as attainment of age 59 ½ and for hardship withdrawals.

**Forfeited Accounts**

Forfeitures serve to reduce future Employer contributions. For the year ended December 31, 2024, forfeited non-vested accounts totaled \$24,788 (\$5,586 for 2023). Employer contributions are recorded net of the forfeited non-vested account amounts.

**Administrative Expenses**

Certain administrative costs of the Plan are paid by the Plan Sponsor and are not included in these financial statements. Additionally, certain administrative expenses were paid by the Plan and are reflected in the accompanying financial statements.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

**Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. See Note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred.

**Payment of Benefits**

Benefit payments are recorded when paid.

**Reclassifications**

Certain amounts in 2023 have been reclassified to conform with the 2024 presentation.

**2. Summary of Significant Accounting Policies (continued)**

**Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Accordingly, actual results may differ from estimated amounts.

**Fair Value Measurements**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan utilizes valuation techniques that maximize the use of observable inputs and minimize the use of unobservable inputs. Based on the observability of the inputs used in the valuation techniques, the Plan is required to provide information according to the fair value hierarchy. The fair value hierarchy ranks the quality and reliability of the information used to determine fair values.

Financial assets and liabilities carried at fair value will be classified and disclosed in one of the following three categories:

Level 1 – Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.

Level 2 – Significant other observable inputs other than Level 1 prices, such as quoted prices for similar assets and liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3 – Significant unobservable inputs that reflect an entity's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In determining the appropriate levels, the Plan performs a detailed analysis of the assets and liabilities. At each reporting period, all assets and liabilities for which the fair value measurement is based on significant unobservable inputs are classified as Level 3.

For the years ended December 31, 2024 and 2023, the application of valuation techniques applied to similar assets and liabilities has been consistent.

**Subsequent Events**

Subsequent events have been evaluated through October 1, 2025, which is the date the financial statements were available to be issued.

**3. Risk and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and long-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**4. Income Tax Status**

The First Bank Upper Michigan Deferred Compensation and Profit Sharing Plan, as amended, is designed and intended to operate in compliance with all applicable requirements of the IRC. The Plan has adopted a Non-Standardized Pre-Approved Defined Contribution Plan with an Internal Revenue Service (IRS) advisory letter dated June 30, 2020. The most recent Plan restatement was adopted with an effective date of July 1, 2021. The most recent Plan amendment was effective January 1, 2022. Although amended, the Plan's administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Accordingly, no provision for income tax is included in the accompanying financial statements.

Generally, tax years 2021 through current year remain open to examination. The Plan does not believe that the results from any examination of these open years would have a material adverse effect on the Plan.

**5. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to terminate the Plan subject to provisions of ERISA and the Plan document. In the event of Plan termination, the participants become fully vested in their accounts.

**6. Financial Information Certified by the Trustee – Unaudited**

The Plan's financial information and data was certified by the trustee, Security National Bank, in accordance with Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the cash, investment balances, notes receivable from participants, interest, dividends, and net appreciation in fair value of investments included in the financial statements and supplemental schedule were obtained from data that has been prepared and certified as complete and accurate by the trustee. This certified information has not been audited by independent auditors.

**7. Fair Value Measurements**

The following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual Funds:* The fair value of mutual funds is based on quoted net asset values (NAVs) of the shares, as reported by the fund. The mutual funds held by the Plan have quoted prices and are considered actively traded.

*Money Market Accounts:* Considered to be cash equivalents with fair value identical to stated value.

**8. Party-In-Interest Transactions**

Security National Bank is the custodian, third-party recordkeeper and administrator of the Plan, and therefore, fees paid for these services are considered party-in-interest transactions. Administrative expenses paid directly to Security National Bank by the Plan totaled \$9,669 for the year ended December 31, 2024 and \$2,250 for the year ended December 31, 2023. Notes receivable from participants are also considered party-in-interest transactions.

Certain Plan investments are deposits in Schwab Bank Savings, Schwab Government Money Fund and its affiliates, which are offered by Charles Schwab & Company, Inc. Security National Bank utilizes the Charles Schwab & Company trading platform; therefore, these deposits are considered party-in-interest transactions.
