Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of 403(b) Thrift Plan for Employees of Wayne Action Group for Economic Solvency, Inc. (WAGES), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of 403(b) Thrift Plan for Employees of Wayne Action Group for Economic Solvency, Inc.'s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- the amounts and disclosures in the financial statements referred above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the 403(b) Thrift Plan for Employees of WAGES and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. A. DESCRIPTION OF PLAN

The following description of the 403(b) Thrift Plan for Employees of Wayne Action Group for Economic Solvency (WAGES), Inc., ("Plan"), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. *General.* The Plan, effective May 1, 1976, is an elective deferral plan for all employees of WAGES. The employees may enter the first day of the month following their date of employment. The Plan assets are held in trust by Mutual of America Life Insurance Company as custodian of assets. Participation in the Plan is voluntary.
2. *Contributions.* Participants may contribute between 1% and 100% of pre-tax or after-tax annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans as defined under Section 402 of the Internal Revenue Code. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 1% of eligible compensation and their contributions invested in the Plan's default investment alternative until changed by the participant.
3. *Participant Accounts.* Each participant's account is credited with participants contributions and allocations of Plan earnings and administrative expenses. Allocations are based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
4. *Vesting.* Participants are 100% vested in their contributions immediately, plus actual earnings thereon.
5. *Payment of Benefits.* Upon termination of employment, retirement, death, or disability, a participant or beneficiary may elect to receive a lump sum payment equal to the value of the participant's vested interest in his or her account. If a terminated participant is 55 years of age or older, payment of their account balance can also be requested in either installment payments over a period that does not exceed life expectancy, or payment in the form of an annuity.
6. *Plan loans.* Through 2020, participants could borrow against their investment accounts. In 2022, notes receivable from participants were converted to plan loans. Currently, loans are not permitted under this Plan. All plan loans were issued directly by funds owned by Mutual of America Life Insurance Company (Mutual of America) and are secured by the value held in the participant's investment account within the Plan (i.e., loan proceeds are not removed from a participant's account balance). At any time, the participant's account value in the Plan must be equal to 120% of the Plan loan in order to ensure adequate collateralization. Plan loans bear interest at a variable rate as determined by Mutual of America equal to the interest crediting rate of the Interest Accumulation Account plus 3%. Interest rates are adjusted by Mutual of America no less than once a year. Plan loans must be repaid within 5 years. If the loan was used for the purchase of a principal residence, the loan term can be extended to a period of no more than 10 years. Principal and interest is paid through semi-monthly installments deducted through payroll. As of December 31, 2024 and 2023, there were Plan loans due to Mutual of America secured by Plan assets of \$7,547 and \$8,628, respectively.

B. SUMMARY OF ACCOUNTING POLICIES

1. *Basis of Accounting.* The financial statements of the Plan are prepared on the accrual basis of accounting.
2. *Estimates.* The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

3. *Investment Valuation and Income Recognition.* Investments are reported at fair value (except for the fully benefit-responsive contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note H for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

4. *Investments.* The Plan's investments are managed by Mutual of America Life Insurance Company. Mutual of America negotiates and selects fixed income accounts, group annuity contracts and mutual funds as investment vehicles for plan assets. These investments are made at the direction of the Plan participants.
5. *Payment of Benefits.* Benefits are recorded when paid.
6. *Administrative Expenses.* The Organization may pay administrative and trust expenses in whole or in part. All expenses not paid by the Organization shall be paid by the Plan. The Organization also pays the salaries of the benefits administrators and other personnel who perform services for the Plan as part of their duties, as well as the audit fees. These expenses are not recorded as Plan expenses.

C. CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest on annuity contracts, and other income for the year ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from the information certified as complete and accurate by Mutual of America Life Insurance Company.

D. TAX STATUS

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the plan is qualified, and the related trust is tax-exempt.

E. GROUP ANNUITY CONTRACT WITH MUTUAL OF AMERICA LIFE INSURANCE COMPANY

In 2022, the Plan entered into a guaranteed annuity contract with Mutual of America Life Insurance Company (Mutual) totaling \$127,525 for 2024 and \$115,113 for 2023. Mutual maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The guaranteed annuity contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Mutual's general account is reported at contract value. The concept of benefit responsiveness does not apply to Mutual's general account. This concept generally applies to guaranteed investment contracts (GICs), whereby the employer enters into the contract with a set amount of money, and the interest rate is guaranteed for a set period of time. The employer agrees not to withdraw the funds early; however, if funds are needed to pay retirement claims, they can be withdrawn from the GIC without penalty (i.e., they are "benefit responsive"). The funds are always available to pay benefits, subject to the plan's vesting schedule. Since the employer does not control participant assets, the need for the plan to be benefit responsive is not relevant.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

F. RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate and market risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

G. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in certain funds managed by Mutual of America. Mutual of America is the custodian of the Plan's assets and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to Mutual of America Life Insurance Company for investment management services amount to \$949 for 2024 and \$401 for 2023.

H. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include: (1) Quoted prices for similar assets or liabilities in active markets; (2) Quoted prices for identical or similar assets or liabilities in inactive markets; (3) Inputs other than quoted prices that are observable for the assets or liability; (4) Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Pooled Separate Accounts. Pooled separate accounts are valued at the net asset value (“NAV”) of units of a fund. The NAV, as provided by Mutual of America, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying mutual funds registered with the Securities and Exchange Commission held by the fund, as determined by quoted prices of identical assets in an active market, less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the pooled separate account, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

In accordance with ASC 820-10, certain investments measured at fair value using the net asset value per share (or its equivalent) practical expedient are not classified in the fair value hierarchy.

The following table sets forth additional disclosures of the Plan’s separate account investments, classified by major category, whose fair value is based on net asset value (NAV) per share as of December 31, 2024 and 2023, respectively.

Participants may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). An aggregate of \$18,264 and \$0 were rolled into the Plan during the years ended December 31, 2024 and 2023, respectively, and are included in rollovers on the statement of changes in net assets available for benefits.

J. COSTS ABSORBED BY PLAN SPONSOR

Administrative costs absorbed by the Plan sponsor totaled \$14,000 and \$10,500 for the years ended December 31, 2024 and 2023, respectively.

K. PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

L. SUBSEQUENT EVENTS

Subsequent events were evaluated through August 18, 2025, the date the financial statements were available to be issued.
