## INDEPENDENT AUDITOR'S REPORT

To the Board of Directors and Employee Benefits Committee  
Safety National Casualty Corporation Savings and  
Profit-Sharing Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the accompanying financial statements of Safety National Casualty Corporation Savings and Profit-Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Safety National Casualty Corporation Savings and Profit-Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 2 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Safety National Casualty Corporation Savings and Profit-Sharing Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audits does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Safety National Casualty Corporation Savings and Profit-Sharing Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

1. DESCRIPTION OF THE PLAN

The following description of the Safety National Casualty Corporation Savings and Profit-Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan with the safe harbor election and is available to full-time employees of Safety National Casualty Corporation (the "Company") who are eligible immediately upon date of hire with no age restrictions. Eligible employees that do not make a deferral election will be automatically enrolled 30 days after date of hire or reclassification from non-eligible to eligible employee, at a contribution of 4% of eligible earnings. The Plan has an automatic escalation feature that increases a participant's contribution by 1% per year up to a maximum of 6% of eligible earnings. The Plan is a salary reduction plan subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

An expansion of Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE 2.0") was signed into law on December 29, 2022, as part of the Consolidated Appropriations Act of 2023. Effective May 15, 2024, the Plan administratively adopted Section 304 and Section 602 of SECURE 2.0; refer to the Payment of benefits section of Note 1 for further information. The Plan has not been formally amended to adopt these provisions as of the date the financial statements were available to be issued.

Plan merger

Effective October 31, 2024, the Midlands Management Corporation 401(k) Plan was merged into the Plan. As a result of the merger, all assets and liabilities of the Midlands Management Corporation 401(k) Plan were transferred to the Plan. The merger was accounted for as a transfer of assets and liabilities at fair value of \$4,463,711, and the financial statements reflect the combined balances as of December 31, 2024.

Plan administration

The Company is the administrator of the Plan and, as such, carries out the duties imposed by ERISA. The Company has delegated certain responsibilities for the operation and administration of the Plan. The Standard Insurance Company (Formerly known as Minnesota Life Insurance Company ("the Standard" or "Trustee"), the trustee of the Plan are responsible for the custody and management of the Plan's assets as well as for maintaining participant accounts and transactions related to participant initiated activity.

Contributions

Contributions are subject to Internal Revenue Code ("IRC") limitations. Contributions to the Plan are funded on a per pay period basis.

Contributions (continued)

For the years ended December 31, 2024 and 2023, the total amount a participant may contribute to the Plan was limited to pre-tax or after-tax Roth deferrals of \$23,000 and \$22,500, respectively. If a participant has attained age 50 before the end of the Plan year, he or she is eligible to make catch-up contributions. The maximum catch-up contribution was \$7,500 in 2024 and 2023. Contributions are subject to other certain limitations.

The Company contributes 100% of the first 4% of base compensation that a participant contributes to the Plan. The matching Company contribution is invested based upon the investment options selected by the participant.

The Plan has a non-elective employer profit-sharing contribution in which the amount is determined by the employer. The Company's non-elective profit-sharing contribution is for all participants who have completed at least 500 hours of service and are employed as of the last day of the Plan year. The profit-sharing contribution, net of forfeitures as described below, for the years ended December 31, 2024 and 2023, totaled \$4,456,739 and \$3,812,227, respectively. The contributions were approved by the Board of Directors and paid to the Plan in March 2025 and 2024, respectively.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants may change their investment options at any time.

Forfeitures

Forfeitures of non-vested employer profit-sharing contributions occur upon termination of employment by a participant who is not fully vested in the Plan. Forfeitures, if any, shall be applied as a credit against the Plan profit-sharing contributions made by the employer. For the year ended December 31, 2024, the employer's non-elective profit-sharing contribution was not reduced by the balance in the forfeited non-vested accounts. For the year ended December 31, 2023, the employer's non-elective profit-sharing contribution was reduced by \$123,057, the balance in the forfeited non-vested accounts. The balance in the forfeiture account at December 31, 2024 and 2023, was \$170,473 and \$123,057, respectively. The profit-sharing contributions for any given year are funded in the subsequent year and reflected as a receivable in the current year to which they were generated.

Vesting

Participants are 100% vested in their salary deferral, rollover contributions and matching contributions upon becoming eligible for the Plan.

Participants will become fully vested in their non-elective profit-sharing contributions upon reaching the normal retirement age of 65, becoming disabled while an employee, or death.

Participant hardship withdrawals

Participants may withdraw from the Plan any portion of their vested account balance in the event of undue financial hardship. The maximum hardship withdrawal is 100% of the participant's total vested balance.

Payment of benefits

Any participant who is terminated or becomes disabled is entitled to receive a lump-sum distribution of their vested account balance, if the participant's account balance is less than \$5,000. The vested account balance will be automatically rolled over to an IRA via a provider selected by the Plan. The IRA provider will invest the rollover funds in a type of investment designed to preserve principal and provide a reasonable rate of return and liquidity. If the participant's balance exceeds \$5,000, the participant may elect to receive a lump-sum distribution of their vested account balance or defer receipt until the participant reaches age 70½. In the event of death, the participant's account balance is paid to the designated beneficiary.

Expenses

Certain administrative expenses to maintain the Plan are paid by the Company and are not included in the financial statements. Distribution and other transaction fees are charged to the participant. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan are prepared using the accrual basis of accounting, in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of estimates in financial statement preparation

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value, except for the fully-benefit responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer liability in an orderly transaction between market participants at the measurement date. The Plan's Employee Benefits Committee determines the Plan's valuation policies utilizing information provided by investment advisers, custodians and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions and contributions receivable

Contributions from participants are recorded based on the date the contributions or repayments have been separated from a participant's pay by the Company, which is the pay date. Employer contributions are recorded in the year earned to coincide with the year in which the Employer records the contributions in its general ledger. The Plan records receivables for contributions attributable to the Plan year but received by the Plan subsequent to year end. Rollover contributions from participants are recorded based on the date the rollover contribution are received by the Trustee.

Payment of benefits

Benefit payments are recorded when paid.

Expenses

Administrative expenses are recorded when incurred.

("The Standard") and Minnesota Life Insurance Company ("Minnesota Life") the trustees of the Plan, have certified the following data included in the accompanying financial statements and supplemental schedule are complete and accurate with respect to investments:

- Investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net appreciation in fair value of investments and interest income as shown in the accompanying statement of changes in net assets available for benefits for the years ended December 31, 2024 and 2023; and,
- Investments reflected on the schedule of assets (held at end of year) as of December 31, 2024 ("supplemental schedule").

Accordingly, as requested by the plan administrator, the Plan's independent auditor performed no audit procedures on the certified information other than to agree the certified information to the related information included in the Plan's financial statements and supplemental schedule.

Subsequent events

The Plan has evaluated subsequent events through October 1, 2025, the date the financial statements were available to be issued.

Pooled Separate Accounts are valued at the NAV of units of insurance company pooled separate accounts. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the funds will sell the investments for an amount different than the reported NAV. There were no transfers between fair value designations during 2024 or 2023.

4. INVESTMENTS CONTRACT WITH INSURANCE ENTITY

Minnesota Life maintains certain contributions within a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Minnesota Life is contractually obligated to repay the principal.

Because the contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the contract. Contract value, as reported to the Plan by Minnesota Life represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023, was \$12,412,137 and \$16,965,935, respectively. The crediting interest rate is based on a formula agreed upon with the issuer and there is no underlying guarantee of a minimum crediting rate. Such interest rates are reviewed on an annual basis for resetting.

Certain events limit the ability of the Plan to contract value with the issuer. Such events include the following: (1) amendments to the plan document (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition and competing investment options or deletion of equity wash provisions, or (3) termination of the contract by the Company. The Plan Administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The contract does not permit the insurance company to terminate the agreement.

5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

6. INCOME TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

8. RELATED PARTY TRANSACTIONS

ERISA defines party-in-interest similar to a related party under U.S. GAAP, except that ERISA's definition is broader and includes all entities and individuals that provide services to the Plan; however, these entities may not necessarily be related parties. Plan management did not identify any related parties to the Plan that were not also considered to be parties-in interest. The Plan did not enter into any material related party transactions during the Plan year related to compensation, arrangements, expense allowances or similar items.

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, and an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain Plan investments are shares of pooled separate accounts and an interest in an insurance company general account managed by The Standard. The Standard is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Additionally, certain Plan expenses may be paid by the Company.
