## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of **Metal One America, Inc. and Nifast Corporation 401(k) Plan** (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for plan benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

## Metal One America, Inc. and Nifast Corporation 401(k) Plan Notes to the Financial Statements

### 1. Description of Plan

The Metal One America, Inc. and Nifast Corporation (Company) 401(k) Plan (Plan) was established January 1, 1998. The following description of the Plan is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

**General** – The Plan is a defined contribution 401(k) plan, covering all employees of the Company (MAI), Metal One Holdings America, Inc. (MOHA) and Nifast Corporation (NIF) collectively referred to as “the Companies”, who have completed one-half year of service and reached the age of 19. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions** – Contributions to the Plan are made by the Companies and the participants. Participants may contribute up to 75% of their compensation, subject to limitations imposed by the Internal Revenue Service. Effective May 1, 2021, the Plan implemented an automatic enrollment with an initial deferral provision equal to 3% of participant compensation.

Each participant is able to allocate their contribution among the Plan's various investment accounts. Investment funds are maintained at Fidelity Management Trust Company (Fidelity) at December 31, 2024, and are maintained in thirty-three separate investment accounts. Each fund represents a different level of risk and earning potential.

The Companies may make matching contributions to the Plan equal to a discretionary percentage to be determined by the Companies. The amount of the contribution is limited to the first six (6) percent of the participant's contribution. For the year ended December 31, 2024, the matching contribution was equal to fifty (50) percent of the participant's deferral contributions, up to the first six (6) percent of the participant's compensation for the Plan year for MAI, MOHA and NIF employees. Additionally, the Companies may make a discretionary non-elective contribution to the Plan. The Companies did not make a discretionary non-elective contribution in 2024.

**Participants' Accounts** – Each participant's account is credited with the participant's contribution and allocations of the Company's contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. **Description of Plan** (cont'd)

**Vesting** – Participants are vested immediately in their contributions, plus actual earnings thereon. Participants become vested in their employer matching contribution and discretionary non-elective contribution account balances based on years of continuous service. The Plan provides for a five-year vesting period for employer matching contributions and discretionary non-elective contributions.

**Notes Receivable from Participants** – Participants are allowed to borrow from their fund accounts a minimum of \$500, up to a maximum equal to the lesser of \$50,000 or fifty (50) percent of their vested account balance. Loan terms range from one to five years. However, loans used to acquire the primary residence shall provide for periodic repayment over a reasonable period of time that may exceed five (5) years. The loans are secured by the balance in the participant's account, and bear interest at 4.25% - 9.50%, which are commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest is paid ratably through monthly payroll deductions.

**Payment of Benefits** – On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount or periodic installments equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

**Forfeitures** – Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures of the employer's contribution shall be used to reduce the employer's matching contribution, used for discretionary contributions or to pay plan expenses. There were forfeiture balances available of \$14,346 at December 31, 2024 (\$2,327 at December 31, 2023). No forfeitures were utilized during 2024 (\$8,211 in 2023).

2. **Summary of Significant Accounting Policies**

**Basis of Presentation** – The accompanying financial statements have been prepared on an accrual basis of accounting.

**Use of Estimates** – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**2. Summary of Significant Accounting Policies (cont'd)**

**Investment Valuation and Income Recognition** – Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisor, custodian and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable From Participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**Payment of Benefits** – Benefits are recorded when paid.

**Expenses** – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

**Subsequent Events** – Subsequent events have been evaluated through October 1, 2025, which is the date the financial statements were available to be issued.

**3. Information Prepared and Certified by Trustee**

The Company, acting in its capacity as the Plan administrator, has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

The following is a summary of the unaudited information regarding the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the Plan's financial statements and supplemental schedule, that was prepared by or derived from information prepared by Fidelity Management Trust Company, the trustee of the Plan, and furnished to the Company. The Company has obtained certifications from the trustee as of December 31, 2024 and December 31, 2023, and for the year ended December 31, 2024, that such information is complete and accurate.

**4. Fair Value Measurements**

Financial Accounting Standards Board (FASB), Accounting Standards Codification (ASC) 820, “Fair Value Measurements and Disclosures,” provides the framework for measuring fair value. That framework provides a three-level valuation hierarchy that prioritizes the inputs to valuation techniques used to measure fair value as follows:

**Level 1** – Valuations are based on unadjusted quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access at the measurement date.

**Level 2** – Valuations are based on quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in markets that are not active; and model-derived valuations whose significant inputs are observable.

**Level 3** – Valuations are based on unobservable inputs for the asset or liability that reflect the reporting entity’s own data and assumptions that market participants would use in pricing the asset or liability. These unobservable inputs are significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize that use of unobservable inputs.

**4. Fair Value Measurements (cont'd)**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. These assets are categorized in Level 1 of the fair value hierarchy.

Collective investment trust's participation units fair value is based upon the net asset values of such fund, as reported in the audited financial statements of the fund. Subject to certain restrictions, withdrawals from the stable value fund are generally permitted daily at contract value.

**5. Plan Termination**

Although the Company has expressed no intent to do so, the Company has the right under the Plan to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

**6. Related Party Transactions and Party-in-Interest Transactions**

Certain Plan investments are under a contract managed by Fidelity. Fidelity is the custodian of the Plan's contract; therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. As described in Note 2, the Plan made direct payments to the third-party administrator of \$46,215 which was not covered by revenue sharing. The Company pays directly any other fees related to the Plan's operations.

**7. Tax Status**

The Plan has adopted the Fidelity Management and Research Company Volume Submitter Profit Sharing Plan. The Internal Revenue Service has determined and informed Fidelity Management and Research Company, by a letter dated June 30, 2020, that the Volume Submitter Profit Sharing Plan is designed in accordance with applicable sections of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by federal and state taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset), or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
