Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Cordis US Corp. Note 1 – Description of the Plan

The following description of the Cordis US Corp. Retirement Savings Plan (the “Plan”) provides only general information. Participants and all others should refer to the Plan document for a more complete description of the Plan’s provisions.

General. The Plan is a defined contribution plan, which went into effect August 2, 2021 (Plan Inception), that is generally available to all employees of Cordis US Corp. (the “Company”, “Employer”, “Plan Sponsor”, or “Plan administrator”). The Plan excludes collectively bargained employees, nonresident aliens, leased employees, reclassified employees, and on-call employees or a consultant. In order to be eligible to participate in the Plan an employee must be age 18 years or older and complete 30 days of entry service. Eligible employees may enter the Plan the first of the month coincident with or after meeting the Plan’s eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). Benefits under the Plan are not guaranteed by the Pension Benefit Guaranty Corporation.

Plan Amendment. Effective January 15, 2024 the Plan document was amended. In connection with this amendment the following occurred:

- The Plan’s eligible employee provisions were changed to include part-time, temporary, or seasonal employees;
- The Plan’s QACA safe harbor Employer matching contributions provisions were modified to allow the Employer to make an additional discretionary contribution; and
- Bargaining employees became eligible for QACA safe harbor Employer matching contributions.

Transfers. Effective January 1, 2024 the MedAlliance LLC 401(k) Profit Sharing Plan was merged into the Cordis US Corp. Retirement Savings Plan. In connection with this merger assets of approximately \$1.13 million were transferred into the Plan effective January 1, 2024.

Contributions. The following types of contributions are allowable under the Plan:

- Elective Deferral Contributions – Participants may contribute a percentage of their pre-tax compensation, as defined in the Plan document, subject to limitations. Participants may also contribute a percentage of their after tax compensation and designate it as a Roth deferral contribution. The Plan has a qualified automatic contribution arrangement (“QACA”). Unless an eligible employee makes an affirmative election otherwise, such employee will be automatically enrolled into the Plan at a 3% pre-tax salary deferral contribution percentage rate. Such rate will increase annually by 1% until a 6% elective pre-tax deferral contribution percentage is reached. Participants who are auto-enrolled under the QACA can elect a permissible withdrawal within 90 days of their first automatic deferral. A participant’s total contributions cannot exceed \$23,000 (\$30,500 if age 50 or older) in calendar year 2024.
- QACA Safe Harbor Employer Matching Contributions – Each payroll period, the Company will make a QACA safe harbor Employer matching contribution equal to 100% of the participant’s contributions up to 5% of compensation. During 2024, the Employer also made an discretionary contribution based on the Plan year.
- Discretionary Employer Contributions – The Employer may make a discretionary Employer contribution to eligible participants that are an active participant on the last day of the Plan year. This contribution is allocated to each eligible participant’s account in the ratio that each participant’s compensation bears to the compensation of all eligible participants. During 2024, the Employer did not make a discretionary Employer contribution.

Note 1 – Description of the Plan (continued)

- Rollover Contributions – Amounts distributed to participants from other qualified employee benefit plans may be rolled into the Plan.

All contributions are allocated to the Plan's investment funds at the direction of the participants. The total annual additions to a participant's account may not exceed the lesser of \$69,000 in 2024 or 100% of the participant's compensation.

Investment Options. Participants may direct their investments into various common collective trusts and registered investment companies.

Participant Accounts. Each participant's account is increased and/or decreased, as applicable, with the participant's contributions (elective deferrals and rollovers, if any) and an allocation of (a) the Employer's contributions (QACA safe harbor and discretionary, if any), (b) fund earnings or losses, and (c) administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting. Participants are immediately vested in their elective deferral contributions, rollover contributions, and related earnings thereon. QACA safe harbor Employer matching contributions are subject to a two year cliff vesting schedule, whereas, participants become 100% vested after two years of service. Discretionary Employer contributions are subject to a three year cliff vesting schedule, whereas, participants become 100% vested after three years of service. Additionally, employed participants become 100% vested in their accounts upon attainment of normal retirement age, disability, death, and termination or partial termination of the Plan.

Forfeitures. When certain terminations of participation in the Plan occur, the non-vested portion represents a forfeiture. Forfeitures are used to pay Plan expenses, used to reduce Employer contributions, or are reallocated to eligible participants as an additional Employer contribution. During 2024, forfeitures of \$250,057 were used to reduce Employer contributions. The balance in the forfeitures account was \$302,535 and \$249,702, as of December 31, 2024 and 2023, respectively.

Notes Receivable from Participants. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of (i) \$50,000 or (ii) 50% of their vested account balance. Loan terms range from 1 month up to a maximum of 5 years. The loans are secured by the balance in the participant's account and bear a reasonable rate of interest based on similar loans from commercial lending institutions as determined by the Plan administrator at the time the loan is granted. Principal and interest payments are paid ratably through payroll deductions.

Payment of Benefits. Benefits to participants or beneficiaries are generally payable as a lump-sum equal to the value of their vested account balance upon retirement, termination of employment, death or disability. A terminated employee with a balance of less than a certain dollar threshold, as defined by the Plan document, may be automatically paid out by the Plan upon termination. Participant may also elect a rollover distribution of their vested account balance into another qualified plan or Individual Retirement Account. Additionally, participants may elect in-service withdrawals of their rollover contributions account, upon attainment of age 59 ½, for a qualified reservist distribution, or upon incurring a financial hardship, as defined, if certain criteria are met.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates. The financial statements of the Plan are prepared using the accrual method of accounting. The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to use estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from those estimates.

Investment Valuation and Income Recognition. The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and trustee. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions. Participant contributions and the related Employer matching contributions are recognized in the period in which participant contributions are withheld from compensation.

Notes Receivable from Participants. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Benefit Payments. Benefits are recorded when paid.

Expenses. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Also included in administrative expenses are contract administrator, recordkeeping, and other fees. Certain investment related expenses are included in net appreciation in fair value of investments.

Note 3 – Fair Value Measurements

The Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1. Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2. Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

- Common Collective Trusts ("CCTs") are valued at the net asset value ("NAV") of units held by the Plan at year end. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the CCTs less their liabilities. This practical expedient is not used when it is determined to be probable that the CCTs will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.
- Registered investment companies are valued at the quoted NAV of shares held by the Plan at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The SV Fund is designed for long-term retirement investing. If the retirement program provides access to the SV Fund and competing investment options, then participant transfers, either directly or indirectly, to competing investment options will be subject to an Equity Wash. An Equity Wash requires that transfers must be directed to a non-competing investment option under the Plan for 90 days before such transferred amounts may be directed to any other competing investment option. Competing investment options include other guaranteed investment options, and cash account, money market, other short-term fixed income investment options with an average duration of less than two years, or investment options where the principal amount is guaranteed to Plan participants.

No withdrawal shall be made before the Valuation Date that is 12 months after the date the Trustee receives proper notice of withdrawal from the Participating Trust. Withdrawals to which this restriction applies include, but are not limited to, any whole or partial withdrawal of the assets of a Participating Trust that is initiated by the employer or sponsor of the Participating Trust, including without limitation, the termination of the Participating Trust, the withdrawal of its assets from the Fund, or certain communications designed to instigate redemptions as described in the SV Fund disclosure document. The Trustee may choose to disburse withdrawals as of a Valuation Date earlier than the valuation date provided if the Trustee determines, in its discretion, that the withdrawal is not detrimental to the best interest of the SV Fund and plans participating therein.

Note 4 – Certified Information

- Interest income on notes receivable from participants, as shown in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024; and
- The investment information presented in the Schedule of Assets (Held at End of Year) as of December 31, 2024, as shown in the supplemental schedules.

Note 5 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination or partial termination, affected participants will become 100% vested in their accounts.

Note 6 – Tax Status

The Plan Sponsor has adopted a Principal Life Insurance Company Non-Standardized Pre-Approved Profit Sharing Plan (“pre-approved plan”). The pre-approved plan received an opinion letter from the Internal Revenue Service (“IRS”) on June 30, 2020, which stated that the pre-approved plan is qualified under the applicable sections of the Internal Revenue Code (“IRC”). Although the pre-approved plan and the Plan have been amended since receiving the IRS opinion letter, the Plan administrator believes that the Plan and related trust are currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified under Section 401(a) of the IRC and the related Trust is tax exempt as of December 31, 2024 and 2023. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 – Party-In-Interest Transactions

The Company provides to the Plan certain accounting and administrative services for which no fees are charged.

Certain Plan investments are units of common collective trusts offered by Principal Global Investors Trust Company. As Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company is the trustee of the Plan, these transactions qualify as party-in-interest transactions. Additionally, the Plan maintains notes receivable from participants. Fees paid for services rendered by parties-in-interest were based on customary and reasonable rates for such services.

Note 9 – Nonexempt Prohibited Transactions

During 2022, the Company had nonexempt prohibited transactions related to participant contributions not remitted to the trust in a timely manner as listed in the aggregate on Schedule H, Line 4a: Schedule of Delinquent Participant Contributions. The Company intends to correct these late contributions by remitting principal amounts and lost earnings into the Plan's trust as soon as administratively feasible.

Note 10 – Concentrations, Risks, and Uncertainties

The Plan provides for various investment options in registered investment companies and common collective trusts. Investment securities, in general, are exposed to various risks, such as significant world events, interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts presented in the Statements of Net Assets Available for Benefits. As of December 31, 2024 and 2023, there were three and two investments, respectively, which individually represented more than 10% of net assets available for Plan benefits. See supplemental Schedule of Assets (Held at End of Year) for a complete listing of investments held at December 31, 2024.

Additionally, some investments held by the Plan are invested in the securities of foreign companies, which involve special risks and considerations not typically associated with investing in U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than those of securities of comparable U.S. companies.

Note 11 – Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through September 26, 2025, which is the date the financial statements were available to be issued.
