### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of 403(B) Thrift Plan of RISE Wisconsin, Inc., an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTE 1—DESCRIPTION OF PLAN

The following description of 403(B) Thrift Plan of RISE Wisconsin, Inc. (the Plan), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

*General.* The Plan is a defined contribution plan under Internal Revenue Code (IRC) section 403(b) covering all employees of RISE Wisconsin Inc. (the Company) subject to universal availability. The Plan is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Investment Committee is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance. Employees are eligible to participate in the salary deferral portion of the Plan upon hire. To be eligible for the employer contribution portion of the Plan, employees must have completed at least one year of service and 1,000 hours with the Company, as defined in the Plan.

*Contributions.* Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants who have attained the age of 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 1% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Company may contribute a non-elective contribution at the option of the Company's board of directors as determined annually. In 2024, the Company contributed 6% of participants' eligible plan compensation. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

*Participant Accounts.* Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contribution and (b) Plan earnings and charged with plan expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Vesting.* Participants are vested immediately in their contributions and the Company's contributions plus actual earnings thereon.

*Payment of Benefits.* Upon termination of service due to death, disability, retirement, or attaining the age of 59½, a participant may elect to receive either (a) a lump sum amount equal to the value of the participant's vested interest in his or her account, (b) installments over a period not to exceed the life expectancy of the participant or beneficiary, (c) an annuity contract, or (d) ad-hoc distributions, if a participant's vested account balance is over \$1,000. If a participant terminates employment and their vested account balance does not exceed \$1,000, then the participant account balance may only be distributed in a single lump-sum payment.

*Hardship Distributions.* Participants experiencing financial hardship may withdraw a portion of their account balance as defined in the Plan. The amount is limited to that necessary to meet the financial need. A hardship is considered any one of the following: deductible medical expenses, expenses to repair damages to principal residence, post-secondary tuition for the participant, spouse or dependents, the purchase (excluding mortgage payments) of a principal residence for the participant or payment needed to prevent the eviction of the participant from his principal residence and funeral or burial expenses for parents, spouse, children, and dependents.

NOTE 2—SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Contributions Receivable**

The Plan uses the ERISA definition of plan assets to determine whether an accrual should be made for employee or the related employer contributions receivable based on when amounts have been withheld from employee compensation. A defined contribution plan can elect to recognize the employee and the related employer matching contribution either (1) in the period related to the participant's service or compensation (even if not yet withheld), or (2) in the period the employee contribution is withheld if the policy is applied on a consistent basis.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the contract holder. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to monthly paper statements sent from Mutual of America are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Payment of Benefits**

Benefits are recorded when paid. There were no requested distributions that were not paid out by December 31, 2024.

**Date of Management's Review**

Management has evaluated subsequent events through September 25, 2025, the date which the financial statements were available to be issued.

NOTE 3—FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Level 1 Fair Value Measurements*

*Registered Investment Companies:* Valued using market quotations or prices obtained from independent pricing sources, except those held by CREF Money Market Fund, whose holdings are valued at amortized cost.

*Pooled Separate Accounts:* Those held by Mutual of America are valued at net asset value (NAV) as determined by the insurance company which is readily determinable.

*Level 2 Fair Value Measurements*

*Pooled Separate Accounts:* Those held by TIAA-CREF are valued based on the market value of the underlying real estate holdings or other real estate related investments which are valued by external appraisals.

*Level 3 Fair Value Measurements*

The fair value of the insurance company general account contract held by TIAA-CREF is valued at the accumulated cash contributions and interest credited to the Plan's contract, less any withdrawals. The value of the insurance contract is readily determinable. The crediting rate is supported by the investment performance of a large, diversified portfolio, is correlated with the highest quality debt security yields, and is adjusted for contract liquidity. A twenty- year analysis of crediting rates for TIAA Traditional Annuity contracts suggests a rate of return that is representative of a risk-adjusted market rate for this type of product; thus, application of observed rates would yield a discounted cash flow which approximates contract value. In determining the reasonableness of the methodology, the plan administrator evaluates a variety of factors including review of existing contracts, economic conditions, industry and market developments, and overall credit ratings. Certain unobservable inputs are assessed through review of contract terms while others are substantiated utilizing available market data.

NOTE 4—GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has a traditional fully benefit-responsive guaranteed investment contract with Mutual of America Life Insurance Company (Mutual of America). Mutual of America maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Mutual of America, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023, was \$71,245 and \$60,718, respectively. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 2.85%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the Plan's ability to transact at contract value with Mutual of America. Such events include the following: (a) amendments to plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**NOTE 5—TAX STATUS**

The Company has adopted a pre-approved plan document that has received an opinion letter from the IRS dated March 31, 2017, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although, the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**NOTE 6—PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**NOTE 7—RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 8—PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are managed by TIAA-CREF and Mutual of America. TIAA-CREF and Mutual of America are the contract holders as defined by the Plan and, therefore, these transactions qualify as party in interest transactions.

Mutual of America receives revenue sharing payments from various investments which were all passed through to the fund participants and reduce the separate account expenses charged by Mutual of America for amounts allocated to those funds.

**NOTE 9—CERTIFIED INVESTMENTS**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by TIAA and CREF and Mutual of America (the contract holders of the Plan).

**NOTE 10—PLAN LOANS**

Plan participants may borrow from Mutual of America (MOA) a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance subject to annuity contract and plan provisions. These loans are issued directly from funds owned by MOA and not directly from a participant's account and therefore are not recorded as an asset on the statement of net assets available for benefits. The loans are secured by the participant's MOA General Account balances in an amount equal to 120% of the outstanding loan balances. Loans bear interest rates that may be fixed or variable depending upon the Plan and annuity contract provisions. Principal and interest is paid ratably by the participant to MOA. Interest is paid directly to MOA while the principal repayments increase the amount of MOA General Account funds available for the participants' use. The amount of such outstanding loans was \$20,362 and \$32,854 as of December 31, 2024 and 2023, respectively.

**NOTE 11—SUBSEQUENT EVENT**

The Plan implemented section 109, an optional provision of the SECURE 2.0 Act in 2025. This provision increases catch-up amounts 50% more than the regular catch-up amount in 2025 for individuals who are ages 60-63. The increased amounts are indexed for inflation after 2025.
