Opinion

1. Plan Description

The following description of the International Cars Employee Stock Ownership Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a leveraged employee stock ownership plan ("ESOP") established effective January 1, 2000, as restated January 1, 2013. The Plan covers all employees of International Cars Ltd., Inc. (the Company or Employer) who have completed 1,000 hours of service and are age 18 or older. The Plan is designed to comply with Section 4975(e)(7) and the regulations there under of the Internal Revenue Code of 1986, as amended ("IRC"), and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The International Cars Ltd., Inc. is responsible for oversight of the Plan. The Plan's trustee committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's International Cars Ltd., Inc.

Contributions

The Company is obligated to make contributions in cash to the Plan which, when aggregated with the Plan's dividends and interest earnings, equal the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its term loan. Employee contributions are not permitted. Participants who are not employed on the last working day of a Plan year are generally not eligible for an allocation of Company contributions for such year. Additional discretionary amounts may be contributed by the Company at the option of the Board of directors. For the year ended December 31, 2024, there was a discretionary contribution of \$1,550,000 to the Plan.

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited with an allocation of the Company's discretionary contributions and, on the last day of each plan year, an allocation of the Company's common stock shares released from the unallocated account, as well as forfeitures of terminated participants' non-vested accounts. Only those participants who are eligible employees of the Company as of the last day of the Plan year will receive an allocation. Allocations are based on a participant's eligible compensation, relative to total eligible compensation. Plan earnings are allocated, as defined in the plan agreement, to each participant's account based on the ratio of the participant's account balance to all participants' account balances.

Vesting

If a participant's employment with the Company is terminated for any reason other than retirement, permanent disability, or death, vesting in their contributions is based on years of continuous service. A participant is 20% vested after two years of credited service and continues to vest in increments of 20% until 100% vested after six years of credited service.

Voting Rights

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by Plan Sponsor, the trustee, prior to the time that such rights are to be exercised. The trustee is not permitted to vote any allocated share for which instructions have not been given by a participant. The Trustee is required, however, to vote any unallocated shares on behalf of the collective best interests of Plan participants and beneficiaries.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant will receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or installment payments as provided in the plan document. For distributions for other separations from service, a participant can elect to receive their account balance by the close of the sixth Plan year following the Plan year in which the separation occurs. Payments are made in annual installments up to five years based on the account balance at the time of the event. The amount to be distributed is based upon the immediately preceding valuation date. Distributions are made in cash or, if a participant elects, in the form of Company common shares plus cash for any fractional share. If at the time a participant terminates employment and his or her vested account balance is \$1,000 or less, the participant shall receive their vested account balance in a lump sum by the end of the following Plan year. If at the time a participant terminates employment, his or her vested account balance is \$5,000 or less, but more than \$1,000, the participant may elect to receive such vested account balance in a lump sum by the end of the following Plan year. Under the provisions of the Plan, the Company is obligated to repurchase participant shares which have been distributed under the terms of the Plan unless the shares are subject to trading limitations.

The Plan may use employer contributions to fund cash distributions to participants, with remaining distributions to participants in shares of employer stock, which are required to be repurchased from participants by the Company and retired. For the year ended December 31, 2024, the Company funded all distributions with cash.

Forfeited Accounts

Plan forfeitures are allocated to each participant's account in the same manner in which the Company contributions are allocated. There were no unallocated forfeiture amounts as of December 31, 2024 and 2023. During 2024 and 2023, \$52,571 and \$82,300, respectively was allocated to participant accounts from forfeited nonvested accounts, in accordance with plan provisions.

Put Option

Under federal income tax regulations, the Company stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

The ESOP provisions require that participants leaving the ESOP sell their allocated stock back to the Company and for the Company to repurchase the shares at the fair market value determined as of the most recent valuation date (December 31, 2024 and 2023, for the years ended December 31, 2024 and 2023, respectively). During 2024, there were no repurchases of shares of common stock.

Diversification

Diversification is offered to participants who are at least 55 years old and have participated in the Plan for at least 10 years (a Qualified Participant). During each of the first five years of eligible diversification, a Qualified Participant may withdraw up to 25% of the value of their investment in Company common stock, less any shares previously diversified, and transfer the amount as a rollover into another qualified plan or as a cash withdrawal. In the sixth and subsequent years, the percentage amount that can be withdrawn increases to 50%. The election to diversify is made subsequent to year-end based upon the shares of Company stock in the participant's account at year-end.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Allocations

The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated stock ("allocated") and (b) stock not yet allocated to employees ("unallocated"), including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustee committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

Subsequent Events

Subsequent events were evaluated through September 30, 2025, the date the financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

Company Common Stock and Convertible Preferred Stock: The fair values of the Company's common stock and convertible preferred stock are valued annually, as of the last day of the Plan year, based upon the results of an independent third-party appraisal performed by a business appraiser selected by the Plan trustees who is accredited by the American Society of Appraisers. The appraisals are performed using a combination of the income approach applying the discounted future cash flows method, the capitalization of cash flows method, and the market approach based upon valuation multiples of guideline public companies (Level 3 inputs). Under the discounted future cash flows method, projections are based upon past performance as identified in financial statements of the Company and management's projections of the Company's future performance.

The capitalization of cash flows method tends to be more appropriate when a company's current operations are indicative of its future operations, while the discounted future cash flow method tends to be more appropriate when future returns are expected to be different from current operations. The resulting cash flow projections are discounted using a market related discount rate (which incorporates the Company's estimated weighted average cost of capital). The guideline public companies' method identifies pricing multiples of public companies deemed to be comparable to the Company. Under both approaches, a discount for a lack of marketability is applied, since the Company's stock is not readily tradable on an established market. The estimated fair value derived in both the years ended 2024 and 2023 appraisals reflected a weighting of 80%, using the cash flows method and 20%, using the guideline public companies method. The historical and projected financial information of the Company used by the appraiser is provided to the appraiser by the Company's Chief Financial Officer ("CFO") who meets with the senior leadership team.

The Plan trustees, CFO and senior leadership team of the Plan sponsor review and evaluate the appraiser's methodology and assumptions, which involves discussions with the appraiser, and the CFO confirms the financial information of the Company used in the appraisal. The Plan trustee, as fiduciary, is responsible for the final approval of the appraisal which is then presented to Plan management and the Board of Directors of the Plan sponsor.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values.

Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

For the years ended December 31, 2024 and 2023, there were no significant transfers between Levels 1, 2, or 3.

Gains and losses included in changes in net assets for the period above are reported in net appreciation in fair value of investments in the statement of changes in net assets available for benefits.

4. Loan Payable

In July 2021, the Plan purchased 200,000 shares of the Company's common stock with a loan from Marshall Jespersen in the amount of \$6,656,598. The lender has no rights against shares of common stock once they are allocated to participants in accordance with the terms of the Plan. The note matures in July 2041 and bears interest at Prime less .75%. As of December 31, 2024 and 2023, the loan interest rate was 6.75% - 7.75%. The borrowing is collateralized by the unallocated shares of common stock and is guaranteed by the Company. Shares are released from collateral and allocated to participants as payments of principal and interest are made. The number of shares released in any year is the number of shares held as collateral, multiplied by the ratio of the current year payments divided by the total of this year's payments, plus all future years' principal and interest payments. This resulted in 40,507 and 7,364 shares being released and allocated for the plan years ended December 31, 2024 and 2023, respectively.

5. Related-Party and Party In Interest Transactions

Certain Plan investments are managed by the trustee, and therefore, these transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

The Plan invests in Company common stock and has indebtedness to and guaranteed by the Company. These are related party and party in interest transactions. As described in Note 2, the Company may pay plan expenses. The Plan has a number of service providers. Such providers are parties in interest under ERISA.

6. Contributions

The Company is obligated to make contributions in cash to the Plan which, when aggregated with the Plan's interest earnings, equal the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its term loan. During 2024, the Company contributed \$2,552,507, of which \$1,954,544 was applied to principal and interest payments and \$597,963 was contributed in cash to fund benefit payments.

7. Plan Termination

Although it has not expressed any intent to do so, the Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon termination of the Plan, the International Cars Ltd., Inc. directs the Trustee to pay all liabilities and expenses of the Plan and to sell shares of financed common stock held as collateral to the extent it determines such sale to be necessary in order to repay the loan. Subsequently, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan agreement and the IRC. In the event of Plan termination, participants would become 100% vested.

8. Tax Status

The IRS has determined and informed the Company by a letter dated July 27, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving this letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Risks and Uncertainties

The Plan investments consist primarily of the Company's common stock, which is exposed to various risks, such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows, and other such techniques. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Concentration of Credit Risk

At December 31, 2024 and 2023, the Plan's investments in the Company represented approximately 99% of its total assets. As of December 31, 2024, the Plan held 364,762 shares of common stock, including 91,089 of unallocated common stock. On December 31, 2023, the Plan held 364,762 shares of common stock, including 131,598 of unallocated common stock.

10. Administration of Plan Assets

The Plan's assets, which consist principally of Company common stock, are held by the trustee of the Plan. Company contributions are held and managed by the trustee. The trustee also administers the payment of interest and principal on the loan, which is reimbursed to the trustee through contributions as determined by the Company.

Certain administrative functions are performed by officers or employees of the Company or its subsidiaries. No such officer or employee receives compensation from the Plan. As provided by the Plan agreement, all administrative expenses will be paid by the Company if not paid from trust assets. To date, the Company has paid all expenses to establish and maintain the Plan.
