As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024, and for the year then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Their report dated September 23, 2024 indicated that (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedule, other than the information in the 2023 supplemental schedule that agreed to or is derived from the certified investment information, were presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2023 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determines meets the requirements of ERISA Section 103(a)(3)(C).

Note 1. Plan Description

General

The following description of the DOS Health Care 401(k) Plan (the “Plan”), as amended, provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

The Plan, which was established on July 1, 1999, is classified as a defined-contribution plan, covering eligible employees of DOS Health Care (the “Company”) with at least 1,000 hours of service during the Plan year, with at least one year of service, and who have attained the age of 21. The primary purpose of the Plan is to provide retirement savings benefits to employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Each year, participants may contribute up to 100% of their gross compensation as defined in the Plan and subject to Internal Revenue Service (“IRS”) limitations. The Company makes a safe harbor matching contribution equal to 100% of participants’ elective contributions up to 3% of their annual compensation, plus 50% of the participants’ elective contributions in excess of 3%, but not greater than 5% of their annual compensation. In addition to the matching contributions, the Company may make qualified non-elective contributions for the benefit of all eligible participants. There were no such qualified non-elective contributions made by the Company during the year ended December 31, 2024.

Participant Investment Account Options

Participants direct the investment of their accounts into various investment options offered by the Plan. Investment account options available include a common/collective trust and registered investment companies.

Participant Accounts

Under the Plan, a separate account is maintained for each participant. Each participant’s account is credited with the participant’s contributions, employer contributions, and allocations of Plan earnings and is charged with an allocation of administrative expenses, if any. Participant contributions and employer matching contributions are allocated, at the participant’s election, to investment funds held at John Hancock Trust Company LLC (the “Plan Custodian”). Participants may change their investment options at any time with certain exceptions. Plan earnings are allocated based on the actual earnings of the respective participant’s investments. The benefit to which a participant is entitled is the vested benefit that can be provided from the participant’s account.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances by executing a note in accordance with the Plan’s provisions. The notes are collateralized by the balance in the participant’s account and bear interest at a rate equal to 4.25% to 9.50%. Participants may have only one outstanding loan at any one time, and the loan must be repaid within a period not to exceed five years from the date of the loan. Principal and interest are repaid ratably through payroll deductions.

Vesting

Participants are immediately vested in their voluntary contributions and employer safe harbor contributions plus actual earnings or losses thereon. Vesting in the qualified non-elective contributions is based on a six-year graded schedule.

Payment of Benefits

Upon the death, permanent disability, or retirement of participants, distribution of benefits may be made in a form of a lump-sum or installment payment. Participants who terminate for reasons other than death, disability, or retirement are entitled only to the value in their account. As of December 31, 2024 and 2023, there were no amounts allocated to the accounts of individuals who have elected to withdraw from the Plan but had not yet been paid.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments held in registered investment companies are valued at the daily closing price, as reported by the fund. The registered investment companies' funds held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The registered investment company funds held by the Plan are deemed to be actively traded and are considered Level 1 investments within the fair value hierarchy (see Note 4).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan Custodian offers a fully benefit-responsive fixed annuity contract (the "John Hancock Stable Value Guaranteed Account") issued by John Hancock Life Insurance Company (U.S.A.) (the "Issuing Company"). The John Hancock Stable Value Guaranteed Account has a minimum guaranteed interest rate, which is 1%. The Issuing Company guarantees that interest will be credited at the higher of the rate guaranteed in the group annuity contract, which is 1%, or the current rate declared by it (2.25% as of December 31, 2024). The Plan Custodian may change the initial interest rate for future contributions. New contributions are guaranteed to earn the applicable initial interest rate for at least a six-month time period from the date contributions are made. Investments held in the John Hancock Stable Value Guaranteed Account are deemed to be fully benefit-responsive, and contract value is the relevant measurement attribute because that is the amount participants normally will receive if they were to initiate permitted transactions under the terms of the Plan. The Plan Custodian values the John Hancock Stable Value Guaranteed Account by crediting the declared rate of interest to the amounts allocated to the account. This value represents the amount Plan participants would receive if they were to withdraw or transfer funds within the Plan. The Plan's ability to receive amounts due in accordance with the fully benefit-responsive contract is dependent upon the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer.

Purchases and sales of funds are reflected on a trade-date basis. Interest income is recorded as earned on the accrual basis. Interest is automatically reinvested in additional fund units.

In accordance with the Plan's policy of stating marketable securities at fair value, the net appreciation for the year ended December 31, 2024 is reflected in the statement of changes in net assets available for benefits as net appreciation in fair value of investments.

Notes Receivable from Participants

Notes receivable from participants are recorded at their unpaid principal balance plus accrued but unpaid interest.

Contributions

Contributions to the Plan are recorded in the period in which they become obligations of the Plan Sponsor.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

The Plan's administrative expenses are shared by the Plan and the Company, as provided by the Plan document. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles, and with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Subsequent Events

The Company has evaluated subsequent events for recognition and disclosure through October 2, 2025, which is the date the financial statements were available to be issued.

Note 3. Certification of the Plan Custodian

The Plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Plan Custodian, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Fair Value Measurements

The fair value of financial instruments is presented based upon a hierarchy of levels that prioritize the inputs of valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy are described below:

- Level 1** Unadjusted quoted prices in active markets for identical assets or liabilities the Plan has the ability to access at the measurement date.
- Level 2** Inputs to the valuation methodology that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3** Significant, unobservable inputs used for valuing the asset or liability in which little or no market data exists.

A financial instrument's level, within the fair value hierarchy, is based on the lowest level of input that is significant to the fair value measurement in its entirety.

There were no transfers of investments among fair value levels during the years ended December 31, 2024. There were approximately \$7,254,000 of funds transferred from fair value Level 2 investments to fair value Level 1 investments during the year ended December 31, 2023.

Note 5. Exempt Party-in-Interest Transactions

Certain plan investments are funds managed by the Plan Sponsor as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions. During 2024, administrative and other custodian costs associated with investment accounts of \$49,311 were charged directly to the Plan. The Company also absorbs significant costs related to various administrative and investment advisory services on behalf of the Plan.

Note 6. Risks and Uncertainties

The Plan's investments are not insured and are subject to risk. Financial information relating to those investments is included in these financial statements based on information provided by the Plan Custodian.

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 7. Income Tax Status

The Plan is intended to be a qualified trust under Section 401 of the Internal Revenue Code ("IRC") and is subject to the provisions of ERISA. The original Plan is a prototype plan prepared and maintained by the Plan's third-party administrator. The prototype plan obtained its latest determination letter on June 30, 2020, in which the IRS stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the IRC. The adopted Plan has been amended, and the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and tax exempt. Therefore, no provision for income taxes has been included in the Plan's accompanying financial statements.

Note 8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.
