Note 1 - Plan Description

The following brief description of the Pencco, Inc. 401(k) P/S Plan (the Plan) is provided for general information only. Participants should refer to the plan document for more detailed information.

General

The Plan is a defined contribution plan covering all eligible employees of Pencco, Inc. (the Company and plan administrator). The Plan is subject to the provisions of the Employee Retirement Income Act of 1974, as amended (ERISA). The Plan was adopted by the Company on January 1, 2008, and has been amended and restated from time to time. John Hancock Life Insurance Company (John Hancock) served as the Plan's asset custodian and recordkeeper from January 1, 2024 until July 31, 2024, and Fidelity Management Trust Company (Fidelity) served as the Plan's asset custodian and recordkeeper from August 1, 2024 until December 31, 2024.

Eligibility

The Plan is a defined contribution plan, covering all eligible employees of the Company who have attained age eighteen and completed the minimum requirement of three months of service. Eligible employees will become participants in the Plan on the first day of the quarter coinciding with or next following the date the eligibility requirements have been met. Effective August 1, 2024, the Plan was amended to reduce the three-month service requirement to only one month of service, as well as modify the entry date to monthly rather than quarterly.

Contributions

The Plan includes a savings feature designed to permit employees and the Company to contribute to the Plan, as allowable under Section 401(k) of the Internal Revenue Code (IRC). Each year, participants may elect to contribute a percentage or a set dollar amount of their annual compensation to the Plan, subject to certain limitations, up to the maximum allowed by the IRC. The Plan also allows for Roth elective deferrals. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified benefit or contribution plans (rollovers).

The Company makes safe harbor employer matching contributions equal to 100% of the participant's elective deferral up to 3% of compensation, plus 50% of the participant's elective deferral that exceeds 3% but does not exceed 5% of the participant's compensation.

The Company may make additional discretionary matching contributions to the Plan, which are subject to certain limitations. There were no additional discretionary contributions made during 2024.

The company may elect to make profit sharing contributions equal to a discretionary amount or may make qualified non-elective contributions (QNEC), either of which is determined each Plan year.

Vesting

Participants are vested immediately in their salary deferral contributions plus actual earnings thereon. Vesting in the Company's safe harbor matching contributions plus actual earnings thereon is based on years of service. A participant is 100% vested after two years of credited service. Vesting in the Company's discretionary matching contributions is based on years of continuous service. Participants are 20% vested in discretionary matching contributions upon completion of two years of service, increased by 20% per year thereafter. Participants are 100% vested after six years of credited service. Regardless of service term, full and immediate vesting occurs for participants upon retirement, death or disability prior to termination of employment.

Forfeitures

Forfeitures attributable to the nonvested matching contributions made by the Company are to be used to reduce employer matching contributions or offset plan expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$48,522 and \$11,761, respectively. No forfeitures were used to reduce employer matching contributions or pay plan expenses for the year ended December 31, 2024.

Participant Accounts

Separate accounts are maintained for each participant. Upon enrollment in the Plan, a participant may direct the investment of his or her account balance. Participants may change their investment options at any time.

Investment earnings and losses are allocated daily to participant accounts in the same ratio as the participant's investment in each fund bears to the total of all participants' investments in each fund.

Each participant's account is credited with the participant's voluntary deferral contribution, safe harbor matching contributions, plan earnings and losses, and allocated administrative expenses for investment management fees. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Notes receivable from participants are loans to participants secured by the vested portion of their accounts as prescribed in the plan document. Participants may borrow up to 50% of their vested account balance, with a minimum loan amount equal to \$1,000 and the maximum loan amount not to exceed \$50,000. The loans are secured by the balance in the participant's vested account and bear an interest rate at the prime rate (7.50% at December 31, 2024) plus 1.00%. Principal and interest are paid ratably through bi-weekly payroll deductions. Loan terms are limited to five years unless for the purchase of a principal residence. Loans for the purchase of a principal residence are limited to terms of 15 years. Participants may only have two loans outstanding at a time.

Benefit Payments

Distributions may be made to participants upon termination of employment, disability, retirement, or death. In-service distributions are allowed for participants who have reached the age of 59½ as well as for other permitted reasons. Additionally, hardship withdrawals may be made to active participants who have demonstrated financial need, subject to the provisions of the Plan. Upon termination, participants with an account balance of \$1,000 or less shall receive an automatic lump-sum distribution from the Plan. Participants with an account balance between \$1,000 and \$5,000 shall receive a direct rollover to an IRA in the participant's name. Upon withdrawal from the Plan or termination of employment, participants may be subject to tax on contributions and income earned.

Note 2 - Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP). Accounting principles followed by the Plan and methods of applying those principles are summarized below:

Investment Valuation and Income Recognition

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in the fair value of investments includes realized gains or losses on investments sold during the year as well as unrealized gains or losses on the investments held at the end of the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as the notes are collateralized by the participants' account balances. Interest income is recorded on the accrual basis. In general, notes receivable from participants are considered in default in the calendar quarter following the quarter in which no payment is made. Defaulted loans are accounted for as distributions based upon the terms of the plan document when a distributable event has occurred.

Benefit Payments

Benefits paid to participants or their beneficiaries are recorded when paid.

Administrative Expenses

Administrative expenses are paid by the Plan unless paid by the Company at its discretion.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Risks and Uncertainties

The Plan provides for investments in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investments will occur in the near term and may impact participant account balances and the amounts reported in the financial statements.

Note 3 - Information Certified by the Plan's Asset Custodians

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator has obtained certifications from Fidelity as of December 31, 2024 and for the period of August 1, 2024 through December 31, 2024, and from John Hancock for the period of January 1, 2024 through July 31, 2024 that all of the information provided is complete and accurate. Information included in the accompanying financial statements, the notes to the financial statements and the supplemental schedule regarding investments, notes receivable from participants, investment income and interest income on notes receivable from participants is presented solely in reliance upon this certification.

The Plan's independent auditor did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements, the accompanying notes to the financial statements, and the supplemental schedule.

Note 4 - Fair Value Measurements

GAAP provides a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds – These investments are valued based upon their quoted market prices.

Pooled Separate Accounts – These funds are valued at their net asset value (NAV) as determined by the issuer based on quoted market prices of the underlying investments, when available. The NAV is used as a practical expedient to estimate fair value. The practical expedient is not used when it is determined to be probable that the investment will be sold for an amount different than reported NAV.

Common/Collective Trust Funds – These investments are valued at their NAV as reported by the issuer based on quoted market prices of the underlying investments, when available, net of certain expenses. The NAV is used as a practical expedient to estimate fair value. The practical expedient is not used when it is determined to be probable that the investment will be sold for an amount different than reported NAV.

The pooled separate accounts and common/collective trust funds that are measured using NAV as a practical expedient have been excluded from the fair market value hierarchy in accordance with GAAP.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a complete termination of the Plan, participants shall be fully vested in all amounts allocated to their accounts, and such amounts will be distributed.

Note 6 - Federal Income Tax

Effective January 1, 2022, the Plan was amended and restated via its adoption of a pre-approved plan. The pre-approved plan received an opinion letter from the Internal Revenue Service (IRS) dated November 30, 2020, stating that it was in compliance with the applicable requirements of the IRC. The volume submitter plan and the pre-approved plan have both been amended since receiving their IRS letters; however, the plan administrator believes the Plan is designed and currently being operated in compliance with the applicable provisions of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and to recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

Note 7 - Party-in-Interest Transactions

Certain investments of the Plan were issued by John Hancock or an affiliate, and certain investments of the Plan are issued by Fidelity or an affiliate, and therefore, these transactions qualify as party-in-interest transactions. These transactions are covered by an exemption from the “prohibited transaction” provisions of ERISA and the IRC.

Note 8 - Subsequent Events

The plan administrator evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 3, 2025, which is the date the financial statements were available to be issued.
