Consideration of Internal Control Over Financial Reporting

In planning and performing our audit of the financial statements of Atlantic Squared Supply, LLC 401(k) Profit Sharing Plan as of and for the year ended December 31, 2024, in accordance with auditing standards generally accepted in the United States of America (GAAS), we considered the Plan's internal control over financial reporting (internal control).

This consideration served as a basis for designing our audit procedures that are appropriate in the circumstance for the purpose of expressing our opinion on the financial statements.

However, this consideration was **not** for the purpose of expressing an opinion on the effectiveness of the Plan's internal control.

Accordingly, we do not express an opinion on the effectiveness of the Plan's internal control.

Our consideration of internal control was for the limited purpose described in the preceding paragraphs and was not designed to identify all deficiencies in internal control that might be material weaknesses or significant deficiencies and, therefore, material weaknesses or significant deficiencies may exist that were not identified.

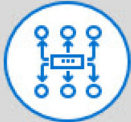

Categorizing Deficiencies by Severity

Deficiency

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent or detect and correct misstatements on a timely basis.



Significant Deficiency

A significant deficiency is a deficiency, or combination of deficiencies, in internal control that is less severe than a material weakness, yet important enough to merit attention by those charged with governance.



Material Weakness

A material weakness is a deficiency, or a combination of deficiencies, in internal control, such that there is a reasonable possibility that material misstatements of the Plan's financial statements will not be prevented or detected and corrected on a timely basis.



Identified Deficiencies

We identified certain deficiencies in internal control that we consider to be significant deficiencies and other deficiencies we consider to be common deficiencies.

Significant Deficiencies

- Ineligible compensation for bonuses and commissions - The Plan was amended during 2024 to exclude commission and bonus payments from eligible compensation for deferral and match purposes. During our testing, we an instance where an employee continued to receive deferrals and employer matching contributions on commission payments after the effective date of the amendment. Following this finding, we expanded our review to assess the broader impact across the employee population. We noted that while the total dollar amount of ineligible contributions was immaterial, the issue was pervasive, affecting a significant number of employees. This represents a compliance issue with the Plan's terms and may require corrective action.

We recommend that the Company implement controls to ensure commissions and bonuses are excluded from compensation used in deferral calculations going forward. Additionally, we suggest consulting with ERISA counsel to determine the appropriate corrective action for affected participants and to ensure compliance with applicable regulations.

- Plan definition of compensation - We noted in our contribution consistent missapplication of the plan definition of compensation related to car allowances, bonuses, commissions, and post employment payouts. These amounts were inconsistently included and excluded as plan compensation, resulting in errors for employee deferrals and employer matching contributions.

We recommend that management review the Plan's definition of eligible compensation in detail and assess the payroll system configuration to ensure that compensation types are properly included or excluded in accordance with Plan provisions. This review should cover both employee and employer matching contributions to ensure ongoing compliance.

- W2 and allocation report differences - During our contribution testing, we identified discrepancies between the Plan's allocation report, which reflects the contributions participants actually received, and the W-2 wage and contribution data used for tax reporting. Misalignment between payroll, W-2 reporting, and Plan records can result in inaccurate tax reporting, participant account balances, and potential compliance issues with IRS and DOL regulations.

We recommend the Plan sponsor consult with ERISA counsel to determine the appropriate corrective action for affected participants. Additionally, we suggest management perform a comprehensive reconciliation between payroll systems and Plan records to ensure consistency in contribution reporting and to prevent future discrepancies.

Deficiencies

- Third-party payroll provider reporting - Throughout our testing, we noted that employer match amounts reported by the third-party payroll provider does not reconcile with the employer match amounts recorded by Ameritas, the Plan's recordkeeper. This is due to manual adjustments being made to the match calculation calculated by the third-party payroll provider and eligible compensation used by the third-party payroll provider.

We recommend management work closely with the third-party payroll provider to ensure the match calculation and definition of plan compensation is correct.

- Employer match calculation – During our contribution testing, we identified an instance where a participant did not receive the correct match. The error stemmed from match-eligible wages being capped based on gross wages rather than eligible compensation as defined by the Plan.

We recommend that management consult with third-party administrator and ERISA counsel to identify appropriate corrective action for impacted participants. Additionally, we recommend management review the employer match calculations for participants on a regular basis and make corrective contributions for any employees negatively impacted during the plan year.

- Prior year compliance testing - We noted the prior year discrimination testing provided by management resulted in corrections that were below trivial misstatement so no adjustment was recorded. However, in the current year, the cumulative correction related to the prior year exceeded the trivial misstatement threshold. Due to incomplete or insufficient prior year discrimination testing, we recorded a passed adjustment to beginning net assets was recorded in the current year to reflect the correction.

We recommend that management ensure completeness and accuracy of compliance testing in a timely manner.

We have determined that an ERISA Section 103(a)(3)(C) audit is permissible under the circumstances. We have also determined that the investment information is prepared and certified by a qualified institution as described by 29 CFR 2520.103-8, that the certification meets the requirements in 29 CFR 2520.103-5 and, that the certified investment information is appropriately measured, presented, and disclosed in accordance with accounting principles generally accepted in the United States of America.

The purpose of an ERISA Section 103(a)(3)(C) audit is to express an opinion on whether the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with generally accepted accounting principles and that the assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the certified investment information.

Certain representations in this letter are described as being limited to matters that are material. Items are considered material, regardless of size, if they involve an omission or misstatement of accounting

information that, in light of surrounding circumstances, makes it probable that the judgment of a reasonable person relying on the information would be changed or influenced by the omission or misstatement. An omission or misstatement that is monetarily small in amount could be considered material as a result of qualitative factors.

4. We acknowledge the Plan does not meet the definition of a "public entity" under generally accepted accounting principles.
5. We have responded fully and truthfully to all your inquiries.

Plan Design & Operations

6. We acknowledge our responsibility for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the ERISA plan financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants to determine the benefits due or which may become due to such participants.

7. The Plan is qualified under the appropriate section of the Internal Revenue Code, and we intend to continue them as a qualified Plan and trust. We do not have any intention at present to terminate the Plan. Required nondiscrimination testing under the appropriate Code Sections has been completed for the Plan, and any excess contributions have been disposed of in accordance with regulations.
8. The adoption date of the most recent plan amendment was August 28, 2024 as provided to you.
9. The Plan has not obtained a determination letter from the Internal Revenue Service (the "IRS") stating that the Plan was in compliance with the applicable requirement of the IRC. The Plan is relying on the IRS approval of the prototype plan that it is utilizing. The IRS has determined and informed the document sponsor by a letter dated June 30, 2020, that the prototype plan agreement was designed in accordance with applicable sections of the IRC. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

U.S. GAAP requires the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are no audits for any tax periods in progress.

11. The Plan has made no investments during the year that violate the terms of the Plan or Trust Agreement.
12. We have reviewed the reports of all transactions processed by third-party servicers, and, based on our review, we believe the transactions shown in the reports are valid and in accordance with our instructions to the third-party processor. We also have had no communications from any of the Plan's service organizations regarding any fraud, noncompliance with laws and regulations, or uncorrected misstatements.
13. We have complied with the DOL's regulations concerning the timely remittance of participant contributions and loan repayments.
14. As applicable, we have complied with the DOL's regulations concerning the services provider fee disclosures in accordance with Section 408(b)(2).
15. We understand the values of the assets and liabilities recorded in the financial statements could change rapidly, resulting in material future adjustments to investment values that could negatively impact the Plan. We acknowledge that you have no responsibility for future changes caused by the current economic environment and the resulting impact on the Plan's financial statements. Further, the Plan Sponsor is solely responsible for all aspects of managing the Plan, including questioning the quality and valuation of investments.
16. We have evaluated whether there are conditions or events known or reasonably knowable, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year of the date of this letter without consideration of potential mitigating effects of management's plans not yet fully implemented and concluded substantial doubt does not exist.

Misappropriation, Misstatements, & Fraud

17. We have informed you of all current risks of a material amount that are not adequately prevented or detected by our procedures with respect to:
 - a. Misappropriation of assets.
 - b. Misrepresented or misstated assets or liabilities.
18. We have no knowledge of fraud or suspected fraud affecting the Plan involving:
 - a. Management or employees who have significant roles in internal control over financial reporting, or
 - b. Others when the fraud could have a material effect on the financial statements.
19. We have no knowledge of any allegations of fraud or suspected fraud affecting the Plan received in communications from participants, former participants, regulators, third-party servicers or others.
20. We have assessed the risk that the financial statements may be materially misstated as a result of fraud and disclosed to you any such risk identified.

Related Parties & Parties-in-Interest

21. We have disclosed to you the identity of all of the Plan's related parties and parties-in-interest and all the related-party and party-in-interest relationships of which we are aware.

In addition, we have disclosed to you all related-party transactions and amounts receivable from or payable to related parties of which we are aware, including any modifications during the year that were made to related-party transaction agreements which existed prior to the beginning of the year under audit, as well as new related-party transaction agreements that were executed during the year under audit.

Another party is also a related party if it can significantly influence the management or operating policies of the transacting parties or if it has an ownership interest in one of the transacting parties and can significantly influence the other to an extent that one or more of the transacting

parties might be prevented from fully pursuing its own separate interests.

The term affiliate refers to a party that directly or indirectly controls, or is controlled by, or is under common control with, the Plan.

23. Neither the Plan nor the Plan Sponsor are aware of any pending or threatened litigation or claims whose effects should be considered when preparing the financial statements. Neither the Plan nor the Plan Sponsor have sought or received attorney's services related to pending or threatened litigation or claims during or subsequent to the audit period. Also, we are not aware of any litigation or claims, pending or threatened, for which legal counsel should be sought.
24. We have no knowledge of communications, other than those specifically disclosed, from regulatory agencies, governmental representatives, employees, or others concerning investigations or allegations of noncompliance with laws and regulations, deficiencies in financial reporting practices, or other matters that could have a material adverse effect on the financial statements.
25. We have disclosed to you all known instances of violations or noncompliance or possible violations or suspected noncompliance with laws and regulations whose effects should be considered when preparing financial statements or as a basis for recording a loss contingency.
26. We have apprised you of all communications, written or oral, with regulatory agencies concerning the operation of the Plan.
