## Independent Auditor's Report

To the Board of Directors of

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### **Other Matter - Supplemental Schedule Required by ERISA**

The supplemental Schedule of Assets (Held at End of Year) is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

#### **1) Description of Plan**

The ARCA 401(k) Plan (the “Plan”) was established September 6, 2014 by ARCA (the “Company”). The following description of the Plan provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

##### General

The Plan is a defined contribution plan and covers all eligible employees. There is no service requirement for employee pre-tax deferral contributions. There is no service requirement to be eligible for an employer matching contribution. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

##### Contributions

Each year, participants may contribute amounts in accordance with Internal Revenue Code regulations as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participant contributions may include regular and roth contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 4% of eligible compensation. Contributions are automatically invested in a designated balanced fund until changed by the participant. ARCA made matching contributions up to 4% of compensation for the years ended December 31, 2024 and 2023. The employer matching contributions for 2024 and 2023 were approximately \$577,000 and \$513,000, respectively.

##### Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company’s matching contribution and, (b) Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant account or compensation balances as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

The Plan utilizes a graded-vesting schedule for ARCA’s matching contributions. A “Year of Vesting Service” is a Plan year during which 800 hours of service is completed. The following discretionary vesting schedule applies to matching contributions:

<u>Years of Vesting Service</u>	<u>Vesting Percentage</u>
Less than two years	0%
Two years but less than three years	20%
Three years but less than four years	40%
Four years but less than five years	60%
Five years but less than six years	80%
Six or more years	100%

Special Vesting Rules: Participants will become fully (100%) vested upon attainment of normal retirement age while an employee, death while an employee, or suffering a disability while an employee.

Participants are always 100% vested in their employee deferrals, rollover contributions and qualified nonelective contributions.

Investment Options

Upon enrollment in the Plan, a participant may direct employee contributions into any of the investment options offered by the Plan. Participants may change their investment options each business day. All investments are participant directed.

Notes Receivable from Participants

Participants are able to borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. Loan terms range from one to five years. Loans for the purchase of a residence may be up to ten years. The loans bear interest at a prime rate plus two percent (2%). Payments will be made through payroll deduction every pay period. Loans become payable in full upon the participant’s termination of employment.

Payments of Benefits

Upon termination of service due to death, disability or retirement, vested benefits are distributed in accordance with specific requirements outlined in the Plan document. A terminated participant is entitled to a lump sum distribution as soon as administratively feasible.

Forfeited Accounts

Forfeitures are used to reduce the employer match contribution and pay administrative expenses. For the periods ended December 31, 2024 and 2023, forfeitures from non-vested terminated participants used to reduce employer contributions and pay plan expenses totaled approximately \$175,000 and \$172,000, respectively. The forfeiture balance remaining at December 31, 2024 and 2023 was approximately \$40,000 and \$22,000, respectively.

2) **Summary of Significant Accounting Policies**

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan's administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reported period. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

In compliance with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan values its investments at fair value, as determined by quoted market prices. Realized and unrealized gains and losses on investments are reflected in the statements of changes in net assets available for benefits. Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Investment Valuation and Income Recognition - continued

Investments are reported at fair value and, as such, their reported value for financial statement purposes is subject to market fluctuations. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for discussion of fair value measurements. Accordingly, the price which may be realized upon the sale of the respective investment may not be equal to its value as currently presented.

Net appreciation and depreciation include the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. Related fees are charged directly to the borrowing participant's account. Principal and interest are paid ratably through monthly payroll deductions. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Expenses

Participants are charged for some or all of the costs and expenses of operating the Plan. Such expenses include, but are not limited to, trust services, investment expenses and costs to process loans, plan distributions and domestic relations orders.

Date of Management's Review

Subsequent events were evaluated through October 1, 2025, which is the date the financial statements were available to be issued.

#### **5) Plan Termination**

Although it has not expressed intent to do so, ARCA, as the Plan's sponsor, has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

#### **6) Tax Status**

The Plan sponsor initially adopted a prototype Plan, effective September 6, 2014. The Plan is operating as a tax-exempt plan under a prototype document with a standardized adoption agreement. The Internal Revenue Service ("IRS") has determined and informed the Plan sponsor by letter dated September 30 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is subject to income tax examinations for the year ended December 31, 2021 and thereafter.

#### **7) Fair Value Measurement**

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

*Level 1 Fair Value Measurements* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value.

*Registered Investment Company Shares* – Valued at the net asset value of shares held by the Plan at the end of each day, which is determined by quoted prices in an active market.

*Cash and Cash Equivalents* – Valued at cost which approximates fair value.

8) **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
