INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Unitex Textile Services LLC 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from Ascensus Trust Company as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 of the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section-

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material aspects, in accordance with accounting principles generally accepted in the United States of America.

Basis of Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTE 1 - DESCRIPTION OF PLAN

The following description of Unitex Textile Services LLC (“Company”) 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Summary Plan Description or Plan Document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all full-time employees of the Company who are age 18 or older (age 21 prior to 2011), are not covered by a collective bargaining agreement, and prior to January 1, 2024, have completed three continuous months of service as of the plan entry dates (on the first day of each calendar quarter). It is subject to the provisions of the Employees Retirement Income Security Act of 1974 (ERISA). Effective January 1, 2024, full-time employees are eligible to participate upon hire, and are auto-enrolled at 3% of eligible compensation. Participants have the right to elect out of the Plan.

On January 1, 2022, the Plan was restated to formally include IRS retirement plan qualification requirements. No material adjustments to the Plan were made by this restatement.

On January 1, 2024, the Plan was amended and restated to implement certain requirements in compliance with the SECURE 2.0 Act.

Contributions

In 2024 and 2023, participants were able to defer up to \$23,000 and \$22,500, respectively, of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year were eligible to make catch-up contributions of \$7,500 for 2024 and 2023, respectively. Those amounts may increase each year according to federal law. For 2024, total additions to a participant’s account through salary deferral and employer matching and contributions may not exceed the lesser of \$69,000 or 100% of the participant’s annual compensation. The compensation limitation is \$345,000 for 2024.

Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers 28 mutual funds as investment options for the participants.

The Company makes a matching contribution to each participant who has completed one year of service, in the amount of 25% of his or her elective deferrals up to 10% of qualifying earnings, for an effective matching contribution limitation of 2.5% of qualifying earnings.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution, and (b) Plan earnings, and may be charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

NOTE 1 - DESCRIPTION OF PLAN (continued)

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after three years of credited service. Participants' accounts become fully vested upon attainment of the normal retirement age of 65, the early retirement age, defined as 55 with three years of service, or in the event of death or total disability.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 8.50%, which are commensurate with local prevailing rates as determined by the Plan Administrator at loan inception. Principal and interest is paid ratably through payroll deductions.

Effective April 3, 2020, the Plan adopted the distribution provision of Coronavirus Aid, Relief and Economic Security ("CARES") Act that was signed into law on March 27, 2020. A CARES Act distribution allows the Plan's participants to take a COVID-19 related distribution up to \$100,000 from the Plan beginning on or after January 1, 2020 and before December 31, 2020. The CARES Act also raised the limit for qualified plan loans from the lesser of \$50,000 or 50% of the present value of the participant's vested account balances to the lesser of \$100,000 or 100% of the present value of the participant's vested account balance for loans issued beginning March 27, 2020 and ending September 23, 2020.

Payment of Benefits

On termination of service due to death, disability, or retirement, or other reasons, a participant or beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over any period not extending beyond the life expectancy of the participant and his or her beneficiary. Plan balances less than \$1,000 will automatically be distributed in a lump sum.

Forfeitures

Amounts forfeited by terminating participants of the Plan are reallocated upon termination. These amounts may be used by the Company to pay plan expenses or to pay company contributions to the Plan. Unapplied forfeitures were \$46,551 and \$47,165 at December 31, 2024 and 2023, respectively.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Date of Management's Review

Subsequent events were evaluated through October 6, 2025, which is the date the financial statements were available to be issued.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Corrective Distributions and Refunds Payable

Amounts payable to participants totaling \$77,370 for contributions in excess of amounts allowed by the IRS are recorded as corrective distributions and refunds payable, with corresponding reductions to 2024 participant and employer contributions. The Plan distributed the 2024 excess contributions prior to March 15, 2025. There were \$109,397 in excess contributions for the year ended December 31, 2023.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

The Company pays the administrative expenses for the Plan. Administrative expenses shown within the plan are comprised of small fees charged to participant accounts for specified services. The Plan participants paid \$11,850 and \$11,824 for administrative fees for the years ended December 31, 2024 and 2023, respectively.

NOTE 3 – FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying Statement of Net Assets Available for Benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. No Level 2 inputs were available to the Plan, and Level 3 inputs were only used when Level 1 or Level 2 inputs were not available.

Level 1 – Quoted Prices in Active Markets for Identical Securities

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year-end.

Level 2 – Other Significant Observable Inputs

The fair values of other collective trusts are measured using a market approach based on quoted prices for similar securities, interest rates, prepayment speeds, credit risk, etc.

NOTE 7 - TAX STATUS

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrators believe that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 9 – RELATED PARTY TRANSACTIONS

The Plan receives investment advisory services from several third parties and therefore these transactions qualify as party-in-interest transactions. Fees paid by the Plan sponsor for the investment management services amounted to \$49,386 and \$15,564 for the years ended December 31, 2024 and 2023, respectively.

All of these party-in-interest transactions are exempt for the prohibited transaction rules of ERISA.
