## **INDEPENDENT AUDITORS' REPORT**

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Hercules Forwarding, Inc. Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

As indicated in Note 1, the Plan was merged into the acquiring company's qualified plan during January 2025. Our opinion has not been modified with respect to this matter.

Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Hercules Forwarding, Inc. Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.



## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

### 1. DESCRIPTION OF PLAN

The following description of the Hercules Forwarding, Inc. Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan with a plan year beginning January 1 and ending December 31.

All employees of Hercules Forwarding, Inc. (the "Company") with at least 6 months of service and who have attained age 18 are eligible for the Plan. Union employees, nonresident aliens, and leased employees are specifically excluded. Employees are eligible to enter the Plan starting the quarter following the month they become eligible. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

During 2024, the Company was acquired by TFI International, Inc. As part of the acquisition, the Plan was merged into the acquiring company's plan, TForce Holdings USA, Inc. 401(k) Plan (the "Surviving Plan") during January 2025 and there were no additional contributions to the Plan after December 31, 2024. The participants' vested account balances in the Surviving Plan equaled the vested account balance in the Plan upon the transfer.

Plan Administration - The Plan is administered by the Company. Bank of America, N.A. is the custodian of the Plan assets through the date of the transfer. Lincoln Financial Group Trust Company is the trustee and provides recordkeeping services through the date of the transfer.

Contributions - Participants may elect to defer up to 100% of their pretax annual compensation. Contributions may not exceed the limitations prescribed by law. Rollovers from another employer's qualified retirement plan are accepted. The Company provides an employer safe harbor matching contribution to each eligible participant. The Company contributes \$1.00 for every dollar of salary deferred by participating employees up to 3% of the participant's annual compensation; in addition, the Company contributes \$0.50 for each dollar of salary deferred by participating employees that exceeds 3% of annual compensation but does not exceed 5% of the participant's annual compensation. The maximum employer safe harbor matching contribution may not exceed 4% of eligible plan participant compensation.

The Company may also elect to make discretionary employer match or profit sharing contributions to eligible participants. For 2024, the Company did not make any discretionary contributions to the Plan.

Contributions to the Plan are invested in various investment options as directed by the Plan's participants. Participants must evaluate their own investment goals and objectives and choose the investment funds best suited.

Participant Accounts - Each participant's account is credited with the participant's contributions, the Company's safe harbor matching contribution, any discretionary employer contributions, and earnings or losses. Allocations are based on the participant's earnings or account balances, as defined. Plan earnings are allocated on a daily basis. Participants self-direct their contributions to the Plan and their share of the Company's employer safe harbor match contribution among the investment options available under the Plan.

Vesting - Participants are fully vested in their salary deferral and employer safe harbor match contributions as of the first day in which they participate in the Plan. For discretionary contributions, participants vest 20% per year and are fully vested after five years.

Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at a fixed rate determined by the plan administrator. Principal and interest are paid ratably through regular payroll deductions.

Payment of Benefits - Upon termination of service, retirement, death, disability, or attainment of age 60 with five years of plan participation, the entire vested amount of the participant's account balance is payable to the participant or participant's beneficiaries. There are no restrictions on in-service distributions of rollover amounts. A participant may elect to receive their vested account balance as a lump sum distribution, a rollover into another qualified plan, or a combination of more than one distribution type.

Forfeitures - Forfeitures are retained in the Plan and are used to pay administrative expenses and reduce any future employer contributions. Forfeiture balances as of December 31, 2024 and 2023 were \$1,707 and \$8,635, respectively. Forfeitures of \$7,072 were used during 2024 to pay administrative expenses.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are prepared using the accrual method of accounting.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Investment Valuation and Income Recognition -The Plan's investments are valued at fair value using quoted market prices, except those at contract value. Shares of mutual funds are valued at the net asset value of shares held by the Plan at year end. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. The mutual funds held by the Plan are deemed to be actively traded.

The Lincoln Stable Value Account is a fixed group annuity issued by The Lincoln National Life Insurance Company (Lincoln). Contract value is the relevant measure attributed to that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the contract. Contract value, as reported to the Plan by Lincoln, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Use of Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Administrative Expenses - Certain management, administrative and legal services are provided to the Plan by Hercules Forwarding, Inc. without charge to the Plan.

Payment of Benefits - Benefits are recorded when paid.

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. #### 4. PARTIES-IN-INTEREST

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. The Plan holds notes receivable from participants. These transactions are exempt from being prohibited transactions under ERISA. Certain fees paid by the Plan for investment management services may be included in net appreciation in fair value of investment, as they are paid through revenue sharing, rather than a direct payment.

#### 5. GUARANTEED INVESTMENT CONTRACT

The Plan holds a fully benefit-responsive investment contract with Lincoln National Life Insurance Company. Lincoln maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise. Minimum guaranteed interest rate is 1.00% and interest is updated quarterly. The interest rate at December 31, 2024 and 2023 was 2.30% and 2.10%, respectively.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Company or other Company events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable. As part of the merger process, Lincoln was provided with required notice and there was no material change to the contract value as a result of the asset transfer during January 2025.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

### 6. FAIR VALUE MEASUREMENTS

The Plan follows generally accepted accounting principles related to fair value measurement. Fair value is defined as the price that would be received from selling an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. When determining the fair value measurements for assets and liabilities required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers assumptions that market participants would use when pricing the asset or liability, such as inherent risk, transfer restrictions, and risk of nonperformance.

Generally accepted accounting principles related to fair value disclosure also establish a fair value hierarchy that requires the Plan to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. A financial instrument's categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the fair value measurement. The three levels of inputs that may be used to measure fair value are as follows:

Level 1 - quoted prices in active markets for identical assets or liabilities;

Level 2 - inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities; or

Level 3 - unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The plan sponsor is responsible for the determination of fair value. Accordingly, they perform periodic analysis on the prices received from the pricing services used to determine whether the prices are reasonable estimates of fair value. As a result of these reviews, the plan sponsor has not historically adjusted the prices obtained from the pricing services.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the end of the reporting period. For the years ended December 31, 2024 and 2023, there were no transfers in or out of Level 1, Level 2 or Level 3.

The Plan's valuation methodology used to measure the fair values of mutual funds were derived from quoted market prices as all of these instruments have active markets.

#### 7. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially effect participants' account balances and the amounts reported in the statement of net assets available for benefits.

#### 8. UNTIMELY CONTRIBUTIONS

The Company has failed to remit to the Plan's trustee certain employee contributions and loan payments within the period prescribed by the DOL's regulations. Amounts previously not remitted within DOL-prescribed regulations during the year ended December 31, 2023 have been deposited to the Plan during 2024. Amounts not remitted within DOL-prescribed regulations and related earnings related to the year ending December 31, 2024 were remitted during 2025.

9. TAX STATUS

The Plan operates under a determination letter dated June 30, 2020, in which the Internal Revenue Service ("IRS") stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan has been amended since the initial determination date, however the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Generally accepted accounting principles require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or DOL. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

10. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events occurring through September XX, 2025, the date that the financial statements were available to be issued for events requiring recording or disclosure in the Plan's financial statements. As discussed in Note 1, due to the Company being acquired during 2024, during January 2025, the Plan was merged into the acquiring company's plan.
