As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

**NOTES TO FINANCIAL STATEMENTS**

**December 31, 2024 And 2023**

**1. Description Of The Plan**

The following description of the Louisa Food Products, Inc. 401(k) Profit Sharing Plan and Trust (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan that is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The purpose of the Plan is to provide participants the opportunity to defer a portion of their compensation for their retirement in accordance with Section 401(k) of the Internal Revenue Code (the Code). The Plan's investments are held by Empower Trust Company, LLC.

**Eligibility**

The Plan covers, generally, all nonunion employees of Louisa Food Products, Inc. (the Company or Plan Administrator) who have one year of service (1,000 hours) and are age 18 or older. Participants may enter the Plan on the first day of year calendar quarter.

The Plan provides for automatic enrollment of employees in the Plan upon satisfying the eligibility requirements. Participants are enrolled at a default contribution rate of 3%. It is the responsibility of the participant to opt out of the Plan if the participant does not want to participate or to elect a different deferral percentage.

**Contributions**

Participants can contribute from 1% to 100% of their base salary subject to certain Internal Revenue Service (IRS) limitations. A participant, age 50 or older, may make catch-up contributions to the Plan.

The Plan provides for Company matching contributions equal to 100% of participant contributions up to 6% of eligible compensation and is applied on a quarterly basis.

The Plan also provides for Company discretionary profit sharing contributions. These contributions are allocated to participant accounts as a percentage of compensation based on each participant's employment class.

Contributions may be invested in a variety of mutual funds offered by the Plan in multiples of 1%. Participants may also elect at any time to reallocate all or any investment option.

**Vesting**

Participants are immediately vested in their contributions, Company matching contributions, and Company discretionary profit sharing contributions plus actual earnings thereon.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, the Company's contributions and an allocation of Plan earnings. The allocation of earnings is determined by the earnings of the participant's investment selections based on each participant's account balance, as defined in the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

**Payment Of Benefits**

Upon termination of service, death, disability, or attainment of normal retirement age of 60, a participant may receive a lump-sum amount equal to the value of their vested account balance.

**In-Service Withdrawals**

Participants may withdraw from the Plan that portion of their account resulting from their salary deferral contributions in the event of undue financial hardship. Certain conditions and restrictions apply, as defined in the Plan Agreement. Participants may also withdraw all or part of their vested account balance upon reaching age 59 ½ or becoming disabled.

**Administrative Expenses**

The Company pays significant administrative fees. Fees associated with distributions are charged to the individual participant's account.

## **2. Summary Of Significant Accounting Policies**

### **Basis Of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

### **Estimates And Assumptions**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

### **Contribution Receivable And Credit Loss Policy**

Amounts due for contributions are stated at the amount that management expects to collect from outstanding balances less an allowance for expected credit losses. The expected credit losses amount reflects management's best estimate of amounts that will not be collected. This assessment considers historical experience, current conditions and, when appropriate, reasonable and supportable forecasts.

The Plan has concluded that no allowance for current expected credit losses was necessary at December 31, 2024 or 2023.

### **Valuation Of Investments And Income Recognition**

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion and disclosures related to fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. The net change in fair value of investments represents the difference between the aggregate fair value of investments at year end and the values at the beginning of the year, and includes any realized gains and losses in shares that were bought and sold during the year.

**Payment Of Benefits**

Benefits are recorded when paid.

**Subsequent Events**

Management evaluates subsequent events through the date the financial statements are available for issue, which is the date of the Independent Auditors' Report.

**3. Certified Investment Information**

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the years then ended, included throughout the Plan's financial statements and supplemental schedule that was prepared by or derived from information certified by Empower, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from Empower that the information provided to the Plan Administrator related to the following information is complete and accurate.

Accordingly, as permitted by CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and supplemental schedule related to the following assets as of December 31:

#### **4. Fair Value Measurements**

The Plan utilizes an established framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value.

**Mutual Funds**

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. Risks And Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

## **6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants will remain fully vested in their account balances.

## **7. Income Tax Status**

The Plan uses a non-standardized pre-approved plan. The pre-approved plan sponsor has received an opinion letter from the IRS dated November 14, 2022, which states that the pre-approved document satisfies the applicable provisions of the Code. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code, which provides that, if certain conditions are met, an employer may rely on a favorable opinion letter issued to a pre-approved plan sponsor as if the employer had received a favorable determination letter. Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
