Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the Financial Statements

We have performed the audits of the accompanying financial statements of The Equinox Holdings, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

NOTE 1 PLAN DESCRIPTION

General

The Equinox Holdings, Inc. 401(k) Plan (Plan) is administered by The Equinox Holdings, Inc. (Company, Plan Administrator, Plan Sponsor). The following brief description of the Plan is provided for general information purposes only. More complete information is provided in the Summary Plan Description and Plan Document, which are available from the Company. The Company established the plan on November 1, 1997. The Plan is subject to the provisions of the Employment Retirement Income Security Act of 1974 (“ERISA”), as amended.

The following are participating employers in the Plan: Blink Fitness Franchising Inc., Blink Holdings, Inc., EQX Hotel Management LLC, EQX Hotel Services LLC, Equinox Media LLC, and SoulCycle LLC.

Eligibility

Employees must be twenty-one years of age or more to be eligible to participate in elective deferrals. No minimum time of employment is required by the Plan for participants to make elective deferrals. Employees must complete 12 months of service and be employed on the last day of the year to receive employer matching contributions. Employees may enter the plan the first day of each month after meeting the Plan’s eligibility requirements. Employees covered under a collective bargaining agreement, nonresident aliens, and residents of Puerto Rico are excluded from the Plan.

Effective August 1, 2024, the Plan was amended to allow automatic enrollment. Newly eligible participants on or subsequent to this date will be automatically enrolled in pretax contributions at a rate of 3%, unless they affirmatively make a different election, or opt out of automatic enrollment.

Employee Contributions

The Plan allows each participant to defer up to the maximum annual limitation set forth in the Internal Revenue Code (the “IRC”) as pre-tax or Roth contributions. Rollovers from other qualified plans and catch-up contributions are also allowed.

NOTE 1 PLAN DESCRIPTION (CONTINUED)

Employer Contributions

The Employer, at its discretion and in an amount as determined year to year, may make a matching contribution. The total of the annual contributions to the Plan on behalf of a participant (including the participant's contribution) is subject to a defined total dollar contribution limit and a defined contribution compensation limit that is based on the participant's annual compensation, as set forth in the IRC. For plan years 2024 and 2023, the administrative committee authorized a discretionary match for SoulCycle employees of 50% on the first 3% of eligible compensation; for every other participating employer, the match was 25% on the first 6% of eligible compensation deferred. Each Plan year's Employer match contribution is paid in the calendar year following the Plan year that it is earned. Accordingly, the match is presented as company contributions receivable on the statement of net assets available for benefits.

Participant Accounts

The Plan is a participant-directed account plan. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants' accounts are credited with participant contributions, Employer contributions and rollovers. Plan earnings are allocated based on participant earnings, account balances, or specific participant transactions, as defined. Administrative expenses are allocated based upon a participant's account balance in proportion to the balances of all participants' accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants' contributions, rollovers, and earnings thereon are always 100% vested. Participants become fully vested in the Company's matching contributions and earnings after two years of service, with no vesting before that time. In the event of total and permanent disability, employer contributions vest immediately.

Forfeitures

Forfeitures may be used to pay Plan expenses or to reduce employer contributions to the Plan. The balance of forfeited accounts was \$266,858 and \$150,868 at December 31, 2024 and 2023, respectively. During the years ended December 31, 2024 and 2023, \$29,138 and \$26,150, respectively, was used to pay Plan administrative expenses.

Investment Options

Contributions are invested by the Trustee according to the options selected by the participants. All participant and employer contributions are directed by the participant among the available investment options. Investment earnings are automatically reinvested into the fund or portfolio from which they were derived.

NOTE 1 PLAN DESCRIPTION (CONTINUED)

Notes Receivable from Participants

Participants may borrow from their participant accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of the participant's vested account balance, whichever is less. The notes are secured by the participant's vested account balances and, except for funds used to acquire a principal residence, have a repayment period of no greater than five years. Only one loan per participant may be outstanding at a time. The interest rate on loans is the prime rate on the first business day of the month before the loan is originated. The interest rate charged is fixed for the life of the loan. Principal and interest are paid ratably in monthly installments via ACH transfers initiated by the participants. Partial lump-sum repayment or repayment of the entire balance is permitted at any time.

Benefit Payments and In-Service Withdrawals

Participants' benefits under the Plan are payable to participants or their beneficiaries upon termination of employment, normal retirement (age 65), disability, financial hardship, or death. Hardship withdrawals are available, as are distributions to participants who have attained the age of 59½. Excess distributions are returned to participants, if necessary, in order to pass IRS compliance testing. If a terminated participant's vested balance is less than \$5,000, an amount exceeding \$1,000 will be automatically distributed to an individual retirement account (IRA) without the participant's consent. If the participant's balance is \$1,000 or less, the participant will receive a lump-sum distribution without consent.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan are prepared under the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. The Plan is responsible for administrative expenses relating to the management of Plan assets incurred by the Plan except for certain transaction fees such as loan and distribution requests, which are paid by the participants. The management fees are allocated either proportionally based on the value of the account balances or as an equal dollar amount based on the number of participants in the Plan. The method of allocating the expenses depends on the nature of the expense. Investment-related expenses are included in net appreciation of fair value of investments.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the Trustee. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded as earned on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Accordingly, actual results may differ from those estimates.

Subsequent Events

The Company has evaluated its subsequent events and transactions occurring after December 31, 2024, through September 24, 2025, the date that the financial statements were available to be issued.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. Plan management distributed the 2024 and 2023 excess contributions of which it was aware to the applicable participants prior to April 15th of the following calendar year.

NOTE 3 INFORMATION CERTIFIED BY THE TRUSTEES

Empower Trust Company, LLC, the trustee of the Plan from January 1, 2023 through March 31, 2023, has certified to the completeness and accuracy of investment activity reflected in the statements of changes in net assets available for benefits for the three month period from January 1, 2023 through March 31, 2023.

Fidelity Management Trust Company, the trustee of the Plan effective April 1, 2023, has certified to the completeness and accuracy of all investment information and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the related investment activity reflected in the statements of changes in net assets available for benefits for the nine month period from April 1, 2023 through December 31, 2023, and for the year ended December 31, 2024, and the ERISA-required supplemental schedules.

NOTE 4 FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 4 FAIR VALUE MEASUREMENTS (CONTINUED)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. (Level 1 inputs)

Common Collective Trust Funds and Stable Value Fund – Valued at the NAV of units of a bank collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of a collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the Trust or account in order to ensure that securities liquidations will be carried out in an orderly business manner. (Other inputs)

Self-Directed Brokerage Accounts – consist of mutual funds, common stocks, options on common stocks, and unit trusts that are valued on the basis of readily determinable market prices.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 RELATED-PARTY TRANSACTIONS

The Plan's investments include investments managed by the Trustees, as defined by the Plan and, therefore, those transactions are considered as party-in-interest transactions.

Notes receivable from participants qualify as party-in-interest transactions.

NOTE 6 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 7 RISKS AND UNCERTAINTIES

The Plan invests in various mutual funds, collective trust funds, and a stable value fund. These investments are exposed to various risks, such as interest rate, market volatility and credit risks. Due to the level of risk associated with these investments, it is at least reasonably possible that changes in the values of these investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8 TAX STATUS

The Plan Sponsor obtained an opinion letter from the Internal Revenue Service (“IRS”) on June 30, 2020 in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 DELINQUENT EMPLOYEE DEFERRAL TRANSMITTALS

During the Plan year ended December 31, 2022, there were occurrences in which the Plan Sponsor did not remit \$5,349 of employee contributions within the timeframe prescribed by the Department of Labor. These delinquent contributions were remitted in 2022, however, as of December 31, 2024, lost earnings on these contributions have not yet been remitted. The late remittances are considered nonexempt transactions. Management is currently working to calculate the lost earnings and intends to fully correct them in 2025.

NOTE 10 SOULCYCLE IRS EXAMINATION

SoulCycle LLC, one of the participating employers of the Plan, was under examination by the IRS for the 2020 plan year. In 2024, the IRS concluded their examination with no findings to report.
