Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Talley Inc. Cash or Deferred Profit Sharing Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Talley Inc. Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

A. Description of Plan

The following description of the Talley Inc. Cash or Deferred Profit Sharing Plan ("the Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provision.

1. **General.** The Plan is a defined contribution plan covering all the eligible employees of Talley Inc. ("the Company") who are employed at enrollment dates of January 1 or July 1 and are age eighteen or older. On May 31, 2024, the Company converted to Talley LLC ("LLC"). The LLC changed ownership during June 2024. The Plan continued unchanged during the year ended December 31, 2024. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). As of December 31, 2024 and 2023, John Hancock Trust Company, LLC is the trustee for the Plan.

2. **Contributions.** Participants may contribute a percentage of pretax annual compensation, as defined by the Plan. The Plan offers various mutual funds as investment options for the participants. The Company may contribute to the Plan out of its current operating cash flow at the discretion of the Company's Board of Directors. Participants may contribute distributions from other qualified defined benefit or defined contribution plans as a "rollover" distribution into the Plan. The Company makes matching contributions based upon a portion of the contribution made by the Participant. In addition, the Company may make discretionary contributions as authorized by its Board of Directors. Contributions are subject to certain IRS limitations.

3. **Participant Accounts.** Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's contribution, (b) Plan earnings, and (c) forfeitures of terminated participant's nonvested accounts, if any, and charged with an allocation of administrative expenses. Allocations are based on participant's earnings or account balance, as defined. The benefit which the participant is entitled is the benefit that can be provided from the participant's vested account.

4. **Vesting.** Vesting in the Company's contributed portion of the participant's account and the related earnings is based on years of continuous service. A participant is 100 percent vested after six years of service. Participants are vested immediately in their contributions plus actual earnings thereon.

5. **Payment of Benefits.** On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump sum or in annual installments over a specified period of years. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution, subject to the appropriate Internal Revenue Service income tax withholding regulations.

6. **Forfeitures.** A participant's non-vested balance is forfeited at the time of termination of employment. Forfeitures may be used to reduce future employer contributions or to pay administrative expenses of the Plan or allocated to the then remaining participants. During the years ended December 31, 2024 and 2023, the Plan used \$66,492 and \$65,623 to reduce employer contributions to the Plan, respectively. At December 31, 2024 and 2023, the forfeiture account was \$48,378 and \$52,083, respectively.

A. Description of Plan, continued

7. **Investment Options.** The Company maintains the retirement assets with an insurance company that provides a selection of mutual funds. This company serves as the trustee of the Plan. Assets in the separate investment allocation account are held by the trustee on behalf of the Plan in one or more of the Trustee's separate investment accounts.

8. **Notes Receivable From Participants.** Participants may borrow from their fund accounts in accordance with terms of the Plan. Notes receivable are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined from time to time by the Plan Administrator. Principal and interest is paid ratably through payroll deductions each payroll period.

B. Summary of Accounting Policies

1. **Basis of Accounting.** The financial statements of the Plan are prepared under the accrual method of accounting and are reconciled to the Form 5500.

2. **Investment Valuation and Income Recognition.** Investment contracts held by a defined-contribution plan are required to be reported at fair value. The value of investments held as of each accounting date is determined based on the fair value of each underlying fund's investments principally using quoted market values from national exchanges. Purchases and sales of investments are reflected on a trade-date basis. The statement of changes in net assets available for Plan benefits includes the net appreciation (depreciation) in the fair value of investments, which consists of the realized gains or losses and the unrealized appreciation (depreciation) on those investments.

Pooled separate accounts are reported at the closing net asset value per unit of participation as determined by the Plan's trustee based upon the respective fund/portfolio as of the last business day of the Plan year. The purchase or redemption price of the units is determined based on the current net asset value per unit of participation. The value per unit is determined by the Custodian using the market values of the underlying assets or the fair values as determined by the Custodian in the absence of an available market price.

3. **Payment of benefits.** Benefits are recorded as paid.

4. **Estimates.** The preparation of financial statements requires management of the Plan to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

5. **Contributions.** Participant contributions are recorded in the period in which the Company makes payroll deductions from Plan participants. The Company's matching contribution is recorded in the related Plan year.

6. **Administrative Expenses.** Expenses related to the administration of the pooled separate accounts and mutual funds are paid by the respective accounts, and are reflected in the overall investment return of such funds or reimbursed from the non-vested fund balance. Any expenses resulting from fund transfers or from withdrawals may be deducted from participants' account balances. The Company pays certain expenses of the Plan.

7. **Risks and Uncertainties.** The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes can materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

8. **Notes Receivable From Participants.** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. The Plan reserves the right to change the ability to borrow or the loan terms. The cost of initiating and servicing the loan are borne by the participant debtor.

C. Information Prepared and Certified by Trustees

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Trust Company LLC (the trustee of the Plan).

D. Fair Value Measurements

The framework for measuring fair value provides fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value end:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust fund: Valued at the NAV of units of a bank collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. Participant transactions may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

These methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. The Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

E. Investments at Contract Value

The Plan may offer a guaranteed income fund meeting the criteria of a fully benefit-responsive contract and reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan and certified by the Trustee, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

F. Expenses

The Company, as sponsor, pays the record keeping and certain administrative fees on behalf of the Plan. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

G. Tax Status

The Internal Revenue Service has determined and informed the Company that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions in accordance with the statute of limitations for audits. The Plan has not been notified by taxing authorities of the intent to audit the Plan. The Plan Administrator believes that the Plan is no longer subject to income tax examinations for years prior to 2021.

H. Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

I. Related Party Transactions

Certain plan investments are shares of mutual funds managed by John Hancock Insurance Company. John Hancock Trust Company, LLC is the trustee of the Plan assets and, therefore, these transactions qualify as party-in-interest transactions. Administrative fees presented on the accompanying statement of changes in net assets were paid to the related party.
