INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator Representatives of The National Football League Capital Accumulation Plan – League Office Employees

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The National Football League Capital Accumulation Plan - League Office Employees (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.

Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess

whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter — Supplemental Schedules Required by ERISA

The supplemental schedule of assets (held at end of year) as of December 31, 2024 and supplemental schedule of delinquent participant contributions for the year ended December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, have been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

**NOTES TO FINANCIAL STATEMENTS
AS OF AND FOR THE YEARS ENDED DECEMBER 31, 2024 AND 2023**

1. ORGANIZATION, BACKGROUND AND PLAN DESCRIPTION

The following description of The National Football League Capital Accumulation Plan - League Office Employees (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan documents for more complete information. However, the more significant provisions of the Plan are as follows:

General - The National Football League (the “NFL”) League Office (the “League Office”) was established by the member clubs of the NFL (the “Member Clubs”) to administer the joint operations of the NFL and the Member Clubs, including the administration of the Plan.

The Plan is a defined contribution plan and was adopted effective April 1, 1984, restated effective January 1, 2002. The Plan has been further amended through June 25, 2020. The Plan provides tax-deferred savings and after-tax savings for employees of the League Office and related entities. The Plan conforms with the Employee Retirement Income Security Act of 1974, as amended (ERISA). PNC Bank (the “Trustee”) serves as the trustee of the Plan.

The Plan is a member plan in the NFL Reciprocal Trust. The Plan invests in a money market fund and the Common Collective Trust (the “Trust”) of the NFL Reciprocal Trust. The Trust was established and is maintained for the collective investment and reinvestment of monies contributed to the plans of the Member Clubs and other NFL entities. The assets of the NFL Reciprocal Trust are maintained by the Trustee.

Plan Administration - The Plan is administered by the League Office and the NFL Employee Benefit Committee appointed by the Commissioner of the NFL.

Eligibility - Employees may participate in the Plan as of the first day of the month following the later of the completion of 500 hours of service in a computation period, which is a twelve consecutive month period beginning on the date on which an employee first performs an hour of service or an anniversary thereof, or the three month anniversary date of the employee’s date of hire. Employment by a Member Club or other NFL entity will count towards meeting the eligibility requirement.

Contributions - Participants may elect to contribute, as a salary deferral contribution, as defined, to the Plan, subject to certain Internal Revenue Code (IRC) limitations. The Plan includes an automatic enrollment feature for newly eligible employees. Employees may opt out of this feature at any time. In addition, the Plan permits participants age 50 or older to make “catch-up” contributions in accordance with special IRC limits. No matching contributions are made by the League Office. Rollovers from other qualified plans and individual retirement accounts are permitted by the Plan.

Participant Accounts - Individual accounts are maintained for each Plan participant. Each participant’s account is credited with the participant’s contributions, rollovers, and an allocation of investment earnings or losses, and charged with withdrawals. Earnings or losses are allocated based on the percentage of an individual account balance to all account balances and are allocated by specific funds

on a monthly basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are fully vested immediately in their salary deferral and rollover contributions, plus actual earnings thereon. In effect, the value of each participant account shall be fully vested and nonforfeitable at all times.

Investments - Participants may direct the investment of their contributions into various investment options offered by the Plan, including one money market fund and units of the Trust and may change investments and transfer amounts between funds. The Trust owns twenty-one separately managed accounts which are investment options for participants. The separately managed accounts are privately offered only to participants in this Plan. All of the investments are held by the NFL Reciprocal Trust.

Benefits - A participant may elect to withdraw funds from his or her account during his or her employment, subject to certain conditions, as noted under withdrawals. Upon retirement or disability, the participant may receive a lump-sum distribution of the full value of his or her account, or the distribution may be deferred, subject to certain conditions. Upon termination of service due to death, the participant's beneficiary will receive a lump-sum distribution of the full value of his or her account.

Withdrawals - In accordance with Plan provisions, participants may not make withdrawals from their salary deferral account prior to reaching age 59 ½, except in the event of termination or a proven financial hardship as defined by the Plan.

Notes Receivable from Participants - Participants may request loans in accordance with the Plan. Generally, participants may borrow up to 50% of their account balance up to a maximum of \$50,000. The minimum loan amount is \$1,000. Participants may have only one outstanding loan at a time and may not apply for a new loan until at least twelve months after the date of the last loan application. Only active employees may apply for a loan. Loans will be withdrawn from investment funds on a pro rata basis. Repayments of principal and interest will be invested consistent with the participant's current salary deferral contributions.

The interest rate on loans is the prime rate on the first business day of the month in which a participant's loan application is received. The interest rate is set for the term of the loan. Loans are made for fixed terms and cannot exceed five years for personal loans and up to ten years for loans related to the purchase of a principal home and are repaid via payroll deduction only, except as defined in the Plan. Upon termination of employment or of the Plan or upon default on a payment, a participant's loan must be repaid in full or delinquent participant loans are recorded as distributions based on the terms of the Plan document.

As of December 31, 2024, notes receivable from participants had maturity dates ranging from 2025 to 2033. As of December 31, 2024, notes receivable from participants had interest rates ranging from 3.25% to 8.50%.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting - The accompanying financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America (“US GAAP”).

Use of Estimates - The preparation of financial statements in conformity with US GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties - The Plan owns units of the Trust and money market fund. The Trust owns various investments in equity and other securities through its separately managed accounts. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk and overall market risk and volatility. Market risk includes the impact of global pandemics and international conflicts. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the value of the participants’ account balances and amounts reported in the financial statements. The Plan's exposure to a concentration of credit risk is dependent upon the investments selected by participants. These risks and uncertainties could impact the participants' account balances and the amounts reported in the financial statements.

Investment Valuation and Income Recognition - The Plan’s investments are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion on fair value measurements.

Purchases and sales of the money market fund and securities held by the Trust are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Net appreciation (depreciation) in fair value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Delinquent participant loans are recorded as distributions based on the terms of the Plan document.

Administrative Expenses - The expenses of administering the Plan are paid by the League Office. Investment related fees are reflected in net appreciation (depreciation) in fair value of investments.

Payment of Benefits - Benefit payments are recorded when paid. There were no amounts allocated to participants who had withdrawn from the Plan but had not been paid as of December 31, 2024 and 2023.

Contributions - Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation.

Excess Contributions Payable - Employee contributions are recorded when withheld. The Plan is required to return contributions received during the Plan year in excess of certain IRC limits. As of December 31, 2024 and 2023, the Plan did not record any excess contributions payable to participants.

3. FAIR VALUE MEASUREMENTS

Accounting Standards Codification (“ASC”) 820, *Fair Value Measurement*, provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation approaches used to measure fair value, as follows: Level 1, which refers to securities valued using unadjusted quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

Asset Valuation Approaches - Valuation approaches maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation approaches used for assets measured at fair value. There have been no changes in the approaches used at December 31, 2024 and 2023.

The Trust - The Plan directly invests in the Trust which files as a direct filing entity on form 5500 with the Department of Labor. The Trust is valued at net asset value (“NAV”) per unit, as a practical expedient, based on the quoted market prices of the Trust’s underlying investments. The Trust, as a common collective trust, holds separately managed accounts, which are unitized and are also stated at NAV, as a practical expedient, based on each separately managed account’s underlying investments.

Money Market Fund - Valued at the daily closing price as this mutual fund is required to publish its daily net asset value and to transact at that price. The money market mutual fund held by the Plan is open-ended mutual fund that is registered with the Securities and Exchange Commission and is deemed to be actively traded.

Transfers between Levels - The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation approaches may require the transfer of financial instruments from one fair value level to another.

The Plan assesses the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits.

4. CERTIFIED INVESTMENT INFORMATION

5. FEDERAL INCOME TAX STATUS

The Internal Revenue Service (IRS) had determined and informed the League Office by letter dated August 20, 2013, that the Plan and related trust were designed in accordance with the applicable regulations of the IRC. In December 2016, the IRS began publishing a Required Amendments List for individually designed plans which specifies changes in qualification requirements. The list is published annually and requires plans to be amended for each item on the list, as applicable, to retain its tax exempt status. The Plan has been amended since receiving the determination letter. However, the League Office believes that the Plan and the related trust is currently designed and operated in compliance with the applicable requirements of the IRC and the Plan and related trust continue to be tax-exempt. Therefore, no provision for federal income taxes has been included in the accompanying financial statements.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021. However, if a correction needs to be made, the IRS may go back indefinitely. In addition, the Plan could be open indefinitely to a Department of Labor audit.

7. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

The Plan has an investment in the Trust which is managed by the Trustee. Such investments maintained and managed by the Trustee and related transactions qualify as exempt party-in-interest transactions.

The Plan issues loans to participants which are secured by the vested balances in the participants' accounts.

Certain ongoing administrative functions of the Plan are handled by the League Office staff personnel who may also be participants in the Plan. There is no allocation of either direct or indirect League Office administrative expenses to the Plan for the years ended December 31, 2024 and 2023.

8. NONEXEMPT PARTY-IN-INTEREST TRANSACTIONS

The League Office remitted participant contributions of \$1,154 for the year ended December 31, 2023 to the Trustee later than required by the Department of Labor Regulation 2510.3-102. The Plan filed Form 5330 with the IRS and paid the required excise tax on the transactions on March 11, 2024. In addition, participant accounts were credited with the amount of investment income that would have been earned had the participant contributions been remitted on a timely basis.

9. PLAN TERMINATION

Although the League Office has no present intention to terminate the Plan, it has reserved the right to terminate the Plan subject to the provisions set forth in ERISA. Upon termination, the net assets of the Plan are to be distributed to each participant according to their vested interest.

10. SUBSEQUENT EVENTS

Management has performed its evaluation of subsequent events through September 29, 2025, the date these financial statements were available to be issued, and has determined that there were no subsequent events requiring adjustment to or disclosure in the financial statements.
