INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator Representatives of the NFL Pension Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the NFL Pension Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of March 31, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended March 31, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of March 31, 2025 and 2024, and for the year ended March 31, 2025, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter — Supplemental Schedules Required by ERISA

The supplemental schedules of assets (held at end of year) as of March 31, 2025 and reportable transactions for the year ended March 31, 2025 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTES TO FINANCIAL STATEMENTS

AS OF MARCH 31, 2025 AND 2024 AND FOR THE YEAR ENDED MARCH 31, 2025

1. ORGANIZATION, BACKGROUND, AND PLAN DESCRIPTION

The following description of the NFL Pension Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for more complete information. The more significant provisions of the Plan are as follows:

General—The National Football League (the “NFL”) League Office (the “League Office”) was established by the member clubs of the NFL (the “Member Clubs”) to administer the joint operations of the NFL and the Member Clubs, including the administration of the Plan.

The Plan is a multiple-employer defined contribution plan that provides tax-deferred savings for employees of the League Office and related entities. The Plan conforms with the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). PNC Bank (the “Trustee”) serves as trustee of the Plan.

The Plan is a member plan in the NFL Reciprocal Trust. The Plan invests in a money market fund and units of the Common Collective Trust (the “Trust”) of the NFL Reciprocal Trust. The Trust was established and is maintained for the collective investment and reinvestment of monies contributed to the plans of the Member Clubs and other NFL entities. The assets of the NFL Reciprocal Trust are maintained and sponsored by the Trustee.

Plan Administration—The Plan is administered by the League Office and the NFL Employee Benefit Committee appointed by the Commissioner of the NFL.

Eligibility—Certain employees of the League Office and related entities (the “Employer”) automatically participate in the Plan as of the first day of the month following the later of six months of service or 1,000 hours of service.

Retirement Age—The normal retirement age is 65 or the age on the fifth anniversary of the initial entry date into the Plan, whichever is later.

Contributions—Each plan year, an eligible employee receives an allocation of 10% of such participant’s annual compensation. Contributions are subject to certain Internal Revenue Code (“IRC”) limitations. Compensation includes certain elective deferrals, but does not include deferred compensation payments, payments under the NFL Long-Term Incentive Compensation Plan, and ancillary compensation, such as automobile allowances. The actual contribution is made by the Employer and is the sum of the allocations for all eligible employees less the amounts forfeited by former employees who terminated with nonvested account balances.

Benefits and Vesting—Participants who were active employees on April 1, 2007 or later are vested 20% after two years of service, 60% after three years of service, 80% after four years of service and 100% after five years of service. Participants who were not active employees on April 1, 2007 or later were vested 60% after three years of service, 80% after four years of service and 100% after five years of service.

Upon retirement or termination of employment, the vested balance in the participant's account is paid to the participant or beneficiary as a single-life annuity for unmarried participants or a qualified joint and survivor annuity for married participants, unless the participant elects an optional form of payment. The options available to the participants include a lump-sum payment, an installment plan or various types of annuities.

Participant Accounts—Individual accounts are maintained for each Plan participant. Each participant's account is credited with the contribution made on the participant's behalf and an allocation of investment income or loss. Investment income or loss amounts are allocated proportionately to participants based on their respective account balances. All investment decisions are nonparticipant-directed. However, an eligible participant, who must have attained age 55 and 10 years of service, can elect to transfer his/her balance in the participant's account into a money market fund offered by the Plan.

Death Benefits—A benefit equal to the deceased participant's vested balance is payable to the participant's named beneficiary. The entire balance, whether or not vested, is payable if the participant dies while an active employee. An additional death benefit is distributable for employees for whom life insurance was purchased prior to 1998 (Note 2) and the Plan was then amended to eliminate new insurance purchases.

Forfeitures—Forfeitures may be used to restore account balances required for rehired participants, or to reduce employer contributions. As of March 31, 2025 and 2024, all available forfeitures were used to reduce employer contributions. Forfeitures used to reduce employer contributions were \$752,246 and \$869,869, for the years ended March 31, 2025 and 2024, respectively.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting—The accompanying financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America ("US GAAP").

Use of Estimates—The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Risks and Uncertainties—The Plan owns units of the Trust and a money market fund. The Trust owns various investments. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market risk and volatility. Market risk includes global pandemics and international conflicts. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the value of the participants' account balances and amounts reported in the financial statements.

Investment Valuation and Income Recognition—The Plan's investments in the NFL Reciprocal Trust consist primarily of a money market fund, the Trust, and insurance policies. The Trust owns a unitized and separately managed account. The Plan's investments, except for the insurance policies, are stated at fair value. Fair value of a financial instrument is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion on fair value measurements.

Prior to 1998, the predecessor plan provisions enabled participants to purchase whole-life insurance policies issued by the New England Life Insurance Company. The premiums due, reduced by any

dividends received, are paid out of the Plan assets. The policies are included in the financial statements at their contract value as reported to the Plan by the Metropolitan Life Insurance Company, which merged with the New England Life Insurance Company.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year and at year end.

Payment of Benefits—Benefit payments to participants are recorded upon distribution. There were no amounts allocated to participants who had withdrawn from the Plan but had not been paid as of March 31, 2025 and 2024.

Administrative Expenses—The expenses of administering the Plan are paid by the League Office. Investment-related fees are reflected in net appreciation in fair value of investments.

Contributions Payable/Receivables—Contributions are recorded based on the calculations performed by the Employer in accordance with the requirements in Note 1. Any true-ups are recorded as a payable or receivable, as applicable.

3. FAIR VALUE MEASUREMENTS

Accounting Standards Codification (“ASC”) 820, *Fair Value Measurement* (“ASC 820”), provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation approaches used to measure fair value, as follows: Level 1, which refers to securities valued using unadjusted quoted prices from active markets for identical assets; Level 2, which refers to securities not traded on an active market but for which observable market inputs are readily available; and Level 3, which refers to securities valued based on significant unobservable inputs. Assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

Asset Valuation Approaches—Valuation approaches maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation approaches used for assets measured at fair value. There have been no changes in the approaches used at March 31, 2025 and 2024.

The Trust— The Plan directly invests in the Trust which files as a direct filing entity on form 5500 with the Department of Labor. Valued at Net Asset Value (“NAV”) per unit, as a practical expedient, based on the fair value of the respective fund's underlying investments.

Money Market Fund— Valued at the daily closing price as this mutual fund is required to publish its daily NAV and to transact at that price. The money market mutual fund held by the Plan is open-ended mutual fund that is registered with the Securities and Exchange Commission and is deemed to be actively traded.

Transfers Between Levels—The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation approaches may require the transfer of financial instruments from one fair value level to another.

The Plan assesses the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits.

6. FEDERAL INCOME TAX STATUS

The Internal Revenue Service (“IRS”) has determined and informed the League Office by letter dated July 26, 2013, that the Plan and related trust are designed in accordance with applicable sections of the IRC. In December 2016, the IRS began publishing a Required Amendments List for individually designed plans which specifies changes in qualification requirements. The list is published annually and requires plans to be amended for each item on the list, as applicable, to retain its tax exempt status. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan’s tax counsel believe that the Plan and related trust is designed and operated in compliance with the applicable requirements of the IRC and the Plan and related Trust are tax exempt. Therefore, no provision for federal income taxes has been included in the accompanying financial statements.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of March 31, 2025 and 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years ended prior to March 31, 2022. However, if a correction needs to be made, the IRS may go back indefinitely. In addition, the Plan could be open indefinitely to a Department of Labor audit.

7. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

The Plan has an investment in the Trust which is managed by the Trustee. Such investments maintained and managed by the Trustee and related transactions qualify as exempt party-in-interest transactions.

Certain ongoing administrative functions of the Plan are handled by the League Office staff personnel, including payment of certain administrative expenses. There is no allocation of either direct or indirect League Office expenses to the Plan for the year ended March 31, 2025.

During the years ended March 31, 2025 and 2024, management believes that the Plan did not enter into any prohibited transactions with parties in interest.

8. PLAN TERMINATION PROVISION

Although the League Office has no present intention to terminate the Plan, it has reserved the right to terminate the Plan subject to provisions set forth in ERISA. In the event the Plan terminates, participant account balances will be fully vested. Upon termination, the net assets of the Plan are to be distributed to each participant according to their vested interest.

9. SUBSEQUENT EVENTS

Management has performed its evaluation of subsequent events through September 29, 2025, the date these financial statements were available to be issued, and has determined that there were no subsequent events requiring adjustment to or disclosure in the financial statements.
