## INDEPENDENT AUDITOR'S REPORT

Plan Administrator and Plan Participants  
The Highlands Long Term Care Retirement Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of The Highlands Long Term Care Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits – modified cash basis as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits – modified cash basis for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Highlands Long Term Care Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of The Highlands Long Term Care Retirement Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Emphasis of Matter - Basis of Accounting***

We draw attention to Note B of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note B, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about The Highlands Long Term Care Retirement Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE A: DESCRIPTION OF PLAN

The following description of The Highlands Long Term Care Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan established to provide retirement benefits to employees of The Highlands at Pittsford, The Highlands Living Center and The Meadows at Westfall, Inc. (collectively, the “Companies” or “Plan Sponsors”). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

The Plan is a 403(b) plan covering all eligible employees of the Companies. Non-eligible employees include certain non-resident aliens who have no earned income from sources within the United States and employees who are enrolled as students, regularly attending classes offered by the Companies.

There is no minimum age for elective deferrals. An employee who is at least twenty-one and has completed one year of eligibility service during which they complete 1,000 hours of service, is eligible to receive employer contributions. Those covered by a collective bargaining agreement are no eligible to receive employer contributions.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may contribute to the Plan, the maximum contribution allowable under the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The company makes qualifying contributions in an amount equal to .5% of compensation, plus, matches 20% of a participants’ elective deferrals. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various registered investment companies and annuities as investment options for participants. Changes in investment choices and transfers among funds are made directly between participant and the custodian and may be made at any time.

Eligible compensation

Eligible compensation consists of the amount paid to employee by employer that must be reported as wages on the employee’s Form W-2, including overtime and other taxable compensation, plus the employee’s salary reduction contributions to this Plan and other benefit plans of the employer. Bonuses and commissions are excluded from eligible compensation. Compensation after employment termination is generally excluded for Plan purposes however amounts paid within 2.5 months after the termination date that meet the definition of eligible compensation will be included.

NOTE A: DESCRIPTION OF PLAN, Cont'd

Participant accounts

Each participant's account is credited with the participant's contribution and an allocation of (a) the Companies' contribution and (b) Plan earnings (losses) and is charged with an allocation of investment expenses. Allocations are based on investment earnings/(losses) or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are immediately vested in their voluntary contributions and the Companies' contributions, plus actual earnings thereon.

Revenue reimbursement

During 2024 and 2023, the Plan received reimbursements from the Plan's third-party administrator totaling \$7,952 and \$6,640, respectively. These amounts were reimbursed to the Plan after actual costs of administering the Plan were compared to actual fees paid by the Plan Sponsors to the third-party administrator, and they are included in other income in the accompanying Statements of Changes in Net Assets Available for Benefits.

Payment of benefits

A participant may withdraw any part of his or her vested account at any time after attaining age 59 ½ for elective deferrals or age 65 for employer contributions. Participants may also withdraw amounts in the event of undue financial hardship, as defined by the Plan. The participant may choose from several forms of benefit payments as described in the plan agreement.

Upon termination of service due to severance of employment if a participant's vested balance exceeds \$5,000, a participant may elect to leave their funds in the Plan, receive a lump sum amount equal to the value of their account, receive periodic installment payments, or roll their funds into another employer's tax-qualified plan. Payments of all vested amounts of \$5,000 or less are made in lump sum payments.

Plan loans and participant notes receivable

Plan loans were issued as separate contracts by TIAA as contemplated under IRC section 72(p)(5) and do not represent plan assets. Plan loans are collateralized using a participant's TIAA Traditional account balance in an amount equal to 110% of the outstanding loan balance. Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of his or her TIAA Traditional account balance subject to annuity contract and plan provisions. Loan terms range from one (1) to five (5) years in one-year increments (up to 30 years for the purchase of the participant's primary residence). Principal and interest is paid ratably by the participant to TIAA, and each payment will reduce amounts collateralized by the borrowing participant's TIAA Traditional account balance.

At December 31, 2024 and 2023 plan loans outstanding with TIAA-CREF totaled \$21,064 and \$22,129, respectively.

NOTE A: DESCRIPTION OF PLAN, Cont'd

Beginning in 2020, participants could borrow directly from the Plan in the form of notes receivable which are measured and valued at their unpaid principal balance plus any accrued but unpaid interest. Participants are permitted to borrow up to 50% of the vested balance in their plan accounts to a maximum of \$50,000. The notes are payable over terms up to five years (longer if for the purchase of a principal residence) and bear interest at a fixed rate of the higher of the Moody's Corporate Bond Yield Average for the calendar month ending two months before the loan was issued or the interest rate credited before the annuity starting date, plus 1%. Thereafter, the interest rate may change quarterly, but only if the new rate differs from the current rate by greater than 0.5%. Principal and interest payments on the notes are redeposited into the participants' accounts based on their current allocation elections.

The Plan classifies all participant notes receivable as in default if any scheduled loan repayment is not made by the end of the calendar quarter following the calendar quarter in which a payment is first missed. Defaulted loans are deemed distributed and recorded as distributions of participant notes receivable in the statement of changes in net assets available for benefits.

At December 31, 2024 and 2023, participant notes receivable due to the Plan totaled \$200,840 and \$187,577, respectively.

Excess contributions payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

Administration

The Plan is administered by the Companies and recordkeeping is maintained by TIAA. Plan assets are also held and administered by TIAA and CREF, agent for TIAA Trust, N.A. (The Trustee). The Companies make their employees aware that they are approaching eligibility in the Plan and distributes materials, the Summary Plan Description, and enrollment packet provided by TIAA. Working directly with TIAA, the participant executes all transactions relating to their 403(b) account including, but not limited to, the enrollment, contributions, investment selection, loans, and distributions.

NOTE B: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The Plan's policy is to prepare its financial statements on the modified cash basis of accounting, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America. Generally, contributions and investment earnings are recorded as received and benefits and administrative fees are recorded as paid.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on trade-date basis. Interest income is recorded on the modified cash basis. Dividends are recorded when received.

The Plan presents in the statement of changes in net assets available for benefits – modified cash basis, the net appreciation or depreciation in the fair value of its investments, which consists of the realized gains or losses and the unrealized appreciation or depreciation on those investments.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

The Plan's expenses are paid either by the Plan or the Companies, as provided by the plan document. Expenses incurred in connection with the general administration of the Plan that are paid directly by the Companies are excluded from these financial statements. Certain investment related expenses are included in net appreciation or depreciation of fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

Use of estimates in the preparation of financial statements

The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan's administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Subsequent events

The Plan has conducted an evaluation of potential subsequent events occurring after the statement of net assets available for benefits date through September 29, 2025, which is the date the financial statements are available to be issued. No subsequent events requiring disclosure were noted.

NOTE D: FAIR VALUE MEASUREMENTS

The modified cash basis of accounting establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
  
- Level 2 - Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered investment companies:* Account investments are primarily valued using market quotations or prices obtained from independent pricing sources who may employ various pricing methods to value the investments including matrix pricing.

*Pooled separate account:* Valued on the basis of the relative interest of each participating investor (including each participant) in the fair value of the underlying net assets of the pooled separate account.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E: GUARANTEED ANNUITY CONTRACTS

The plan invests in a guaranteed investment contract, TIAA Traditional Annuity. Participants who choose to allocate a portion of their contributions to the TIAA Traditional Annuity make contributions that purchase a specific guaranteed minimum amount of lifetime income based on the contractual rate schedule in effect at the time the premium is paid. The principal amount invested along with a contractually specified interest rate (generally 3%, but in some recent contracts between 1% and 3%) is guaranteed. The guaranteed annuity contracts offer the opportunity for additional interest amounts to be earned in excess of the contractually specified interest rate.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

#### NOTE F: TAX STATUS

On August 7, 2017, the Internal Revenue Service stated that the prototype adopted by the Plan, as then designed, qualifies under the applicable requirements of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the plan itself; however, the Plan administrator and the Plan's tax counsel believe that the Plan was designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The modified cash basis of accounting requires plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or other applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### NOTE G: PLAN TERMINATION

Although it has not expressed any intention to do so, the Companies have the right under the Plan to discontinue their operations at any time and to terminate the Plan subject to the provisions of ERISA.

#### NOTE H: TRANSACTIONS WITH PARTIES-IN-INTEREST

The Plan invests in shares or units of a registered investment company, retirement annuity contracts and a pooled separate account managed by TIAA and CREF, the custodians of the Plan, as defined by the Plan. Transactions in such investments qualify as party-in-interest transactions which are exempt from the prohibited transaction rules. In addition, as described in Note B, the Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party-in-interest transactions under ERISA.

#### NOTE I: RISKS AND UNCERTAINTIES

The Plan invests in various types of investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits – modified cash basis.

#### NOTE J: THE HIGHLAND'S LIVING CENTER, INC. AND THE MEADOWS AT WESTFALL, INC. CURRENT OPERATING ENVIRONMENT AND FINANCIAL CONDITION

As disclosed in their audited financial statements, as of and for the year ended December 31, 2024, one of the Plan sponsors, The Highlands Living Center, Inc. had an accumulated net deficit of (\$1,828,814), a working capital deficit of (\$2,148,099), and a deficiency of revenue over expenses of (\$2,795,226). Management continues to work to improve overall financial standing.

As disclosed in their audited financial statements, as of and for the year ended December 31, 2024, The Meadows at Westfall, Inc. had an accumulated net deficit of (\$10,000,870), a working capital deficit of (\$125,096), and a deficiency of revenue over expenses of (\$2,678,922). Management continues to work on mechanisms, including an enhancement to revenues and cost reductions to generate positive financial results in the future.
