Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the financial statements of Wet Willie's 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution.)

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion on the 2024 Financial Statements

In our opinion, based on our audit and the procedures performed as described in the Auditors' Responsibilities for the Audit of the 2024 Financial Statements section:

- the amounts and disclosures in the accompanying 2024 financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the information in the accompanying 2024 financial statements related to assets held by and certified by a qualified institution agrees to, or is derived from, in all material respects, the information prepared by and certified by an institution that management determines meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). Responsibilities of Management for the 2024 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. 1. Description of the Plan

The following description of the Wet Willie's 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, which is sponsored by Wet Willie's Management Corporation (the Company) effective January 1, 2003, and restated on January 1, 2022. The Plan covers all employees of the Company and its related eligible entities. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility

All active employees of the Company, excluding union employees and non-resident aliens with no source of income in the United States, who have completed one year of service, as defined by the Plan, and are at least 21 years of age, are eligible to participate in the Plan. Participants become eligible to participate on the first Plan entry date (either the first day of the first month or the first day of the seventh month of the Plan year) following completion of the eligibility requirements. Long-term part-time employees who met eligibility requirements under SECURE 2.0 Act of 2022 are also eligible to participate in the Plan.

Contributions

Participants may contribute a percentage of their eligible compensation, as defined in the Plan document, on a tax-deferred basis, subject to certain Internal Revenue Code (IRC) limitations. In addition, eligible Participants who have attained age 50 before the close of the Plan year are allowed to make catch-up contributions up to the maximum allowed under the IRC. Participants may also contribute amounts representing distributions from other qualified defined contribution plans or individual retirement accounts (rollovers).

The Company provides for safe harbor matching contribution equal to the sum of 100% of the amount of the Participant's elective deferral that does not exceed 3% of the Participant's compensation, plus 50% of the amount of the Participant's elective deferral that exceeds 3% of the Participant's compensation but not to exceed 5% of the Participant's compensation.

The Company may also make additional discretionary employer matching contributions or discretionary employer profit sharing contributions. Discretionary employer matching contributions amounts are based on a percentage of a Participant's elective deferrals. Discretionary employer profit sharing contributions are determined by the Company. Catch-up contributions are taken into account in applying any matching contributions under the Plan. For the year ended December 31, 2024, the Company did not make discretionary matching or profit sharing contributions.

Participant Accounts

Each Participant's account is credited with the Participant's contribution, the Company's contribution, Participant's earnings (losses) and is charged with an allocation of administrative expenses. Allocations are based on Participant account balances, deferrals or compensation. The benefit to which a Participant is entitled is the benefit that can be provided from the Participant's vested account. All contributions made to these accounts are directed by the Participant into a particular investment offered by the Plan administrator and the allocations between investments can be changed.

1. Description of the Plan (cont.)

Vesting

Participants are always 100% vested in their elective deferral contributions and in employer safe harbor matching contributions, along with any earnings thereon. Other Company elective contributions (and the earnings thereon) are vested in accordance with the following schedule:

Notes Receivable from Participants

Participants' loans are not permitted by the Plan.

Payment of Benefits

Participant accounts may be withdrawn upon retirement, death, disability, attainment of age 59½, or termination of employment, as a lump-sum or in the form of installments as specified in the Plan. On termination of service due to any other reason, the Participant may elect to receive a lump-sum or rollover to an eligible retirement plan in the amount equal to the value of the Participant's vested interest in his or her account. If a terminated Participant's vested balance is less than or equal to \$7,000, the amount may be automatically distributed in the form of rollover to an individual retirement account designated by the Company. In-service and hardship distributions are available to Participants provided certain requirements are met. In-service distributions are limited to Participants who attain age 65. Hardship distributions are limited to withdrawals from active employees pre-tax deferral balance.

Plan Expenses

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan document. Certain expenses incurred from maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are included in net appreciation or depreciation in fair value of investments. Administrative expenses paid by the Plan consist of contract administrator and brokerage fees.

Forfeitures

Forfeited account balances are utilized to reduce future Company contributions. There were no forfeitures as of December 31, 2024 and 2023, and no forfeitures were utilized during 2024.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan were prepared using the accrual basis of accounting. The Plan follows accounting standards set by the Financial Accounting Standards Board (FASB). The FASB sets accounting principles generally accepted in the United States of America (GAAP).

2. Summary of Significant Accounting Policies (cont.)

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and the disclosure of the contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The investments of the Plan are reported at fair value with the exception of the fully benefit-responsive investment contract which is valued at contract value. Contract value is the relevant measurement for that portion of the net assets available for benefits because contract value is the amount Participants would normally receive if they initiated permitted transactions under the terms of the Plan.

The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market Participants at the measurement date (the exit price).

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan Participants and the matching contributions (if applicable) from the Employer (Company) are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefit payments to Participants are recorded upon distribution.

Reclassification

Certain amounts in the prior year's financial statements have been reclassified to conform to the current year's presentation. These reclassifications had no effect on the net assets available for benefits or changes in net assets available for benefits.

3. Certified Information

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, John Hancock Life Insurance Company (U.S.A.) (John Hancock), the custodian of the Plan, has certified to the completeness and accuracy of all investments reported in the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) – Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024. Such information was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution.

4. Investment Contract with Insurance Company

The Plan holds fully benefit-responsive guaranteed investment contract with John Hancock Life Insurance Company (U.S.A.) ("John Hancock"). Contributions are maintained in John Hancock's general account and credited with interest based on a formula established by the issuer. The issuer is contractually obligated to repay principal plus compound interest earned over a defined 3, 5, or 10-year term, less any applicable contract or Participant-level recordkeeping charges, provided all contributions remain in the account until the end of the guaranteed period. Interest rates are reviewed monthly and may vary, but are not less than zero percent. The investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. There are no reserves against contract value for credit risk of the issuer or otherwise.

Certain events may limit the Plan's ability to transact at contract value, including amendments to the Plan, changes to competing investment options or equity wash provisions, bankruptcy of the Plan sponsor, or loss of tax qualification. The Plan administrator does not believe the occurrence of any such events, which would limit the Plan's ability to transact at contract value with Plan Participants, is probable.

5. Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs in which little or no market data exists (Level 3 measurements). The three levels of the fair value hierarchy under GAAP are described below:

Basis of Fair Value Measurement

Level 1 - Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

Level 2 - Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;

Level 3 - Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Pooled Separate Accounts - The fair value of the pooled separate accounts is based on the net asset value (NAV) of each account calculated based on the NAV of the underlying investments. The NAV is used as a practical expedient to estimate fair value.

The methodology described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methodology are appropriate and consistent with other market Participants, the use of different methodology or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Fair Value Measurement (cont.)

The Plan's investments as of December 31, 2024 and 2023 are made up entirely of pooled separate accounts, which are measured at the NAV as a practical expedient. In accordance with GAAP, certain investments that were measured as such are not classified in the fair value hierarchy. The Plan has no assets at December 31, 2024 and 2023, that are classified in the fair value hierarchy.

6. Tax Status

The Plan has adopted a Non-Standardized Pre-Approved Profit Sharing Plan with CODA (Pre-Approved Plan) sponsored by Retirement Plan Administrators LLC. The Internal Revenue Service (IRS) has opined and informed Retirement Plan Administrators LLC by a letter dated November 30, 2020, stating that the form of the Pre-Approved Plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the Pre-Approved Plan document, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Related Parties and Party-In-Interest Transactions

Plan investments are managed by John Hancock. Usual and customary fees were paid for investment management and recordkeeping services to John Hancock. These transactions, as defined by the Plan, qualify as party-in-interest transactions. Such transactions are exempt from the prohibited transaction rules.

8. Plan Termination

Although it has not expressed an intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of such termination of the Plan, affected Participants would become 100% vested in their accounts.

9. Risks, Uncertainties, and Concentrations

The Plan's investments include funds which invest in various types of investment securities and in various companies within various markets. Investment securities are exposed to several risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statements of net assets available for benefits.

At December 31, 2024, approximately 32 percent of the Plan's investments were invested in the John Hancock USA American Funds Balanced Fund.

10. SECURE 2.0 Act of 2022

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements.

11. Subsequent Events

The Plan has evaluated, for consideration of recognition or disclosure, subsequent events that have occurred through the date of issuance, September 25, 2025, and has determined that no significant events occurred after December 31, 2024, but prior to the issuance of these financial statements, that would have a material impact on these financial statements.


