Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of PCNA 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in assets available for benefits for the years then ended, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF THE PLAN

The following description of the PCNA 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General - The Plan, established effective January 1, 1993, and most recently amended and restated on January 1, 2022, is a defined contribution plan which covers substantially all non-union employees of Leedsworld, Inc. (the "Sponsor") and the following related employers (collectively, the "Company"):

- Bullet Line, LLC
- Timeplanner Calendars, Inc.
- ETS Express, LLC
- Spoke Custom Products, LLC (effective August 10, 2022)

The Plan is qualified under Section 401(k) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility - Employees become eligible to participate in the Plan beginning on the first day of the payroll period subsequent to completing three months of service. Employees must attain the age of 18 to become eligible to participate in the Plan. The plan entry date is the first day of the first month subsequent to the date that the employee meets the eligibility requirements.

Participant Contributions - Participants may elect to contribute up to 75% of their pre-tax or post-tax compensation subject to certain limitations under the IRC. The Plan allows for participants who are age 50 or older to make catch-up contributions based on limits established by the IRC and also accepts rollover contributions for eligible employees from other qualified plans.

The Plan's automatic enrollment provision provides for an initial 3% pre-tax deferral for certain groups of eligible employees, as defined in the plan document, which increases by 1% each year until a maximum deferral of 15% is met or an affirmative election is made. If eligible employees who are subject to the automatic enrollment do not submit an automatic enrollment waiver or elect a deferral rate they are automatically enrolled in the Plan.

Employer Contributions - The Plan provides for an employer funded safe harbor matching contribution equal to 100% of the first 3% of eligible compensation contributed as an elective deferral and 50% of the next 2% of eligible compensation contributed as an elective deferral.

The Plan also provides for an annual discretionary nonelective profit sharing contribution. The participant's share is allocated to their account based on the ratio of the individual's compensation to total compensation of all eligible participants. Any participant who is employed on the last day of the plan year is eligible to receive the discretionary profit sharing contribution. There were no discretionary nonelective profit sharing contributions for the year ended December 31, 2024 or 2023.

Participant Accounts - Each participant's account is credited with the employee and applicable employer contributions and an allocation of the Plan's earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options - Participants may direct their contributions and employer contributions into various investment options and may change their investment options at any time.

Risks and Uncertainties - The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of assets available for benefits.

Vesting - Participants are immediately vested in their contributions and employer safe harbor matching contributions plus actual earnings thereon. The discretionary nonelective profit sharing contributions vest according to the following schedule:

<u>Years of Service</u>	<u>Percentage</u>
Less than 1	0%
1 but less than 2	20%
2 but less than 3	40%
3 or more	100%

Forfeitures - Forfeited balances of terminated participants' non-vested accounts may be applied to administrative fees or to reduce the employer's contributions to the Plan, as defined in the plan document. Forfeitures of approximately \$28,000 and \$17,000 were applied to administrative fees during the years ended December 31, 2024 and 2023, respectively. Forfeited non-vested accounts totaled \$7,000 and \$31,000 at December 31, 2024 and 2023, respectively.

Payment of Benefits - On termination of service due to death, disability, or normal retirement, participants may elect to receive the value of their benefits in a lump-sum distribution or installments. Terminated employees will receive a lump-sum distribution if their account balance is less than \$1,000. If their account balance is more than \$1,000, the

participant must consent to receive a lump-sum distribution. A participant may request a withdrawal from their account based upon financial hardship or at age 59 1/2, as defined by IRC regulations.

Notes Receivable from Participants - Participants are able to borrow up to the lesser of 50% of their vested account balance or \$50,000. The loans are secured by the balance in the participant's account and bear interest at rates determined by the plan administrator. Interest rates on outstanding loans at December 31, 2024 and 2023 ranged from 4.25% to 9.50%. Repayment is required within five years or within a reasonable period of time not to exceed ten years if the loan is for a primary residence. Principal and interest are paid through regular payroll deductions.

Administrative Expenses - The Plan's expenses are paid by the Company or the Plan as provided by the plan document.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The Plan's financial statements are prepared under the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates - The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in assets and liabilities at the dates of the financial statements. Actual results could differ from these estimates.

Investment Valuation and Income Recognition - Except for the common collective trust described in Note 3, the Plan's investments are stated at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividend income is recorded on the ex-dividend date.

U.S. GAAP establishes a framework for measuring the fair value of financial assets which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs are not quoted prices in active markets but they are observable either directly or indirectly; and
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds: Valued using the net asset value (NAV) provided by the administrator of the fund on the last day of the Plan's year end using a quoted price in an active market (level 1 measurement).

Collective Investment Trusts (Great Gray Mid Cap Growth and Balanced Sustainable Fund): The trusts are invested in mutual funds and bonds, which are valued using publicly quoted pricing inputs. The fair value of the underlying investments is used to determine the NAV of the trust. The NAV is not publicly quoted but is available to current investors. The NAV is the basis for current transactions, and the trust can be redeemed at NAV as of the measurement date. Therefore, the trust has a readily determinable fair value (level 1 measurement).

Collective Investment Trust (Great Gray Stable Value Fund): The trust is invested in the Putnam Stable Value Fund. The fair value of the underlying investment is used to determine the NAV of the trust. The NAV is not publicly quoted but is available to current investors and is the basis for current transactions. Therefore, the fund has a readily determinable fair value (level 1 measurement). Were the Plan to initiate a full redemption of this fund, the issuer reserves the right to temporarily delay withdrawal from this fund in order to ensure that securities' liquidations will be carried out in an orderly business manner.

The methods described above may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements at the reporting dates.

Net Change in Fair Value of Investments - The Plan presents the net appreciation (depreciation) in the fair value of its investments, which consists of the realized gains (losses) and the net unrealized appreciation (depreciation) on those investments in the statements of changes in assets available for benefits.

Notes Receivable From Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest.

Contributions - Participant and employer safe harbor matching contributions to the Plan are recorded in the period during which the Company makes payroll deductions from the participant's earnings. Employer nonelective profit sharing contributions are recorded in the period earned.

Employee and employer contributions to the Plan are subject to certain statutory limits established by the Internal Revenue Code.

Benefits - Benefits are reflected when they have been approved for payment and are paid by the Plan.

Subsequent Events - Management has evaluated subsequent events through October 2, 2025, the date which the financial statements were available to be issued.

3. COMMON COLLECTIVE TRUST

The Plan held a fully benefit responsive common collective trust with Fidelity Management Trust Company (Stable Value Fund), which maintained the contributions in a general account. The account was credited with interest at guaranteed rates that were declared quarterly. Fidelity Management Trust Company was contractually obligated to repay the principal and accrued interest.

Because the common collective trust is fully benefit responsive, contract value is the relevant measurement attribute for that portion of the assets available for benefits attributable to the common collective trust. Contract value, as reported to the Plan by Fidelity Management Trust Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limited the Plan's ability to transact at contract value with Fidelity Management Trust Company. Such events included the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator did not believe that any events that would limit the Plan's ability to transact at contract value with participants were probable of occurring.

The common collective trust did not permit Fidelity Management Trust Company to terminate the agreement prior to the scheduled maturity date. In November 2023, the Plan exercised a 12-month put option on the stable value fund with the intent to exit the fund and replace it with another investment option. Effective October 31, 2024, the Plan replaced the stable value fund with another stable value fund option offered by Fidelity Management Trust Company (see Note 2).

4. PLAN TERMINATION

Although it has not expressed any intention to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their accounts.

5. INCOME TAX STATUS

The Plan operates under an adoption agreement in connection with a non-standardized pre-approved profit sharing plan from Fidelity Management Trust Company. The Internal Revenue Service has stated in a letter dated June 30, 2020 that the Plan, as then designed, was in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Management believes that there is no liability related to uncertain tax positions at December 31, 2024 or 2023. The Plan is no longer subject to U.S. federal or state income tax examinations by tax authorities for tax years before 2021.

6. CERTIFIED FINANCIAL INFORMATION

Fidelity Management Trust Company, the trustee, has certified that the following data included in the accompanying financial statements is complete and accurate:

- Investments and notes receivable from participants, as shown in the statements of assets available for benefits as of December 31, 2024 and 2023.
- Investment activity and interest income on notes receivable from participants, as shown in the statements of changes in assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information included in the schedule of assets held for investment purposes at December 31, 2024, as shown on the accompanying schedule.

7. RELATED PARTIES AND PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are managed by the trustee. Additionally, the Plan paid certain administrative fees for trustee and recordkeeping services. Fees paid by the Plan for trustee and recordkeeping services were not significant for the years ended December 31, 2024 or 2023. These transactions are not, however, considered prohibited transactions under Section 408(b) of ERISA regulations.

Neither the Sponsor nor employees of the Sponsor involved in the administration of the Plan receive any compensation from the Plan.
