Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of the Eichelberger Farms, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audits"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Notes to Financial Statements**December 31, 2024 and 2023****1. Summary of Significant Plan Provisions**

The following description of the Eichelberger Farms, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

- a. **General** – The Plan is a defined contribution plan for the benefit of eligible employees of Eichelberger Farms, Inc. and related adopting employers (collectively, the “Employer”). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.
- b. **Eligibility** – Employees, except union employees, leased employees, or nonresident aliens, are eligible to participate in the Plan at the next entry date after attaining the age of 18 and completing one year of service. Entry dates are the first day of the Plan quarter coinciding with or immediately following the date the participant meets the eligibility requirements.
- c. **Contributions** – Participants may contribute to the Plan through payroll deductions and rollover contributions. The Plan has an Eligible Automatic Contribution Arrangement in which eligible employees will automatically enter the Plan at a deferral rate of 4% of compensation for each payroll period, unless the participant makes an affirmative election to defer a different percentage. The Employer will make a safe harbor matching contribution of 100% of the participant’s elective deferrals that do not exceed 4% of the participant’s compensation. The Employer may also make other discretionary contributions. No such discretionary contributions were made during 2024. The Plan contains provisions as to the maximum annual additions that can be made to a participant’s account.
- d. **Participant accounts** – Each participant’s account is credited with the participant’s and Employer contributions and allocations of Plan earnings/losses, and is charged with applicable withdrawals and an allocation of administrative expenses. Allocations are based on participant’s earnings, contributions, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- e. **Vesting rights** – Participants are immediately vested in participant contributions, Employer discretionary contributions, and their Employer matching contributions plus earnings/losses thereon.
- f. **Investment options** – Upon enrollment in the Plan, a participant may direct the investment of their account to any of the investment options offered under the Plan. Participants may change their investment selections at any time.
- g. **Notes receivable from participants** – Participants may borrow from their Plan accounts in amounts ranging from a minimum of \$1,000 up to a maximum amount of the lesser of 50% of the participant’s vested account balance or \$50,000 reduced in accordance with the Plan agreement. The notes are secured by the participant’s account and bear interest at a rate commensurate with local prevailing borrowing rates, as determined by the Plan administrator. Note terms may not exceed five years unless the note is for the purchase of a primary residence for which the note term can be extended to a reasonable amount of time beyond five years. Principal and interest are paid through payroll deductions.

- h. **Benefits** – Upon termination of service, a participant or beneficiary may elect to receive a lump sum distribution. Participants may elect upon termination of employment to defer payment of their account balance if it exceeds \$5,000. If a participant’s account balance is equal to or less than \$5,000, the account will be automatically distributed. In-service withdrawals are available from the accounts designated in the Plan document to participants who attain age 59½ or meet certain hardship requirements.
- i. **Termination of the Plan** – Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

2. Summary of Significant Accounting Policies

- a. **Basis of accounting** – The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).
- b. **Estimates** – The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.
- c. **Investment valuation and income recognition** – Investments are reported at fair value, except for the fully benefit-responsive investment contract as disclosed in Note 3. See Note 5 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Net change in value of investments includes the Plan’s gains and losses on investments bought and sold, as well as held during the year.

- d. **Notes receivable from participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan documents.
- e. **Payment of benefits** – Benefits are recorded when paid.
- f. **Administrative expenses** – Fees related to loans and distributions are charged directly to the participants’ accounts. Administrative expenses paid by the Plan are allocated to participants’ accounts. Any administrative expenses paid by the Employer are excluded from these financial statements.

3. **Fully Benefit-Responsive Investment Contract**

The Plan has entered into a fully benefit-responsive guaranteed investment contract (“GIC”) with Transamerica Life Insurance Company (“Transamerica”). Transamerica maintains the contributions in a general account. The account is credited with earnings on the underlying investment and charged for participant withdrawals and administrative expenses. Transamerica is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The actual crediting rate is established by Transamerica semiannually.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Transamerica, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all, or a portion of, their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include termination of the contract or termination of the Plan. The Plan’s management does not believe the occurrence of any such event, which would limit the Plan’s ability to transact at contract value with participants, is probable.

4. **Investments**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by Transamerica, custodian of the Plan, and was not subjected to any audit procedures, except for comparing the information with the related information included in the financial statements and supplemental schedule:

- a. Total investments as shown on the accompanying statement of net assets available for benefits of \$8,015,832 and \$6,991,624 as of December 31, 2024 and 2023, respectively.
- b. Interest as shown on the accompanying statement of changes in net assets available for benefits of \$1,456 (excluding \$9,452 from participant loans) for the year ended December 31, 2024.
- c. Net change in value of investments as shown on the accompanying statement of changes in net assets available for benefits of \$1,074,046 for the year ended December 31, 2024.

- d. All investment transactions that occurred during the year ended December 31, 2024.
- e. All information included in the supplemental schedule, excluding participant loans.

The Plan provides for investments in various investment securities which, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Further, due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

5. Fair Value Measurements

The following is a description of the valuation methodology used for assets measured at fair value.

Pooled separate accounts: These investments are valued based on the net asset value (“NAV”) of the pooled separate account multiplied by the number of shares held by the Plan at year-end. The NAV is determined based on the fair value of the underlying investments, adjusted for expenses. The NAV is used as a practical expedient to estimate fair value.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. Tax Status

The Plan is utilizing a non-standardized pre-approved profit sharing plan document (the “Plan Document”), which received an opinion letter dated June 30, 2020, in which the Internal Revenue Service (“IRS”) stated the Plan Document is designed in accordance with the applicable sections of the Internal Revenue Code (“IRC”). As allowed by the IRS, the Plan is relying on the opinion letter of the Plan Document for its own qualification. Although the Plan Document has been amended since receiving the opinion letter, the Plan administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

6. Tax Status (cont.)

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Parties-in-Interest Transactions

The Plan is invested in pooled separate accounts and a GIC with Transamerica. The Plan pays Transamerica for its services. Inasmuch as Transamerica serves as custodian of the Plan, it is by definition a party-in-interest and, as a result, pooled separate accounts, the GIC, and all transactions pertaining to these investments were with a party-in-interest. Accel Wealth Management, LLC (“Accel Wealth”) serves as investment advisor to the Plan and is, therefore, a party-in-interest. The Plan pays Accel Wealth for its services. The Retirement Advantage, Inc. (“TRA”) serves as third-party administrator to the Plan and is, therefore, a party-in-interest. The Plan pays TRA for its services. The Plan also holds notes receivable from participants. As a result, these notes receivable from participants and all related transactions were with parties-in-interest. All of these transactions are exempt from being prohibited transactions by ERISA.
