The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

Their report dated July 18, 2024 indicated that in their opinion (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). NOTE A – DESCRIPTION OF PLAN

The following description of the Bell Nursery USA, LLC 401(k) Plan (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan established by Bell Nursery USA, LLC (“the Company”) effective April 26, 2007, for employees of Bell Nursery USA, LLC. Effective January 1, 2021, eligible employees as part of Hopewell Nursery, Inc. acquisition were accepted into the Plan. The Plan covers all employees who complete 1,000 hours of service within a twelve consecutive month eligibility computation period at the Company and are age twenty-one or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The enrollment period to start contributing to the plan is twice a year, on January 1 and July 1.

Contributions

Each year, as defined by the Plan, participants may contribute the lesser of 100% of their compensation or the annual dollar limit to their pre-tax or Roth salary deferral contributions. The annual dollar limit in effect for years 2024 and 2023 are \$23,000 and \$22,500 respectively. Any calendar year in which a participant has reached (or will reach) at least age 50, a catch-up contribution of \$7,500 may be made for years 2024 and 2023. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes a matching safe harbor contribution to the Plan. If the participant makes an elective deferral during the plan year and is an eligible employee on the last day of the plan year, the participant will be eligible for the plan year to receive an allocation of matching contributions. The amount of the safe harbor matching contribution will vary depending upon the percentage of the participant’s compensation that is contributed to the Plan as a deferral. If the participant’s contribution is between 1% and 3% of their compensation, the Company will make a safe harbor matching contribution of 100% of these deferrals. For any contribution greater than 3%, but less than 5% of the participant’s compensation, the Company will match 50% of these deferrals. The Company may also make non-elective contributions. These contributions are totally discretionary and set by the employer. The employer safe harbor matching contributions to the plan were \$669,907 and \$605,080 in 2024 and 2023, respectively.

NOTE A – DESCRIPTION OF PLAN (CONTINUED)

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Plan earnings and charged with an allocation of administrative expenses when paid from the Plan assets. Allocations are based either on a pro-rata basis or on an equal-dollar basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Contributions to the Plan are invested by the Trustee in various investment funds, according to participant instructions. The plan administrator provides participants with current copies of the prospectus describing each investment option.

Vesting

Participants are immediately vested in their salary deferral contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contributions portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

Payment of Benefits

After a participant leaves the Company due to any reason (death, disability, termination, or retirement), the participant may elect to receive his or her vested benefit in a single lump sum or have the payment paid as a "direct rollover" to an individual retirement account (IRA) or to another employer's tax qualified plan.

Forfeitures

Forfeitures resulting from terminated non-vested participants are used by the employer to pay plan administrative expenses of the Plan and/or to restore previously forfeited balances. Forfeitures not used for these purposes at the election of the administrator, may be used to reduce employer contributions. During 2024 and 2023, there were no forfeited non-vested amounts.

NOTE A – DESCRIPTION OF THE PLAN (CONTINUED)

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the balance in the participant's account and bear interest at rates determined by the plan. Principal and interest are paid ratably through monthly payroll deductions.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Date of Management's Review of Subsequent Events

Subsequent events were evaluated through August 31, 2025, which is the date the financial statements were available to be issued.

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Operating Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Payments of Benefits

Benefits are recorded when paid.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Quoted market prices are used to value investments. Shares of mutual funds are valued at quoted market prices which represent the net asset value of shares held by the Plan at year end. The net appreciation (depreciation) in fair value of investments has been reported as the change between the current market value and the market value at the time of purchase.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

NOTE C – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants are 100% vested as provided in the Plan documents.

NOTE D – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE E – TAX STATUS

The Internal Revenue Service has ruled that the Plan qualifies under Section 401(a) of the Internal Revenue Code (“IRC”). The Plan was established April 26, 2007, using the AccuDraft Volume Submitter Profit Sharing 401(K) Plan document which has been approved by the Internal Revenue Service, and it is currently operating in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

NOTE F – FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year end. The fair values of common stocks, corporate stocks, and U.S. Government securities are based on the closing price reported on the active market where the individual securities are traded.

NOTE G – RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

Ascensus Trust Company is the trustee of the Plan. As a result, Ascensus Trust Company qualifies as a party in interest to the Plan with respect to transactions related to these funds. The fair market value of the funds managed by Ascensus Trust Company totaled \$19,261,350 and \$15,906,264 for the years ended December 31, 2024 and 2023.

Fees paid by the Plan for investment management services amounted to \$68,790 and \$58,500 for the years ended December 31, 2024 and 2023, respectively.

NOTE H – INFORMATION CERTIFIED BY THE TRUSTEE (UNAUDITED)

At December 31, 2024 and 2023, the Plan’s investments were held by Ascensus Trust Company (“the Trustee”). The following is a summary of the Plan’s financial information that is included in the financial statements based on information certified by the Custodian as complete and accurate in accordance with 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.
