### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of Solomon Colors, Inc. Salary Deferral Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution, American Trust Company, as of and for the year ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

### **Basis for Opinion**

**Notes to the Financial Statements**  
December 31, 2024

**1. Description of Plan**

The following description of the Solomon Colors, Inc. Salary Deferral Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

*General* – The Plan is a defined contribution plan covering eligible employees of Solomon Colors, Inc. (Company), who have three months of service and have attained age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*Plan Amendment and Restatement* – During 2024, the Plan was retroactively restated and amended, effective January 1, 2022, to remove the automatic escalation of the salary reduction agreement amount feature.

*Contributions* – Each year, participants may elect to defer a portion of their compensation, as defined by the Plan. Current employees may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, a collective investment fund, and a common collective trust as investment options for participants. The Plan also offers a Progressive Savings Program, which allows participants to automatically increase their deferral percentages by a set percentage each year on May 1. The maximum contribution to the Plan in any year is determined by provisions in the Plan and the Internal Revenue Code (IRC) and Income Tax Regulations.

The Plan requires the Company to make a Safe Harbor matching contribution equal to 100 percent of the first 3 percent of compensation that a participant contributes to the Plan and 50 percent of the next 2 percent of compensation that a participant contributes to the Plan. The Company may also make an additional matching or profit-sharing contribution at the discretion of the Company's management. The determination period for the contribution is based on each plan year. For the year ended December 31, 2024, the Company did not elect to make an additional matching or profit-sharing contribution.

*Participant Accounts* – Each participant's account is credited with the participant's contribution, if any, and allocations of (a) the Company's contribution, (b) forfeitures, (c) administrative expenses, and (d) plan earnings, net of investment fees. Allocations are based on participant earnings, account balances, or other participant events, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Vesting* – Participants are vested immediately in their contributions plus actual earnings thereon. Participants are also vested immediately in any employer Safe Harbor contribution. Vesting of employer non-Safe Harbor contributions is based on years of service and a participant is 100 percent vested in these contributions after five years of credited service.

*Payment of Benefits* – On termination of service, distributions under the Plan may be made in lump-sums, substantially equal installments, or partial withdrawals, provided the minimum withdrawal is \$1,000. The Plan provides for an automatic lump sum distribution of account balances of \$5,000 or less. The Plan also allows for financial hardship withdrawals of all or part of the participant’s deferral contributions, if the participant can prove financial hardship and is unable to meet their financial needs another way. The Plan allows for in-service distributions from all fully vested account balances if the participant has attained age 59 ½.

*Forfeited Accounts* – Forfeited amounts are allocated to participant accounts as an additional employer contribution or used to pay plan expenses. The Plan had no forfeitures at December 31, 2024 and 2023, and no forfeitures were allocated to participant accounts in 2024.

*Notes Receivable from Participants* – Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 (reduced by the excess, if any, of the participant’s highest outstanding note balance during the one-year period ending on the day before the date on which such note is made over the participant’s outstanding balance of notes on the date such note was made) or 50 percent of the participant’s vested balance. The minimum amount of a loan shall be \$1,000. Note terms range from 1 to 5 years and up to 30 years for the purchase of a primary residence. The notes are secured by the vested balance in the participant’s account and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

## **2. Summary of Significant Accounting Policies**

*Basis of Accounting* – The financial statements of the Plan are prepared on the accrual basis of accounting.

*Use of Estimates* – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

*Investment Valuation and Income Recognition* – The Plan’s investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sale of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Notes Receivable from Participants* – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

*Investment and Administrative Expenses* – The Plan’s expenses are paid either by the Plan or the employer, as provided by the Plan document. Expenses paid directly by the employer are excluded from these financial statements. Certain fees are charged to the Plan for services provided by the investment custodian of the Plan and are netted with investment earnings.

*Payment of Benefits* – Benefits are recorded when paid for financial statement purposes.

*Subsequent Events* – The Plan has evaluated subsequent events through September 19, 2025, the date on which the financial statements were available to be issued.

### 3. Information Certified by American Trust Company, the Investment Custodian

Certain information, as noted below, related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule including investments and notes receivable from participants held at December 31, 2024 and 2023, net appreciation in fair value of investments, interest and dividend income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agree to or derived from information certified as complete and accurate by American Trust Company.

### 4. Fair Value Measurements

The Financial Accounting Standard Board (FASB) Accounting Standards Codification (ASC) 820-10 establishes a framework for measuring fair value under generally accepted accounting principles. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10 are described below:

Level 1 Inputs to the valuation methodology are based on unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodologies used at December 31, 2024.

The following is a description of the valuation methodologies used for assets measured at fair value:

- *Mutual Funds*: Shares of mutual funds are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end.
- *Collective Investment Fund*: The fund is a collective investment of assets contributed from employee benefit plans maintained by more than one plan that is invested in a variety of qualified investment vehicles. The fund is priced daily. The assets of the fund consist of exchange traded securities whose net asset values are aggregated and combined with stated fees through these procedures to arrive at the fair market value.
- *Common Collective Trust (CCT)*: The UTC Stable Value Trust held by the Plan is a collective investment trust that invests in a fully benefit responsive group annuity contract with MetLife. The contract consists of the units of the MetLife separate accounts and an insurance wrapper that guarantees plan participants can transact at contract value in perpetuity. Withdrawals resulting from an employer or plan sponsor-initiated event (e.g. a decision to terminate the Plan's participation in the trust) could result in a payment less than the guaranteed value if the contract's market value is less than the guaranteed value. An event limiting the ability of plan participants is not considered probable of occurring.

Management has determined the CCT qualifies for the net asset value practical expedient under FASB ASC 820, and, as such, the CCT is not categorized in the fair value hierarchy.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. Administrative Expenses and Party-In-Interest Transactions**

A transaction with certain service providers to the Plan qualifies as a party-in-interest transaction. Service provider fees, either directly or indirectly, are paid by American Trust Company, the investment custodian, investment advisor, record keeper, and third-party administrator. Of these fees, \$40,703 is included in administrative expenses on Exhibit B. Other investment fees are netted with investment earnings. Certain expenses incurred in the administration of the Plan were also paid by the plan sponsor.

Additionally, certain plan investments are both held and managed by the investment custodian.

Notes receivable from participants are both party-in-interest and a related-party transaction.

**6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their employer contributions.

**7. Tax Status**

On June 30, 2020, the Internal Revenue Service stated that the pre-approved plan adopted by the Plan, as then designed, was in compliance with the applicable sections of the Internal Revenue Code (IRC). The plan administrator and the prototype provider believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore, believe that the Plan is qualified, and the related trust is tax-exempt. As such, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
