To management and the plan administrator of

### **Opinion**

We have audited the accompanying financial statements of JDS Industries, Inc. Employee Stock Ownership Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Plan as of December 31, 2024, and the changes in its net assets available for benefits for the year then ended, in accordance with accounting principles generally accepted in the United States of America.

### **Basis for Opinion**

### 1. Plan Description:

The following brief description of the JDS Industries, Inc. Employee Stock Ownership Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan agreement for complete information.

JDS Industries, Inc. (the Company) established a profit-sharing plan for the benefit of its employees, effective as of January 1, 2024. That plan was converted, amended, and restated into the JDS Industries, Inc. Employee Stock Ownership Plan (the Plan), effective December 18, 2024. The Plan is administered by an independent third-party trustee appointed by JDS Industries, Inc.'s board of directors.

Eligibility: Employees of the Company are generally eligible to participate in the Plan as of January 1 of the Plan year in which they complete 1,000 hours of service and have attained the age of 21. Participants who do not have at least 1,000 hours of service during such plan year or are not employed on the last working day of a Plan year are generally not eligible for an allocation of Company contributions for such year. Employees covered by a union contract, non-resident aliens whose only income is from other than U.S. sources, and leased employees are excluded.

Entry Date: Employees may participate in the Plan on the first day of the plan year in which they satisfy the eligibility requirements.

Contributions: Non-elective discretionary amounts may be contributed at the option of the Company's Board of Directors. Allocation of the non-elective discretionary employer contribution is allocated to eligible participants in the ratio that their compensation for the plan year bears to the compensation for the plan year of all eligible participants. Employer contributions may be in the form of employer stock or cash. Employees are not permitted to make contributions. During the year ended December 31, 2024, the Company made a discretionary contribution of 1,000,000 shares of Company common stock.

Payment of Benefits: No distributions from the Plan will be made unless a participant retires (age 65 or older), becomes disabled, dies (in which case, payment shall be made to his or her beneficiary or, if none, his or her legal representatives), terminates employment with the Company, or is required to receive required minimum distributions.

Distributions due to retirement, disability and death may commence in the year following termination. Distributions for terminations due to other reasons commence in the year following the fifth anniversary of termination.

Distributions may be made in cash or employer stock. If employer stock is distributed, it must be sold back to the Company or the Plan at the current appraised value.

Distributions are generally made in a single lump sum if the vested account balance is \$10,000 or less. For vested account balances greater than \$10,000, distributions are generally made in up to five annual installments.

Payment of Benefits: (continued) A terminated participant with a vested balance of less than \$1,000 may be automatically paid out by the Plan upon termination. Terminated participants with a vested balance between \$1,000 and \$7,000 may also be automatically paid out if their balance is rolled into a qualified individual retirement account.

Administrative Expenses: As provided in the Plan agreement, administrative expenses may be paid either by the Plan or by the Company.

Voting Rights: Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account with respect to a merger or consolidation, recapitalization, reclassification, liquidation, dissolution, or sale of substantially all of the assets of the Employer, and is notified by the Trustee prior to the time that such rights are to be exercised. The Trustee votes any allocated share for which instructions have not been given by a participant and any unallocated shares on behalf of the collective best interests of Plan participants and beneficiaries. For other corporate matters, the Trustee will vote all employer stock in the Plan.

Participant Accounts: The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each Plan year with an allocation of company contributions and forfeitures of terminated participants' nonvested accounts. Only those participants who are eligible employees of the Company as of the last day of the Plan year will receive an allocation. Allocations are based on a participant's eligible compensation, relative to total eligible compensation. Plan earnings are allocated to each participant's account based on the ratio of the participant's account balance.

Vesting: If a participant's employment with the Company ends for any reason other than retirement, disability or death, he or she will vest in the balances in his or her account based on total years of service with the Company. Participants are vested in the Company's contributions according to the following schedule:

Participants are credited with a year of service if they complete at least 1,000 hours during the Plan year. Service prior to January 1, 2024 is not considered. If a participant's employment ends due to retirement, disability or death, the participant becomes 100% vested.

### 1. Plan Description: (Continued)

Put Option: Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market or is subject to trading limitations includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. The Company can pay for the purchase with interest over a period not exceeding five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Diversification: Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a 6-year period. In each of the first 5 years, a participant may diversify up to 25 percent of the number shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50 percent. The diversified amount will be transferred to another qualified Plan of the Company. The election to diversify is made subsequent to year-end based upon the shares of employer stock in the participant's account at year-end.

Forfeitures: Plan forfeitures are allocated to each participant's accounts based upon the relation of the participant's compensation to total compensation for the Plan year. Forfeitures allocated to participants during the year ended December 31, 2024, totaled \$0. Forfeited non-vested accounts to be allocated to participants in future year as of December 31, 2024 was \$0.

Plan Termination: The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon such termination of the Plan, participants become fully vested and the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the IRC.

### 2. Summary of Significant Accounting Policies:

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in accordance with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments are stated at fair value. See Note 3 for discussion of fair value measurements.

Dividend income is accrued on the ex-dividend date.

### 2. Summary of Significant Accounting Policies: (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses from security transactions are reported on the average cost method. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefit Payments: Benefits are recorded when paid.

Subsequent Events: The Plan has evaluated subsequent events through September 29, 2025, the date the financial statements were available to be issued.

### 3. Fair Value Measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The 3 levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

### 6. Tax Status:

The Internal Revenue Service has determined and informed the Company by a letter dated September 8, 2025, that the Plan and related trust are designed in accordance with the applicable requirements of the IRC, and therefore, the related trust is exempt from taxation.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by authorities; however, there are currently no audits for any tax periods in progress.

### 7. Risks and Uncertainties:

The Plan invests primarily in the Company's common stock. Investment securities are exposed to various risks such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows, and/or other such techniques. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in the estimates and assumptions, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.
