Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Western Building Center 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Basis for Opinion

NOTE 1 – DESCRIPTION OF PLAN

The following brief description of the Western Building Center 401(k) Profit Sharing Plan (Plan) is provided for general information purpose only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of the Company who have completed a minimum of 12 months of service and are 21 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated fund until changed by the participant. Each year, the Board of Directors determines the amount of the matching contribution, if any, to be allocated to the Plan as well as the amount of the profit-sharing contribution. To qualify for a profit-sharing contribution, the participant must meet certain eligibility requirements. The profit-sharing contribution made by the Company is allocated using a pro rata formula. Under this formula the contribution is divided among all eligible plan participants based on their compensation as compared to all eligible participants' compensation.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and, (b) Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the plan. Allocations are based on participant compensation and account balance as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's profit-sharing and matching contribution is based on years of service. A participant is 100% vested after six years of credited service. A participant is fully vested upon reaching retirement age, death, or permanent disability.

Forfeited Accounts

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$19,717 and \$12,812, respectively. These accounts are periodically allocated to participants' accounts as discretionary matching contributions of the Company. During the years ended December 31, 2024 and 2023, \$11,950 and \$12,127 of forfeitures, respectively, were used to pay administrative fees of the Plan. None of the forfeited non-vested accounts were allocated to participants' accounts as discretionary matching contributions.

Payment of Benefits

Benefits are available when a qualifying event occurs, i.e. termination of employment, attainment of retirement age (59 1/2), death or financial hardship as defined by the Plan agreement. The portion of unvested plan benefits are forfeited if an employee discontinues employment before rendering six years of service. Participants or their beneficiaries may elect to receive the benefits in the form of a joint and survivor annuity, single annuity, or as a lump-sum distribution upon termination or retirement. If a vested sum is less than \$1,000 the benefit is required to be taken as a lump-sum.

Notes Receivable from Participants

The Plan permits participants to borrow from their accounts. The loans, which are approved by the Plan sponsor, are limited to the lesser of \$50,000 or one-half of the participants vested account balance. Loans, which are repaid by payroll deductions, must be repaid within five years. All loans bear a reasonable rate of interest as determined by the Administrator based on the prevailing interest rates charged by persons in the business of lending money for loans which would be made in similar circumstances.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting which is in conformity with accounting principles generally accepted in the United States of America.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is reported on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – Cont.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosures of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions (deductions) to (from) net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Investments in mutual funds are valued at the net asset value of shares held by the Plan at year-end. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. All the interest and dividends earned in the pooled separate accounts were reported in the net appreciation in fair value of the investments.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Company and therefore excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account.

Subsequent Events

Management has considered subsequent events through October 3, 2025, the date the financial statements were available to be issued and determined that none have any effect on the financial statements.

NOTE 4 – PLAN TERMINATION

Although it has not expressed intent to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, participants will become 100% vested in their accounts, including the portion related to all Company contributions and earnings thereon.

NOTE 5 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1

Inputs to valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access. The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year-end.

Level 2

Inputs to the valuation methodology include: 1) quoted prices for similar assets or liabilities in active markets, 2) quoted prices for identical or similar assets or liabilities in inactive markets, 3) inputs other than quoted prices that are observable for the asset or liability, and 4) inputs that are derived from or corroborated by observable market data by correlation or other means.

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Pooled separate accounts are valued at the net asset value (NAV) or equivalent based on units of the pooled separate accounts. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is generally based on the fair value of the underlying investments held by the pooled separate account less its liabilities. This practical expedient is not used when it is determined to be probable that the pooled separate account will sell the investment for an amount different than the reported NAV.

The Plan’s policy is to recognize transfers between levels of the fair value hierarchy at the end of the reporting period. For the years December 31, 2024 and 2023, there were no transfers between levels of the fair value hierarchy.

NOTE 6 – PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in certain pooled separate accounts (PSA’s) managed by John Hancock. John Hancock is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services for the years ended December 31, 2024 and 2023, amounted to \$39,394 and \$34,324, respectively.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 7 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 8 – TAX STATUS

The IRS has determined and informed the Company by a letter dated June 30, 2020 that the prototype Plan and related trust adopted by the Company are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the prototype Plan has been amended since receiving the determination letter the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
