Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Alter 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Note 1. Description of Plan

The following description of the Alter 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document and Summary Plan Description for a more complete description of the Plan's provisions.

Sponsoring companies: Companies participating in the Plan include:

These participating companies are hereafter referred to collectively as "the Companies".

General: The Plan is a defined contribution plan established for the benefit of the employees of those Companies participating in the Plan, who meet certain eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility: Employees of the Companies participating in the Plan who are regular nonunion full-time employees or union employees who have negotiated their participation through their labor agreement are eligible to participate in the Plan.

Contributions: Participants may elect to contribute a percentage of their salary in the form of a salary reduction not to exceed limits established by the Internal Revenue Code (IRC). The elective deferred amount may not be more than the lesser of: (a) 100% of their compensation, (b) maximum dollar limit allowed under the requirements of the IRC (\$23,000 for 2024) or (c) such lesser amount as determined by the discrimination tests for the Plan. Participants who have attained age 50 before the end of the Plan year are also eligible to make catch-up contributions. Rollover contributions by participants from another qualified plan are permitted as defined in the Plan. The Companies make a fixed matching contribution equal to 25% of the participant's voluntary salary reduction amount. The Board of Directors may also consider a discretionary matching contribution, which may either be a uniform percentage of salary deferrals or a flat dollar amount for each participant. There were no discretionary contributions during the year ended December 31, 2024.

The Plan document also includes an automatic deferral feature whereby a participant is treated as electing to defer 6% of eligible compensation unless the participant makes an affirmative election otherwise. On each January 1, all participants (excluding highly compensated employees) who have either an automatic or elective deferral amount greater than 0% and less than 10% will be subject to an automatic increase of 1% of eligible compensation until their deferral rate reaches 10% unless they elect otherwise.

Participant accounts: Each participant's account is credited with the participant's elective and, if applicable, rollover contributions and allocations of: (a) the Companies' fixed matching contributions, (b) the Companies' additional discretionary contributions, (c) administrative expenses and (d) plan earnings. Allocations are based on participant's earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Note 1. Description of Plan (Continued)

Participant investment options: Participants may direct contributions to their accounts to selected investments as made available and determined by the Plan trustees. Participants may change their investment options at any time throughout the year via direct phone access or internet access to the Plan's third-party administrator. If a participant does not designate an investment option for their contributions, all contributions to their account will be deposited into the Vanguard Target Retirement Funds.

Vesting: Participants are immediately vested in their voluntary contributions and the Companies' fixed matching contributions, plus actual earnings thereon. Vesting in the Companies' discretionary contribution portion of their accounts plus earnings thereon is based on years of continuous service which starts after two years of service at 20% and increases ratably until six years of continuous service when participants are 100% vested.

The entire amount credited to a participant's account balance becomes fully vested if any of the following occur: (a) participant attains normal or early retirement age, (b) termination of participant's employment due to total disability, or (c) participant's death.

Notes from participants: Notes from participants are measured at their unpaid principal balance plus any accrued interest. Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of the participant's vested account balance. Participants are allowed one outstanding note at a time. Note terms are up to five years or a reasonable period of time, which may exceed five years for notes used to acquire a principal residence. The notes are secured by the balance in the participant's account. The interest rate is determined at the time of the loan based on the current prime rate plus 1%. The interest rates applicable to outstanding notes as of December 31, 2024, ranged from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions and is credited to the participant's Plan account. Participants may also make principal reduction payments outside of payroll deductions.

Payments of benefits: Distributions may be made after a participant's retirement, termination of employment, death, disability, reaching age 59½ or approved hardship. Distributions are made in the form of lump-sum payments or installments over a period of time as defined in the Plan equal to the value of his or her vested account.

Forfeitures: Forfeitures are used to reduce future employer contributions in the year of forfeiture. For the 2024 plan year, \$4,496 in forfeitures were used to reduce employer contributions. At both December 31, 2024 and 2023, there was no balance in the forfeited nonvested accounts.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Notes to Financial Statements

Note 2. Summary of Significant Accounting Policies (Continued)

Contributions: Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits, and changes therein. Actual results may differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Refer to Note 5 for a discussion regarding the fully benefit-responsive contracts.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the Plan document.

Payments of benefits: Benefits are recorded when paid.

Administrative expenses: Certain administrative functions applicable to the Plan are performed by employees of the Companies. No such employees receive compensation from the Plan. Administrative expenses may be paid by the Companies or the Plan, at the Companies' discretion.

Subsequent events: The Plan Administrator has evaluated subsequent events through October 2, 2025, the date the financial statements were available to be issued. Subsequent to year end, the Plan Sponsor began working with their service providers to update the sponsoring company names, which were changed during 2024.

Note 4. Investments and Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the closing price reported on the active market on which the individual securities are traded.

Common collective trust fund: Valued based on the net asset value (NAV) of units of the common collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Note 5. Benefit-Responsive Insurance Contract

The Plan has entered into a benefit-responsive insurance contract with The Standard Insurance Company (The Standard). The Standard maintains the participant directed contributions in an account called The Standard Stable Asset Fund (the Fund). The Fund is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The insurance contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to Plan participants.

Because the insurance contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed insurance contract. Contract value, as reported to the Plan by The Standard, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. These contracts are included in the financial statements at contract value, as reported to the Plan by The Standard. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. There is no guaranteed crediting interest rate. Instead, the crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 1%. Such interest rates are reviewed on a quarterly basis for resetting.

The Plan's ability to receive amounts due in accordance with the fully benefit-responsive investment contract is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the IRC or the failure of the trust to be tax-exempt under Section 501(a) of the IRC
2. Premature termination of the contracts
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the Companies or other Company events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

Note 5. Benefit-Responsive Insurance Contract (Continued)

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer

Note 6. Tax Status

The Plan has adopted a preapproved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the IRC. The Plan has been amended since adopting the preapproved plan document; however, the Plan Administrator believes the Plan is currently designed, and is being operated, in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the accounts of all participants will become 100% vested and shall be distributed to the participants or their beneficiaries.

Note 8. Party-in-Interest Transactions

The Plan invests in a common collective trust fund managed by the trustee and, therefore, transactions related to this investment qualify as party-in-interest transactions. Fees paid by the Plan for investment management and administrative services amounted to \$236,317 for the year ended December 31, 2024.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
