INDEPENDENT AUDITORS' REPORT

The Plan Trustees of the WRD Inc. Employee Stock Ownership Plan

Opinion

We have audited the accompanying financial statements of the WRD, Inc. Employee Stock Ownership Plan (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the WRD, Inc. Employee Stock Ownership Plan as of December 31, 2024 and 2023, and the changes in net assets available for benefits for the year then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis of Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). 

Notes to Financial Statements

NOTE 1—DESCRIPTION OF PLAN

The following brief description of the WRD, Inc. Employee Stock Ownership Plan is provided for general information purposes only. Participants should refer to the Plan documents for complete information.

General. WRD, Inc. (the “Sponsor”) adopted the WRD, Inc. Employee Stock Ownership Plan (the “Plan”) effective February 27, 2004. The Plan was restated effective January 1, 2017 and amended on July 7, 2023. The 2023 amendment froze the Plan effective June 1, 2023; accordingly there are no new participants admitted to the Plan and there will be no further contributions.

The Plan operates as an employee stock ownership plan under section 401 of the Internal Revenue Code, and covers the employees of the Sponsor and its subsidiaries. The Plan is designed to comply with Section 4975(e) (7) of the Internal Revenue Code of 1986, as amended, and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974.

Management has evaluated subsequent events through October 2, 2025, the financial statement issuance date.

Eligibility. Subject to the 2023 Plan amendment which froze the Plan, employees of the Sponsor and its subsidiaries are eligible to participate after years-of-service and age requirements, as defined in the Plan Document, are met. Participants generally enter the plan on the later of the January 1 or July 1 following satisfaction of eligibility requirements.

Investment Allocation and Participant Accounts. The Plan holds shares of common stock of the Sponsor. Allocation of the value of the Sponsor’s stock to the participants’ accounts was based on the original purchase price of the stock. Participants will recognize the cumulative gain or loss in their account balance based on the difference between the original purchase price of the stock and the appraised fair market value of the stock as of the end of the year.

The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Contributions. The 2023 Plan amendment discontinued Sponsor contributions.

Benefit Payments. Distributions from the Plan are made upon retirement, death or other separation of employment with the Sponsor.

Vesting. Vesting is based on years of service. A participant is completely vested after six years of service.

Notes to Financial Statements

Termination. The Sponsor reserves the right to terminate the Plan at any time, subject to Plan provisions and the requirements of ERISA. Upon such termination of the Plan, participants will become fully vested in their entire account balances.

Forfeitures. Forfeited account balances are allocated to participants based on the participant's eligible compensation as a percent of the aggregate eligible compensation of all participants for the allocation year. For 2024, there were no forfeited shares available to be allocated to participants.

Diversification. Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their retirement plan balance into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify their account by directing the Plan to distribute the diversification amount.

Put Option. Sponsor stock held by the Plan includes a put option, since the stock is not readily tradable on an established market. The put option is a right to demand that the Sponsor buy the underlying shares of stock. The put price is set to equal the year-end appraised value of the stock at the date of redemption.

NOTE 2—SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting. The financial statements of the Plan are prepared under the accrual method of accounting.

Payment of Benefits. Benefits are recorded when paid.

Investment Valuation and Income Recognition. The Plan's investments are stated at fair value. Common shares of the Sponsor are valued at fair value as determined by annual independent appraisal, which is performed under a framework of generally accepted valuation methodologies, as well as economic and market factors as of the appraisal date, and is prepared on a minority, non-marketable interest basis. The appraisal takes into consideration IRS Revenue Ruling 59-60, which outlines the general approaches, methods, and factors to consider in the appraisal of the common stock of closely held companies and thinly-traded public corporations, and considers factors such as the nature of the business, the economic outlook of the industry in which the business operates, the book value and earnings capacity of the business, the business' goodwill and intangible value, and market prices of corporations engaged in similar lines of business.

The appraisal develops and considers valuation approaches including the income approach, which considers the present value of future economic benefits to be derived from ownership, the market approach, which is based on values of ownership interests in similar companies

that have been sold, and the asset approach, which considers the value of the underlying assets of the business.

Use of Estimates. The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

NOTE 3—INVESTMENTS

Generally accepted accounting principles provide a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

NOTE 4—INCOME TAX STATUS

The Plan obtained its latest determination letter on December 31, 2017, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023 there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to audits by taxing jurisdictions; however, there are currently no such audits in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

NOTE 5—TRANSACTIONS WITH PARTIES IN INTEREST

Certain administrative expenses of the Plan are absorbed by the Sponsor and are therefore not reflected in the Plan's financial statements.

NOTE 6—RISKS AND UNCERTAINTIES

The Plan maintains holdings in investment securities that are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risks associated with investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
