Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

(1) Description of the Plan

The following description of Audemars Piguet (North America) Inc. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

(a) General

The Plan was established January 1, 2000, and subsequent restatement effective January 1, 2022, with the adoption of the Pre-Approved Plan sponsored by FIS Business Systems LLC. Effective January 1, 2022, the Plan adopted the Cycle 3 Amended Plan document, which updated the Plan for certain regulatory and administrative requirements. The Cycle 3 Amended Plan document obtained an Internal Revenue Service opinion letter dated June 30, 2020.

The Plan is a defined contribution plan covering employees of Audemars Piguet (North America) Inc. (the “Company”). Employees are eligible to participate in the Plan upon reaching age 21 and completing three months of service. Participants are able to enroll in the Plan on the first day of the month following completion of the eligibility requirements. The Company manages the operation and administration of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan operates under an agreement with Transamerica Retirement Solutions (“TRS”) to act as recordkeeper of the Plan. TRS enters into a trust agreement with a related party or third-party trustee to hold the investments and execute investment transactions of the Plan during the year. Reliance Trust Company (“RTC”) served as trustee at December 31, 2024 and 2023 for all investments except the stable value fund, where Transamerica Financial Life Insurance Company (“TFLIC”) serves as the custodian. At year end, all investments and related investment activity are certified by RTC.

(b) Contributions

Each year, participants may contribute up to 100% of their annual compensation as pre-tax or Roth contributions, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, participants age 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined in the Plan. Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan does not include an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan and therefore all eligible employees must affirmatively elect to participate in the Plan.

The Company contributes a traditional ADP Safe Harbor non-elective contribution to eligible participants (see Note 1(a)), which is calculated as 3% of the participant’s compensation for the plan year. As of December 31, 2024 and 2023, approximately \$928,000 and \$799,000 was recorded as employer contribution receivable relating to the ADP Safe Harbor non-elective contribution. Contributions are subject to certain Internal Revenue Code (“IRC”) limitations.

(b) Contributions - Continued

The Plan also allows for the Company to contribute a discretionary match and/or discretionary non-elective contribution (generally in the form of a discretionary profit-sharing contribution) to eligible participants, as determined by the Plan Sponsor. For the years ended December 31, 2024 and 2023, there was a discretionary profit-sharing contribution of approximately \$393,000 and \$332,000, respectively, which is recorded as employer contribution receivable at December 31, 2024 and 2023, respectively. No discretionary non-elective contribution was made during 2024.

(c) Participant Accounts

Each participant's account is credited with the participant's contribution, ADP safe harbor contribution, and discretionary profit-sharing contribution, plan earnings and administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

(d) Participant Investment Account Options

Participants may direct contributions to any of the investment options offered by the Plan. The investment options include a various mutual funds and a stable value fund. Fund allocation percentages may be changed by participants at any time.

(e) Vesting

Participants are immediately vested in their contributions and the ADP non-elective safe harbor contribution plus actual earnings thereon. Vesting in the Company's discretionary matching and discretionary non-elective contributions plus actual earnings thereon is based on years of service. A participant vests 20% per year starting with one year of service and is 100% vested after five years of credited service. Additionally, participants become 100% vested upon reaching the normal retirement age of 62 or in the event of disability or death.

(f) Forfeited Accounts

Any non-vested account balance after the distribution of a terminated participant's vested account balance is forfeited. Forfeitures of participants' non-vested account balances are used to reduce future Company contributions or to reduce administrative expenses of the Plan. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$172,000 and \$9,000, respectively. During 2024, approximately \$99,000 in forfeitures were used to reduce Company contributions.

(g) Notes Receivable from Participants

Participants may borrow from their vested accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000 reduced by the excess of the Participant's highest outstanding loan balance during the 12-month period ending on the date of the loan over the Participant's current outstanding Participant loan balance on the date of the loan. Loan terms may range from one to five years for general loans, and up to fifteen years for the purchase of a principal residence.

(g) Notes Receivable from Participants - Continued

The loans are collateralized by the balance in the participants' accounts and bear interest at the prime rate plus 1%, as defined by the Plan. Principal and interest are paid ratably through payroll deductions. Any distribution, other than an in-service distribution, from the Plan will first be applied to offset any outstanding loan balance unless the loan is directly rolled over to another employer's plan.

(h) Payment of Benefits

The Plan provides for the payment of vested benefits to participants upon retirement, death, disability, or termination. Benefits are recorded when paid. If the value of participant's vested account does not exceed \$7,000, the entire amount shall be paid to the participant in a single lump sum. Account balances greater than \$7,000 are distributed after Participant's consent as either a lump-sum amount equal to the vested value of the participant's account balance or in installment payments.

(i) Hardship Withdrawals

The Plan allows participants to withdraw a portion of their account balance in the event of immediate and heavy financial need if they satisfy certain conditions. Any hardship withdrawal is limited to the amount needed to meet the financial need and must qualify with respect to plan provisions.

(j) Plan Termination

Although the Employer expects to continue the Plan indefinitely, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan. In the event of plan termination, all benefits become fully vested.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

(b) Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of net assets available for benefits and the related changes therein. Actual results could differ from those estimates.

Notes to Financial Statements - Continued

(2) **Summary of Significant Accounting Policies - Continued**

(c) **Valuation of Investments and Income Recognition**

Investments in registered investment companies are stated at fair value. Shares in registered investment companies are valued based on readily available and determinable market values, which represent the net asset value of the shares held by the Plan at year end.

The stable value fund is a fully benefit-responsive investment contract that is valued at contract value (see Note 5).

Net appreciation in fair value of investments includes both realized gains and losses on investments sold during the year and unrealized gains and losses on investments held at the end of the year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

(d) **Risks and Uncertainties**

Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

(e) **Contributions**

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which [the employee contributions are withheld from compensation.

(f) **Payment of benefits**

Benefits are recorded when paid.

(g) **Administrative Expenses**

Administrative expenses represent recordkeeping and advisory fees incurred to maintain the Plan, certain of which are paid to TRS. Trustee and third-party administrator fees are paid out of plan assets with any other costs being paid by the Employer.

(h) **Notes Receivable from Participants**

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income on notes receivables from participants is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments, the loan balance is reduced, and a benefit payment is recorded.

(3) **Information Certified by the Trustee (Unaudited)**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, RTC, the trustee has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Registered investment companies, at fair value
- Fully-benefit responsive investment contract at contract value
- Notes receivable from participants
- Net appreciation in fair value of investments
- Interest on fully-benefit responsive investment contract
- Interest on notes receivable from participants
- Dividends
- Schedule of assets (held at end of year)

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in these financial statements and supplemental schedule.

(4) **Fair Value Measurements**

Accounting Standards Codification ("ASC") Topic 820, Fair Value Measurement, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy under ASC Topic 820 are described below. A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Registered Investment Companies

Registered investment companies are valued at quoted market prices, which represent net asset values of shares held by the Plan at year end.

(5) Fully Benefit-Responsive Investment Contract

The Plan has a fully benefit-responsive stable value fund with TFLIC. Investments in the stable value fund allow participants to invest money in a general account of TFLIC which earns interest. Participant contributions are commingled with TFLIC's other assets and TFLIC assumes the risk of principal and accrued interest. An effective annual rate of interest is established prior to January 1st and July 1st each year. Interest is credited to the stable value fund daily based on its daily balance, at a rate of interest that is the daily equivalent of the effective annual rate of interest applicable for each six-month period.

Because the stable value fund is fully benefit-responsive, contract value is the relevant measurement for the stable value fund. Contract value, as reported to the Plan by TFLIC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

(5) **Fully Benefit-Responsive Investment Contract - Continued**

Certain events limit the ability of the Plan to transact at contract value with TFLIC. Such events include the following: (1) amendments to the plan documents (including complete or partial termination); (2) bankruptcy of the Company or Employers; (3) other Company or Employers' events that cause a significant withdrawal from the Plan; or (4) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA.

(6) **Tax Status**

The Plan has adopted a Pre-Approved Plan document which received its latest opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the pre-approved plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The pre-approved plan has been amended since receiving the opinion letter. However, the plan administrator and the Plan's tax counsel believe that the pre-approved plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(7) **Party-in-Interest Transactions**

Notes receivable from participants and the stable value fund are managed by TRS or its related party TFLIC and these transactions qualify as party-in-interest transactions. During 2024, the Plan paid TRS approximately \$43,000. In addition, the Plan paid approximately \$61,000 for TPA and investment advisory services. While these transactions qualify as party-in-interest transactions as defined in Section 3(14) of ERISA, they are expressly exempted from the prohibited transaction rules.

(8) **Subsequent Events**

The Plan's management has evaluated events and transactions for potential recognition or disclosure in the financial statements through September 22, 2025, the date the financial statements were available to be issued.
