Tom A. McCabe was the founder, owner, CEO and held all corporate positions for McCabe Architecture. Tom passed away on 2/1/23 and since there was no formal will in place the corporation was forced into dissolution through probate court. A probate attorney was assigned and I was granted temporary authorization to oversee the dissolution of the corporation. The probate attorney authorized the beneficiaries to collect and/or transfer funds in their names. Tom's, two children, Maren and Griffin McCabe were named beneficiaries in Tom's Members Retirement Program through Equitable.

Because I was not a named beneficiary or administrator on the plan the 2023 5500-SF was not submitted since it required Thomas A. McCabe, the listed administrator, to sign the filing.

I spoke with Mr. Martin/IRS # 100406061D regarding this situation and with Equitable representatives.

In order for the 2023 5500-SF to be electronically submitted to the IRS Equitable representative Taylor Gerard instructed Maren, a legal beneficiary, to obtain signing credentials through the Department of Labor then Maren can sign the 5500SF so Equitable can electronically file the form.

Maren McCabe is a named beneficiary so they sent the attached copy of the 5500 SF (unsigned) form to her and she sent to me so I could enclose it with this explanation.

There were no deposits made to the account and as soon as Maren obtains the necessary credential the final return will be filed. McCabe Architecture Corporation has been dissolved.
