Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters - Supplemental Schedule Required by ERISA

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTE 1. DESCRIPTION OF PLAN

The following description of the Heinzen, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan, covering all employees of Heinzen, LLC, Heinzen Manufacturing, Inc., Garlic Town Consultants, and 5P Consulting, Inc., (collectively, the Company) who have reached 18 years of age and have completed one hour of service during the first three months of employment. Plan entry dates are the first day of each calendar quarter. Heinzen, LLC is the Plan Sponsor. Plan Design Consultants, Inc. is the Plan Administrator and John Hancock Life Insurance Company U.S.A. (John Hancock) holds the assets of the Plan as the custodian. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Participants can contribute up to a maximum of \$23,000 and \$22,500 (\$30,500 and \$30,000 if over 50 years of age) in 2024 and 2023, respectively. Rollovers from another plan are allowed. Participants may select an investment account in which contributions will be invested in various funds offered through John Hancock. Participants may change their investment options at any time. The Company will make matching safe-harbor contributions equal to 100% on the first 1% of Plan compensation, plus 50% up to the next 5% of compensation.

The employer may make a separate employer contribution to participants in the following allocation groups:

- Group 1 – All highly compensated employees 5% or greater owners
- Group 2 – All other highly compensated employees
- Group 3 – All other participants

Participant Accounts: Each participant's account is credited with the participant's contribution and allocation of (a) the Company's contributions, (b) Plan earnings, and (c) fees. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum of \$50,000, or 50% of their vested account balance, whichever is less. Interest on loans is charged at the prime interest rate plus 2%, and loan payments cannot exceed five years. The balance in the participant's account secures the loans. All balances are due and payable in their entirety upon a participant's termination, retirement or death.

Payment of Benefits: Upon termination of service for death, disability or retirement, a participant will be 100% vested in their account and the participant or his/her beneficiary may elect to receive the balance as a lump-sum distribution. For termination of service due to other reasons, a participant may receive the value of the vested interest in his/her account as a lump-sum distribution or delay withdrawal until a future date.

Payment of Benefits (continued): The Plan provides that if an employee separates and has a vested balance of less than \$7,000, a lump sum distribution to the employee will be made as soon as administratively practicable. The employee can elect to receive the distribution or roll the distribution over into another retirement plan.

Vesting: Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's matching contributions is based on years of continuous service in the Plan. A participant is vested after years of credited service per the following schedule:

Forfeited Accounts: At December 31, 2024 and 2023, unallocated non-vested accounts totaled \$0. Amounts forfeited by terminated participants will be used to reduce future employer contributions.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Notes Receivable from Participants: Participant loans are valued at their unpaid principal balances plus any accrued but unpaid interest.

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 3 for discussion of fair value measurements.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition (continued): Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits: Benefits are recorded when paid.

Plan Expenses: Investment management fees and other fees related to investments of the Plan are paid either from the earnings of the Plan's investments or from forfeitures. Fees related to the administration of notes receivable or distributions from participants are charged directly to the participant's account and are included in administrative expenses. All other expenses relating to the operation of the Plan are paid by the Company.

NOTE 3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

Following is a description of the valuation methodologies used for assets measured at fair value:

- Money market: Valued at the closing price reported by the fund sponsor from an actively traded exchange.

- Pooled separate accounts invested in mutual funds or domestic equity securities are measured using quoted prices in active markets for identical assets. The pooled separate accounts directly invested in fixed maturity securities are valued at net asset value based on the pricing data provided by outside valuation service providers who in turn generally use the mean of bid and ask prices but may also use alternative observable pricing inputs for certain securities.

NOTE 4. CERTIFIED INFORMATION

The financial information included in the Plan’s financial statements as it relates to investment assets, investment transactions, investment income, and the schedule of assets (held at end of year) have been derived from information certified as complete and accurate by John Hancock, the custodian of the Plan and a qualified institution as defined by Department of Labor’s regulations, in accordance with Section 29 CFR 2520.103-5(c) of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. All investments and notes receivable from participants as of the financial statement date are covered by this certification.

NOTE 5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 6. TAX STATUS

The IRS has determined and informed the Company by a letter dated March 31, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7. PARTY IN INTEREST TRANSACTIONS

Plan Design Consultants, Inc. is the administrator of the Plan and, as such, is a party in interest. John Hancock, as the custodian of the Plan assets, is also a party in interest.

Certain officers and employees of the Company (who may also be participants in the Plan) perform administrative services related to the operation and financial reporting of the Plan. The Company pays these individuals' salaries and also pays other administrative expense on behalf of the Plan. Certain fees, to the extent not paid by the Company, are paid by the Plan.

These transactions are not deemed prohibited party in interest transactions, because they are covered by statutory and administrative exemptions from the Code and ERISA's rules on prohibited transactions.

NOTE 8. RISKS AND UNCERTAINTIES

The Plan provides for various investment options in investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 9. EMPLOYEE STOCK OWNERSHIP PLAN (ESOP)

In February 2025, Heinzen, LLC received IRS approval allowing the limited liability company to be taxed as an S-Corporation. Heinzen, LLC subsequently established an employee stock ownership plan (ESOP) designed to comply with Section 4975(e)(7) and regulations thereunder of the IRC and is subject to the provisions of ERISA. On July 30, 2025, the Company completed the sale of all its owners' outstanding shares, resulting in the ESOP becoming the sole owner of the Company as of that date. In connection with the ESOP transaction, the Company issued a \$5 million note payable to the previous owners. The ESOP will repay the \$5 million note over time using future Company's earnings and cash flows. The previous owners agreed to remain in their current management roles through July 30, 2026, to ensure a smooth transition of operations.

NOTE 10. SUBSEQUENT EVENTS

The Plan's management has evaluated its December 31, 2024 and 2023 financial statements for subsequent events through October 2, 2025, the date of issuance of the financial statements. The Plan's management is not aware of any additional subsequent events that would require recognition or disclosure in the financial statements.
