## **Independent Auditors' Report**

To the Plan Administrator of

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed the audits of the financial statements of FEMG Holdings, LLC 401(k) Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

## Notes to Financial Statements

December 31, 2024 and 2023

### (1) Description of the Plan

The following description of FEMG Holdings, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

#### (a) General

The Plan was established January 1, 2020, and subsequent restatement effective July 15, 2022, with the adoption of the 401(k)/Profit Sharing Non-Standardized Plan sponsored by Benefit Solutions, Etc. Effective July 15, 2022, the Plan adopted the Cycle 3 Amended Plan document, which updated the Plan for certain regulatory and administrative requirements. The Cycle 3 Amended Plan document obtained an Internal Revenue Service opinion letter dated June 30, 2020.

The Plan is a defined contribution plan covering employees of FEMG Holdings, LLC (the “Company”). Employees are eligible to participate in the Plan upon reaching age 21 and completing three months of service. Participants are able to enroll in the Plan on the first day of the month following completion of the eligibility requirements. The Company manages the operation and administration of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan operates under an agreement with Empower Retirement, LLC (“Empower”) to act as recordkeeper and custodian of its group annuity contract. At year end, all investments and related investment activity are certified by Empower.

#### (b) Contributions

Participants may contribute up to 100% of annual compensation as pre-tax or Roth contributions. Contributions are subject to certain Internal Revenue Code limitations. Additionally, participants age 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined in the Plan.

Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Company provides a non-elective safe harbor contribution equal to 3% of base compensation to all eligible employees throughout the year. In 2024, the Company made non-elective safe harbor contributions totaling approximately \$1,042,000, which included a true-up contribution of about \$133,000. Of the total true-up amount, \$85,000 will be allocated from the forfeiture account, and \$48,000 is recorded as a receivable subsequent to year-end. The total employer contributions received during the year amounted to \$909,000.

#### (c) Participant Accounts

Each participant’s account is credited with the participant’s contribution, non-elective safe harbor contribution, plan earnings and administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

### Notes to Financial Statements - Continued

#### (1) Description of the Plan - Continued

##### (d) Investment Options

Participants may direct contributions to any of the investment options offered by the Plan. The investment options include various mutual funds, collective investment trusts, and a guaranteed interest account. Fund allocation percentages may be changed by participants at any time.

##### (e) Vesting

Participants are immediately vested in their contributions and the non-elective safe harbor contributions, plus actual earnings thereon. Accordingly, the Plan has no forfeited accounts.

##### (f) Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan terms may range from one to five years for general loans, and up to fifteen years for the purchase of a principal residence. The loans are collateralized by the balance in the participants' accounts and bear interest at the prime rate plus 1%, as defined by the Plan. Principal and interest are paid ratably through payroll deductions.

##### (g) Forfeited Accounts

At December 31, 2023, forfeited nonvested accounts totaled \$164,024. These accounts will be used to reduce future employer contributions. Also, for the year ended December 31, 2024, no forfeitures were used to reduce employer contributions.

##### (h) Payment of Benefits

The Plan provides for the payment of vested benefits to participants upon retirement, death, disability, termination of employment, or upon reaching the age of 59½ years. Benefits are recorded when paid. If the value of a terminated participant's account does not exceed \$5,000, the entire amount shall be paid to the participant in a single lump sum. Account balances greater than \$5,000 are distributed either in a lump-sum amount equal to the vested value of the participant's account balance or in installment payments.

##### (i) Hardship Withdrawals

The Plan allows participants to withdraw a portion of their account balance in the event of immediate and heavy financial need. Any hardship withdrawal is limited to the amount needed to meet the financial need and must qualify with respect to plan provisions.

##### (j) Plan Termination

Although the Employer expects to continue the Plan indefinitely, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan. In the event of plan termination, all benefits become fully vested.

#### (2) Summary of Significant Accounting Policies

##### (a) Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

##### (b) Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of net assets available for benefits and the related changes therein. Actual results could differ from those estimates.

##### (c) Valuation of Investments and Income Recognition

Investments in registered investment companies are stated at fair value based on quoted market prices.

The Guaranteed Interest Account (“GIA”) is a general account product under a group annuity contract with Empower which allows participants to invest money in a general account which earns interest. The Sponsor has determined, based on recommendations from Empower, that this investment is fully-benefit responsive as participants may direct permitted withdrawals and/or transfer transactions of all or a portion of their balance in the investment option at contract value. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets of the portion of the general accounts that is used to determine the GIA’s crediting rate compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The interest crediting rate is reset at least annually and no more frequently than quarterly for some contracts. The average yield earned by the Plan was 1.47% for the year, and as of December 31, 2024 and 2023, the calculated interest rate was 1.46% and 1.40%, respectively, for all GIA accounts. The GIA is reported at contract value as of December 31, 2024 and 2023.

Certain events limit the ability of the Plan to transact at contract value with Empower. Such events include the following: (1) amendments to the plan documents (including complete or partial termination); (2) bankruptcy of the Company or Employers; (3) other Company or Employers’ events that cause a significant withdrawal from the Plan; or (4) the failure of the Plan to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Company does not believe that the occurrence of any such event, which would limit the Plan’s ability to transact at contract value with participants, is probable.

Net appreciation in fair value of investments includes both realized gains and losses on investments sold during the year and unrealized gains and losses on investments held at the end of the year. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

##### (d) Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

#### (2) Summary of Significant Accounting Policies - Continued

##### (e) Risks and Uncertainties

Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

##### (f) Administrative Expenses

Administrative expenses represent recordkeeping and advisory fees incurred to maintain the Plan, certain of which are paid to Empower. Trustee and third party administrator fees are paid out of plan assets with any other costs being paid by the Employer.

##### (g) Notes Receivable from Participants

Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income on notes receivables from participants is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments, the loan balance is reduced and a benefit payment is recorded.

#### (3) Information Certified by the Trustees (Unaudited)

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower, the Plan's trustee, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments:

- Investments at fair value
- Fully benefit-responsive guaranteed interest account at contract value
- Notes receivable from participants
- Net appreciation in fair value of investments
- Interest and dividends
- Interest income on notes receivable from participants
- Schedule of Assets (Held at End of Year)

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in these financial statements and supplemental schedule.

**(4) Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

***Registered Investment Companies***

Valued at the net asset value of shares held by the Plan at year end, based on quoted market prices in active markets.

#### (5) Tax Status

The Plan has adopted a Pre-Approved Plan document sponsored by Benefit Solutions Etc. (see Note 1) which received its latest opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the pre-approved plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The pre-approved plan has been amended since receiving the opinion letter. However, the plan administrator and the Plan's tax counsel believe that the pre-approved plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### (6) Party-in-Interest Transactions

Notes receivable from participants and the guaranteed interest account are managed by Empower and its related entities, and these transactions qualify as party-in-interest transactions. During 2024, the Plan paid Empower and its related entities approximately \$40,000. In addition, the Plan paid approximately \$37,000 for investment advisory services and \$27,000 for third party administrative services. While these transactions qualify as party-in-interest transactions as defined in Section 3(14) of ERISA, they are expressly exempted from the prohibited transaction rules.

#### (7) Subsequent Events

The Plan's management has evaluated events and transactions for potential recognition or disclosure in the financial statements through September 29, 2025, the date the financial statements were available to be issued.
