Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Prestress Services Industries, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Notes to the Financial Statements

1. Description of Plan

The following brief description of the Prestress Services Industries, LLC 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General

The Plan is a defined contribution retirement plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), and became effective July 1, 2004 and was restated effective August 1, 2021. The Plan covers all eligible employees, as defined in the Plan Agreement of Prestress Services Industries, LLC, (the Company and Plan Sponsor) as signatory employer, and the following participating employers: Prestress Services Transportation, LLC, Prestress Services Industries of TN, LLC, and Prestress Services Industries of Ohio, LLC. Management of the Company controls and manages the operation and administration of the Plan.

Eligibility

The Plan covers all eligible employees of the Company and participating employers. Employees are eligible to participate in the Plan if they are not a member of a class of employees identified as Excluded Employees in the Plan agreement. Excluded Employees are union employees whose employment is governed by a collective bargaining agreement under which retirement benefits were the subject of good faith bargaining, certain nonresident aliens who have no earned income from sources within the United States, or leased employees. Employees not identified as Excluded Employees are eligible to participate and enter the Plan immediately. Participants become eligible for Employer matching contributions after completing one year of service and 1,000 hours. Upon meeting the matching contribution eligibility requirements, employees may begin receiving the matching contribution on the first day of the following month.

Contributions

Participants may voluntarily contribute up to the maximum amount allowed under Internal Revenue Service regulations to their individual accounts on a pre-tax and post-tax basis. Participants may also contribute amounts representing distributions from other qualified defined contribution plans. The Company makes discretionary matching contributions up to the first \$1,000 of participant contributions. The total contribution to a participant's account for the Plan year cannot exceed the maximum limit determined by Internal Revenue Service regulations.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution, the Company's matching contribution, an allocation of Plan earnings or losses, and charged with an allocation of certain investment and administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan agreement. The benefit to which the participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to the Financial Statements, continued

1. Description of Plan, continued

Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan. If no such direction is made, participant accounts are invested in accordance with default investment alternatives as established under the Plan. The Plan Sponsor's contributions are automatically invested in the same investment options at the same percentage as participant deferral contributions.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. Participants become 20% vested after two years of service of 1,000 hours or more, and vest 20% each additional year of service up to 100% after six years. The non-vested portion of a participant's account balance is forfeited upon the distribution of the vested portion of the participant's account or the incurrence of five consecutive one year breaks in service, as defined by the Plan. If a participant dies or becomes permanently disabled, he or she is automatically 100% vested in all accounts.

Forfeited Accounts

During the year ended December 31, 2024, forfeited non-vested accounts totaled \$7,760. Forfeitures used to pay Plan expenses amounted to \$6,898 for the year ended December 31, 2024. As of December 31, 2024 and 2023, there were \$4,319 and \$3,343 of forfeited nonvested accounts, respectively.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump sum amount equal to the value of his or her vested account balance. Termination benefits less than \$5,000 will be automatically distributed.

Risk and Uncertainties

The Plan provides for various participant directed investment options in various securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

2. Summary of Significant Accounting Policies

The financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America (GAAP) which require the Plan administrator to make estimates and assumptions that affect the reported amounts and disclosures in the financial statements. Actual results may differ from those estimates.

2. Summary of Significant Accounting Policies, continued

The following is a summary of the significant accounting policies consistently followed by the Plan in the preparation of its financial statements:

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains or losses on investments bought and sold as well as held during the year. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisor or custodian.

Contributions

Contributions from Plan participants and the matching contributions from the Plan Sponsor are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Investment and Administrative Expenses

Certain expenses of the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of distributions and notes receivables from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 and 2023 contributions to the applicable participants in the following Plan year.

Subsequent Events

The Plan's management has evaluated subsequent events for accounting and disclosure requirements through September 30, 2025, the date that the financial statements were available to be issued.

3. Information Prepared and Certified by the Trustee

The Plan's investment information included in this note and throughout the Plan's financial statements and supplemental schedule was prepared by or derived from information provided by Charles Schwab Trust Bank (Schwab), the trustee of the Plan, and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the trustee that investment information provided to the Plan Administrator by the trustee related to the following investment information is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditor not to perform any auditing procedures with respect to investment information in this note which appears throughout the financial statements and the supplemental schedule.

Schwab also certified to the completeness and accuracy of the \$1,393,945 of net appreciation in the fair value of investments and \$306,533 of interest and dividends related to the aforementioned investments for the year ended December 31, 2024.

4. Fair Value Measurements

The Plan classifies its investments based on a hierarchy consisting of: Level 1 (valued using quoted prices from active markets for identical assets), Level 2 (not traded on an active market but for which observable market inputs are readily available), and Level 3 (valued based on significant unobservable inputs). The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price.

4. Fair Value Measurements, continued

Common collective trust: Valued based on NAV of units of the common collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan Administrator believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no significant transfers in or out of Level 3.

5. Exempt Party-in-Interest Transactions

Schwab is the trustee of the Plan and therefore, transactions with Schwab qualify as party-in-interest. Pension Corporation of America (PCA) is the third-party recordkeeper of the Plan and therefore, transactions with PCA qualify as party-in-interest. Administrative expenses of \$10,856 for the year ended December 31, 2024 are comprised of fees paid by the Plan to PCA for investment management services and recordkeeping services.

Additionally, indirect fees are paid to Schwab based on investment account values and totaled \$5,507 for the year ended December 31, 2024. The fees are included with net appreciation in fair value of investments on the statement of changes in net assets available for benefits.

6. Tax Status

The Plan uses a volume submitter plan document sponsored by CCH Incorporated DBA ftwilliam.com (CCH). CCH has received an advisory letter from the Internal Revenue Services, dated June 30, 2020, as to the volume submitter plan's qualified status. The volume submitter plan advisory letter has been relied upon by the Plan. The Plan has been amended since the volume submitter plan received the advisory letter. The Plan Administrator believes that the Plan is designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

7. Plan Termination

Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA.
