INDEPENDENT AUDITOR'S REPORT

To the Investment Committee of
Magneto & Diesel Injector Service, Inc. 401(k) Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Magneto & Diesel Injector Service, Inc. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

December 31, 2024 and 2023

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Magneto & Diesel Injector Service, Inc. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of Magneto & Diesel Injector Service, Inc. and adopting affiliates (collectively the “Company”), except leased employees, union employees, nonresident aliens, and temporary employees who do not complete 1,000 hours of service during a 12 month computation period. Employees are eligible to participate on the first day of each calendar month coinciding with or next following attaining 18 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may elect to make pre-tax and/or Roth salary deferral contributions to the Plan up to the maximum amount allowed by law. Participants who have attained the age of 50 before the end of the plan year may make catch-up contributions. The Company will automatically make a pre-tax salary deferral contribution of 3% of eligible compensation for eligible employees, unless the employee elects not to participate or elects a different deferral percentage. The Plan allows rollover contributions from other qualified retirement plans and in-plan Roth transfers.

The Company may contribute a discretionary matching contribution in an amount equal to a percentage of the participants’ elective deferrals for each payroll period. During 2024, the Company elected to match an amount equal to 50% of each participant’s elective deferrals that do not exceed 6% of the participant’s eligible compensation. The Company may also make a discretionary non-elective contribution for participants employed on the last day of the plan year. The Company did not elect to make a discretionary non-elective contribution for the year ended December 31, 2024. The Plan is participant directed. Participants may change their contribution rates at the beginning of each month and investment options at any time.

Participant Accounts

Each participant’s account is credited with the participant’s contributions and Company contributions, as well as allocations of Plan earnings and any administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

NOTE 1 - DESCRIPTION OF THE PLAN (CONTINUED)

Notes Receivable from Participants

Plan participants may borrow Plan assets starting at an amount of no less than \$1,000 and up to a maximum of the lesser of \$50,000 (reduced by the difference between the highest outstanding balance of loans in the past 12 months and the outstanding balance of loans on the date the loan is made) or 50% of their vested account balance in the Plan. A participant cannot have more than one outstanding loan at any given time. Interest rates on loans are stated at a reasonable rate. Loans are repaid in level installments through payroll deductions for periods ranging up to five years and in certain situations may exceed five years. Loans are secured by the participant's vested account balance to the extent of the principal amount of the loan plus accrued interest.

Vesting

Participants are at all times fully vested in their contributions and the appreciation or depreciation thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. Participants vest 20% each year after one year of service and are 100% vested after five years of service. A participant becomes 100% vested upon death, disability, and normal retirement.

Payment of Benefits

Normal retirement age under the Plan is 65, at which time a participant may withdraw their vested account balance. Upon a participant's termination, retirement, disability, or death, the vested funds in the participant's account are available to be distributed in a lump-sum payment. Distributions after termination for reasons other than death may also be made in substantially equal installments or partial withdrawals. The Plan also allows for hardship withdrawals from a participant's salary deferral account and in-service withdrawals at age 59 ½ from all of the participant's accounts.

Forfeitures

Forfeitures of nonvested employer contributions shall be used to pay Plan administrative expenses or to reduce employer contributions as determined by plan management. The forfeitures balance was \$19,326 and \$4,240 at December 31, 2024 and 2023, respectively. Forfeitures of \$30,567 were used during 2024 to pay Plan administrative expenses. No forfeitures were used to reduce employer contributions during 2024.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation

Investments are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales of investments are reflected on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the Company discretionary matching contributions are recorded in the plan year in which the participant contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to recordkeeping, investment management, notes receivables from participants, and withdrawals are charged directly to the participant's account and are included in administrative expenses. Other investment-related expenses are included in net appreciation in fair value of investments.

NOTE 3 - FAIR VALUE MEASUREMENTS

Various inputs are used in determining the fair value of the Plan's investments. Valuation techniques used to measure fair value must maximize the use of observable inputs and minimize the use of unobservable inputs. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The three levels of the fair value hierarchy, including the types of Plan investments that fall under each category and the valuation methodologies used to measure fair value, are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

Money Market Deposit Account: Consists of the Schwab Bank Savings, which is an interest bearing, FDIC-insured account. Valued at carrying cost which approximates fair value.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Level 2 - Inputs to the valuation methodology are other than quoted market prices in active markets that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities in active markets; quoted prices that are in inactive markets; inputs other than quoted prices that are observable for the asset or liability and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable inputs (i.e., projections, estimates, interpretations, etc.) that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The inputs and methodologies used for valuing securities are not an indication of the risk associated with investing in those securities. There have been no changes in the methodologies used at December 31, 2024 or 2023.

NOTE 4 - INFORMATION CERTIFIED

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Bank, the trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024, and the related investment income and interest income on notes receivable from participants reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

NOTE 5 - TAX STATUS

The Plan has adopted a non-standardized pre-approved plan, which obtained an opinion letter dated June 30, 2020 in which the Internal Revenue Service (IRS) stated that the document satisfies the applicable provisions of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan to determine if the Plan has taken an uncertain position that more than likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions. In October 2024, the Plan completed a Department of Labor examination of the plan years from 2020 to 2023. The examination was closed with no reported findings.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are in mutual funds and a money market deposit account managed by entities related to Charles Schwab Trust Bank, the trustee of the Plan. Therefore, these transactions qualify as party-in-interest transactions as defined by ERISA. Notes receivable from participants also qualify as party-in-interest transactions. These transactions are permitted under the provisions of the Plan and are covered by an exemption from prohibited transaction provisions.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan provides for various investments. In general, such investments are exposed to various risks such as significant world events, interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Participant investments in the Schwab Bank Savings may at times exceed the federally insured limit of \$250,000.

NOTE 8 - DELINQUENT CONTRIBUTIONS

During 2024 and 2023, there were unintentional delays by the Company in submitting participant contributions to the Plan in the amount of \$338 and \$33,374, respectively. During 2024, the Company compensated the affected participants for lost earnings on \$33,374 of these delinquent contributions. The Company intends to compensate the affected participants for lost earnings on the remaining \$338 of these delinquent contributions in 2025.

NOTE 9 - SUBSEQUENT EVENTS

Effective August 1, 2025, the Company terminated its relationship with BOK Financial and entered into an agreement with Fidelity Workplace Services as the new recordkeeper for the Plan. The custodian and trustee of the Plan was changed from Charles Schwab Trust Bank to Fidelity Management Trust Company. The Plan was amended and restated effective August 1, 2025 to adopt a new non-standardized pre-approved plan sponsored by FMR, LLC. There were no significant changes to the Plan's provisions.

Management has evaluated subsequent events through October 2, 2025, the date the financial statements were available to be issued.
