Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

NOTE 1 DESCRIPTION OF PLAN

The following description of the Bruening Rock Products, Inc. 401(k) Profit Sharing Plan (the Plan) provides general information only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Bruening Rock Products, Inc. (the Company or Employer) who have completed two months of service. The Plan also covers the employees of Skyline Construction, Inc., Skyline Materials, LLC, Skyline Trucking, Minnowa Construction, Inc., and Jennerjohn & Holtous, Inc. The Plan was initially effective March 1, 1989 and has been amended and restated throughout the years for administrative purposes and to comply with tax legislation. The Plan excludes employees covered by a collective bargaining agreement, nonresident aliens, leased employees, and part-time/temporary/seasonal employees. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.

Contributions

Employees become eligible for the Plan upon attainment of two months of service. Employees enter the Plan on the first day of the month after meeting the eligibility requirement.

Participants may elect to make salary reduction contributions of pre-tax compensation, as defined in the Plan. Participants are also allowed to make after-tax (Roth) deferral contributions. The Plan allows participants age 50 and older to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Plan allows in-Plan Roth rollover contributions and also includes an automatic deferral feature. Accordingly, the Company automatically withholds a portion of the participant's compensation from each payroll period and contributes that amount as a pre-tax 401(k) deferral unless the participant makes an election to the contrary. Participants are automatically enrolled at 3% of their compensation.

The Company may make discretionary matching contributions on each participant's contribution. Effective April 1, 2019, the Company matched 25% of each participant's contribution not to exceed \$2,500. In addition, the Company may make profit sharing contributions to the Plan at the discretion of its Board of Directors. There were no profit sharing contributions for the years ended December 31, 2024 or 2023.

Contributions are subject to limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's matching contribution, and an allocation of (a) the Company's profit sharing contribution and (b) Plan earnings or losses. Allocations are based on participant earnings or account balances, as defined. Income is allocated daily based on the shares in the participant's account. The benefit to which a participant is entitled is the benefit that can be provided by the participant's account.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Employer's matching and profit sharing contribution portion of their accounts, plus actual earnings thereon, is based on years of continuous service. A participant is 100% vested after six years of credited service. Notwithstanding the above, a participant is fully vested upon reaching normal retirement age, death, or permanent disability.

Payment of Benefits

Upon termination of service, death, disability, or retirement (as early as age 62), the participant will receive the value of the vested interest in his or her account in the form of a lump sum distribution or installment payments. If a participant terminates employment and the participant's account balance is less than \$5,000, the Plan administrator will authorize the benefit payment without the participant's consent in the form of a direct rollover to an individual retirement account. The Plan allows for in-service distributions for participants that have attained age 59 1/2, subject to Plan provisions. Effective July 1, 2020, the Plan allows hardship distributions.

Forfeited Accounts

Forfeited nonvested accounts may be used to reduce administrative expenses or to reduce Employer contributions to the Plan. As of December 31, 2024 or 2023, forfeited nonvested accounts were \$276 and \$30,567, respectively. Forfeitures of \$29,462 and \$3,608 of forfeitures were used to pay Plan expenses for the years ended December 31, 2024 and 2023, respectively. Forfeitures of \$21,543 and \$-0- were used to reduce Employer contributions during the years ended December 31, 2024 or 2023, respectively.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements. Estimates also affect the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are valued at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses

The Company pays certain administrative expenses on behalf of the Plan.

Benefit Payments

Benefit payments are recorded when paid.

Reclassification

Certain amounts in 2023 have been reclassified for comparative purposes to conform with the presentation in 2024. The reclassifications have no effect on previously reported Net Assets Available for Benefits or the statement of Changes in Net Assets Available for Benefits.

Subsequent Events

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through September 22, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

Minnesota Life Insurance Company, the former insurance company and qualified institution of the Plan, has provided the Plan administrator with a certification as to the completeness and accuracy of investments as of December 31, 2023, and investment income for the period from January 1, 2023 to November 15, 2024, in the accompanying financial statements.

Transamerica Life Insurance Company, the insurance company and qualified institution, as well as the related Transamerica Trust Company, custodian of the Plan, have supplied the Plan administrator with certifications as to the completeness and accuracy of investments as of December 31, 2024, and investment income for the period from November 15, 2024 to December 31, 2024, in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; or
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

NOTE 4 FAIR VALUE OF INVESTMENTS (CONTINUED)

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Fund – Valued at the NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

Pooled Separate Accounts: Valued using the net asset value (NAV) of units, as determined by the insurance company. NAV is a readily determinable fair value and is the basis for current transactions.

NOTE 5 PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants will become 100% vested in their accounts.

NOTE 6 PARTIES-IN-INTEREST

Plan investments are managed by Transamerica. Therefore, these transactions qualify as party-in-interest transactions.

NOTE 7 INVESTMENT IN INSURANCE COMPANY INVESTMENT CONTRACT

The Plan held a traditional fully benefit-responsive guaranteed investment contract with Minnesota Life Insurance Company (the former Insurance Company) totaling \$-0- and \$2,574,124 as of December 31, 2024 and 2023, respectively. The former Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the former Insurance Company to terminate the agreement prior to the scheduled maturity date.

In 2024, the Plan entered into a traditional fully benefit-responsive investment contract with Transamerica Life Insurance Company (the Insurance Company) when the Plan transferred to Transamerica as its new TPA, which totaled \$2,750,463 and \$-0- as of December 31, 2024 and 2023, respectively. The Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 2%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the Insurance Company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the plan. Contract value, as reported to the Plan by the Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

NOTE 8 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 PLAN TAX STATUS

The prototype plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service (IRS) stated that the volume submitter plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
