We have performed audits of the financial statements of The MYR Group Hourly 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024, and the related notes to the financial statements.

### 1. Description of the Plan

The following description of The MYR Group Hourly 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

#### *General*

MYR Group Inc. (the Company or the Plan Sponsor) is a publicly traded electrical construction company headquartered in Henderson, Colorado.

The trustee and recordkeeper of the Plan is Empower Trust Company (the Trustee). The administrator of the Plan is the Company. The Trustee holds all assets of the Plan in accordance with the service provider contract with the Company. The Benefit Plans Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### *Eligibility*

Employees of the Company are eligible to participate in the Plan if the employee is a regular full-time, hourly field employee of the Company or if the employee was a prior Plan participant and is rehired. Part-time employees are eligible to participate on the first day of the month following completion of 1,000 hours during the first year of employment, or during any calendar year commencing after the date of hire. An employee may not participate in the Plan if they are a temporary employee, a leased employee, a contract worker, covered under a collective-bargaining agreement that does not provide for participation in the Plan, or covered by a multi-employer pension plan to which the Company makes contributions.

#### *Contributions*

Participants may contribute from 1% to 75% (in 1% increments) of their wages to the Plan. Unless a participant is eligible to make catch-up contributions, the employee contributions will automatically stop when they reach the contribution limit for the year based on the current Internal Revenue Code (IRC) requirements. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Plan also includes an automatic escalation clause whereby employee contributions increase by 1% annually, up to 6%, unless the participants opt out of this feature.

The Company makes a safe harbor dollar-for-dollar matching contribution up to a maximum of 4% of the participant's eligible wages. The Company also makes a dollar-for-dollar supplemental matching contribution for deferral amounts in excess of 4% up to 6% of a participant's wages. Contributions are calculated for each payroll period, and payment is made within a reasonable time after each payroll period. The Company's contributions are invested into the various investment options as directed by the participant.

### ***Participant Accounts***

Each participant's account is credited with the participant's contribution, the safe harbor matching contributions, the supplemental matching contribution, and an allocation of the Plan earnings and expenses. Allocations are based on participant contributions, base wages, account balances, or specific participant-requested transactions, as defined in the Plan agreement. Each account maintained for a participant reflects its value for each investment held. All income, gain, or loss attributable to the investment of the balance of any account maintained for a participant is recorded to that account.

### ***Vesting and Forfeitures***

Participants are immediately vested in their employee before-tax account, Roth account, safe harbor match account, rollover account, pension plan account, pre-2006 after-tax contribution account, and any other employee contribution accounts. The amounts held in the Supplemental Match Account vest based on years of service. A year of service is any Plan year in which an employee completes 1,000 hours of service. A participant becomes 20% vested after one year of service, 40% vested after two years of service, 60% vested after three years of service, 80% vested after four years of service, and 100% vested after five years of service. Participants become 100% vested upon death, permanent disability, or reaching normal retirement age of 65.

The non-vested portion of the employer contributions for all terminated employees may be used to reduce subsequent employer contributions or to pay Plan expenses. In 2024, \$75,040 of forfeitures were used to reduce employer contributions. The unallocated forfeitures balance as of December 31, 2024 and 2023 was \$81,340 and \$40,205, respectively.

### ***Payment of Benefits***

A terminated employee may elect to receive the value of their account in the form of a single-sum payment, a partial payment, a direct rollover, or a distribution in the form of an annuity if such total account balance exceeds \$5,000. Account balances below \$5,000 will be automatically distributed to the participant. If the account balance is between \$1,000 and \$5,000, the balance will be automatically rolled into an Individual Retirement Account (IRA) on behalf of the participant. If the account balance does not exceed \$1,000, the account balance will automatically be distributed to the participant in a lump-sum payment. Active employees may make withdrawals from the Plan under certain circumstances. Distributions are subject to the applicable provisions of the Plan Agreement.

### ***Notes Receivable from Participants***

Loans made to a participant from their account must be for a minimum of \$1,000. Loan amounts may not exceed the lesser of \$50,000 or 50% of a participant's vested account balance, less outstanding balances of any other loans with the Plan. A loan is secured by the balance in the participant's account and bears interest at the Prime rate published in *The Wall Street Journal* on the first business day of each month, plus 1%. Loans are generally to be repaid within five years unless the loan is for the purchase of a principal residence. Also, each participant may not have more than two loans outstanding at any time.

### *Transfer of Assets to/from Other Plans*

The Company serves as the parent company for 12 subsidiaries. Employees may transfer between subsidiaries due to project needs, promotional opportunities, or when applying for and accepting an open position with another subsidiary. Because the Company offers multiple benefit plans, both based on position or subsidiary, a transfer may result in changes to an employee's benefits eligibility. This includes, but is not limited to, medical coverage and 401(k) participation. When such a transfer occurs, the applicable benefit transition process will be initiated to align the employee with the benefit plans of their new subsidiary. In 2024, transfers between Company-sponsored benefit plans were \$36,052 transferred in and \$669,904 transferred out.

## **2. Summary of Accounting Policies**

### *Basis of Accounting*

The accounts of the Plan are maintained, and the accompanying financial statements have been prepared, on the modified cash basis of accounting, which is a basis of accounting other than generally accepted accounting principles (GAAP). Contributions, investment income, benefit payments, and expenses are recorded when received or paid.

### *Use of Estimates*

The preparation of financial statements in conformity with the modified cash basis of accounting requires the administrator to make significant estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

### *Investment Valuation and Income Recognition*

The investments held by the Plan at December 31, 2024 and 2023 are reflected at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability (an exit price) in an orderly transaction between market participants at the measurement date in the principal or most advantageous market for the asset or liability. Inputs are used in applying the various valuation techniques and broadly refer to the assumptions that market participants use to make valuation decisions, including assumptions about risk.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

### *Notes Receivable from Participants*

Notes receivable from Plan participants represent participant loans and are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Repayments of principal and interest are recognized in the period in which payroll deductions are processed. No allowance for credit losses had been recorded as of December 31, 2024 and 2023.

### *Payment of Benefits*

Benefit payments are recorded when paid.

### *Administrative Expenses*

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

### *Subsequent Events*

The Plan has evaluated subsequent events through October 1, 2025, which is the date the financial statements were available to be issued, and there were no material subsequent events that required recognition or additional disclosures in these financial statements.

## **3. Fair Value Measurements**

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement (including the entity's own assumptions about the assumptions that market participants would use in pricing the asset or liability) and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The investments at December 31, 2024 and 2023 are presented at fair value, which has been determined utilizing information provided by the investment advisors and Trustee.

Plan management uses the following methods and significant assumptions to estimate fair value of investments. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds* - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-Directed Brokerage Accounts* - Self-directed brokerage accounts are comprised of common stock, mutual funds, and cash and cash equivalents. Common stock is valued at the published market price on an active market. The mutual funds are valued at the NAV that is quoted on an active market and is determined based on the fair value of the underlying assets at the end of each day. During the year ended December 31, 2024, Self-Directed Brokerage Accounts were moved from Level 2 to Level 1. There were no changes in the fair values as a result of this change.

*Common Collective Trust Funds (CCTs)* - The investments in CCTs are valued at the NAV of units held by the Plan at December 31, 2024 and 2023. The NAV is used as a practical expedient to estimate fair value. The NAV is provided by the fund manager of the CCT and is based on the fair value of the underlying investments held by the fund less their liabilities. The redemption frequency is daily and there are no unfunded commitments or redemption restrictions. These investments are a direct-filing entity.

### 4. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

### 5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

### 6. Tax Status

The Plan uses a pre-approved plan from the Trustee, which received an opinion letter from the Internal Revenue Service (IRS) on November 14, 2022, which states that the pre-approved plan, as then designed, satisfies the applicable provisions of the IRC. Although the Plan has been amended since the date of the opinion letter, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

### 7. Related Party and Party-in-Interest Transactions

Certain Plan investments are managed by the Trustee or its affiliates. Fees have been paid to the Trustee by the Plan for record-keeping services. Certain administrative functions are performed by officers or employees of the Company at no cost to the Plan.

The Plan has notes receivable from participants subject to specific guidelines, as defined in the Plan Agreement (see Note 1). These transactions are not deemed prohibited party-in-interest transactions, because they are covered by statutory or administrative exemptions from the IRC and ERISA's rules on prohibited transactions.
